*BRIEF SUMMARY: The Municipality of the City of Cape Town has issued a by-law, RE OUTDOOR ADVERTISING AND SIGNAGE.*

**SUBJECT: USE OF LAND AND BUILDINGS FOR OUTDOOR ADVERTISING AND SIGNAGE**

1. Your attention is drawn to the Municipality of the City of Cape Town's by-law in the above-mentioned regard as promulgated in Provincial Gazette Extraordinary 5801, dated 5 December 2001. The by-law is applicable only to those educational institutions that fall under the jurisdiction of the Municipality of the City of Cape Town.
2. The by-law requires that outdoor advertising shows respect for the integrity of any site on which it is displayed, and complements the character of the locality in which it is displayed. In addition, outdoor advertising and signs should not compromise the functioning and safety of traffic and should not adversely affect the character of the locality by way of appearance, size or illumination.
3. This by-law also sets out the procedures to be followed when applying to the Municipality of the City of Cape Town, and the criteria that will be used when an application is considered.
4. The above-mentioned Provincial Gazette Extraordinary is obtainable from the Provincial Legislature.


