1. Inkqubo yokuqeshwa ngokwesiqendu 43(1)

Ngokwesiqendu 43(1) somthetho i-SASA, ibhunga lolawulo lesikolo sikarhulumente maliqeshe umntu obhalisiweyo njengomphicothi-ncwadi ngokwe-Auditing Profession Act, ka-2005 (uMthetho 26 ka-2005) ongokuphicotha iirekhodi neengxelo zemali ezichazwe kwisiqendu 42 somthetho i-SASA.

2. Amaxwebhu afunekayo okuqesha ngokwesiqendu 43(1)
