1. ISebe leMfundo leNtshona Koloni (WCED) lijongene nenani eliphezulu eliye lisanda lemibuzo emalunga nezicelo zokwamkelwa kwabafundi ezazingeniswe ezikolweni yaye oku kubangela uxinzelelo olungeyomfuneko kwisistim.
2. Le setyhula yazisa izikolo ngokuqaliswa kwenkqubo eyifankshini yekhomyutha ukuncedisa abazali ekulandeleleni izicelo zabo zokwamkelwa kwabafundi kwizikolo zikarhulumente.
3. Le fankshini iya kuvumela umzali okanye umgcini womfundi atshekishe ngokungena kwiziko lewebhu leSebe iWCED ukuba sifakiwe na isicelo esasingeniswe esikolweni kwi-School Admissions Management Information (SAMI) system.
4. Kwangoko sakuba sifakiwe isicelo kwisistim, i-imeyili ezenzekelayo (*automated email*) iya kubazisa abazali ukuba isicelo sele sifakiwe kwisistim sikolo, ngokuxhomekeke ekubeni umzali unike idilesi ye-imeyili esemthethweni.
5. Abazali baya kubanako ukutshekisha **KUPHELA** besebenzisa inombolo yesazisi somfundi (*learner's identity (ID)*) okanye inombolo yeCEMIS eyi-unique CEMIS number.

7. Ziyakhunjuzwa izikolo ukuba **ZONKE** izicelo zokwamkelwa kwabafundi ezikolweni mazifakwe kwisistim ukwenzela ukuba kuqinisekise ukusetyenziswa kwenkqubo yezolawulo enobulungisa engqinelana noMthetho *Promotion of Administrative Justice Act (PAJA), 2000 (Act 3 of 2000)*.
8. Kucelwa kuqatshelwe ukuba oku kubandakanya nezicelo ezifunyenwe emva komhla omisiweyo njengoko oko kuya kunceda abazali ekubeni bafumane igama neenkukacha zomfundi okwilisti yeSebe iWCED yabafundi abangekafakwa zindaweni abakwisistim i-SAMI system.
9. Ziyakhunjuzwa izikolo zizalandele mbo amaxesha amisiweyo, iinkqubo nemigaqo yokwamkelwa kwabafundi ezikolweni njengoko kumiselwe kwiSetyhula 0035/2017, yomhla we-13 Septemba 2017.
