 - d) ubhalisile kwi-South African Council for Educators (SACE).
7. Apho ibhunga lolawulo lingakuxhasiyo ukuqeshwa ngokusisigxina kukatitshala osanda kufumana isiqinisekiso samabanga emfundo, ibhunga lolawulo malingenise incwadi ebhaliweyo enezizathu ezamkelekileyo ezicacisa ukuba kungani na kungaxhaswayo ukuqeshwa ngokusisigxina kukatitshala.
