Isihloko: Ukutshintshwa kwengqesho yooTitshala beZithuba zeNqanaba 1 itshintshelwe kwingqesho esisigxina ngokwesiqendu 6(b) soMthetho wezeNgqesho yooTitshala (Employment of Educators Act, 1998)

1. Le setyhula ihlaziyiwe yaye iyitshitshisa ngokupheleleyo iSetyhula 0055/2015
2. Isiqendu 6(b) soMthetho wezeNgqesho yooTitshala, 1998, (uMthetho 76 ka-1998)) sibonelela ngemigaqo yokutshintshwa kwemeko yengqesho yootitshala yethutyana/yokuqeshwa ngokwemvumelwano (*temporary/contract*) itshintshelwe kwingqesho esisigxina.
3. Utitshala ongesosigxina ngutitshala ngoku oqeshwe **kwiSithuba seNqanaba 1 esivunyiweyo nesingenamntu esixhaswa ngemali noqeshwe kwisithuba sethutyana ithuba eliqingqiweyo (closed period)**. Le nkcazo ayisebenzi kootitshala abaqeshwe kwizithuba zonyuselo-sikhundleni ezingenamntu ezixhaswa ngemali (*vacant substantive promotion posts*), ababambeleyo, okanye kootitshala abambele ezindaweni zootitshala abaqeshwe ngokusisigxina abangekhoyo emsebenzini, ngenxa yaso nasiphi na isizathu.
4. Ootitshala abasele balifumanayo ithuba lokusebenza ixesha elide kwezemfundo, umzekelo, abo badla umhlala-phantsi (nakoluphi na udidi), abayekisiweyo emsebenzini ngenxa yokungabinampilo, abathathe iphakheji yokuyeka

ngokuzithandela yalo naluphi na uhlobo, okanye ootitshala abalahlayo kwinkonzo yomsebenzi wokufundisa (kuzwelonke okanye kumaphondo) kwithuba leenyanga ezilishumi elinambini, ababandakanywa kule miqathango iqulethwe kule setyhula.

5. Ukutshintshwa kwengqesho yethutyana itshintshelwe kwingqesho esisigxina kwenziwa ngokwesigqibo enelungelo lokusenza iNtloko yeSebe leMfundo.
6. Ngokungqinelana neSigqibo soThetha-thethwano neMibutho yaBasebenzi, iSebe leMfundo leNtshona Koloni (WCED) lazamkela ezi khayitheriya zilandelayo zokutshintshwa kwemeko yengqesho yootitshala yethutyana, itshintshelwe kwingqesho esisigxina ngokwesiqendu 6(b) soMthetho weNgqesho yooTitshala (EEA) ka-1998.
 - 6.1 Ukuqeshwa ngokusisigxina makwenziwe kwisithuba seNqanaba 1 esixhaswa ngemali kwaye isithuba eso masibonakaliswe kwini lezithuba ezivunyiweyo zootitshala ezabelwe isikolo.
 - 6.2 Utitshala ochaphazelekayo ngexesha lokufaka isicelo sokutshintshwa kwemeko yengqesho, makabe ngoqeshwe **kwisithuba sethutyana, kangangethuba eliqhubekeke okoko eliziinyanga ezintathu.**
 - 6.3 Utitshala makazanelise ezi khayitheriya zilandelayo ukwenzela ukuba aqwalaselelwe ukutshintshwa kwemeko yengqesho yakhe yethutyana/yemvumelwano, itshintshelwe kwingqesho esisigxina ngokuthi abe:
 - a) ngofumene uqeqesho kumsebenzi wobutitshala wokufundisa,
 - b) unamabanga emfundo afanelekileyo okufundisa isifundo kwisigaba aya kuqeshwa kuso
 - c) uyazifezekisa iimfuno ezimiseliweyo ezisisiseko zesithuba ekuya kutshintshelwa kuso ingqesho yakhe; yaye
 - d) ubhalisile kwi-South African Council for Educators (SACE).
7. Izicelo zokutshintshwa kwezithuba zengqesho yethutyana zitshintshelwe kwizithuba ezisisigxina, ziya kuqwalaselwa kuphela ukuba kufunyenwe iingcebiso nobungqina obuvela kwibhunga lolawulo, kwinqununu nakumphathi wesekethe bokuba abakho ootitshala abangaphezu kwemfuneko abafumanekayo yaye akafumanekanga utitshala osanda kufumana amabanga emfundo okanye akakho utitshala onokugayelwa ukuqeshwa kweso sithuba.
8. Apho ibhunga lolawulo lingakuxhasiyo ukutshintshwa kwemeko yengqesho yethutyana/yemvumelwano katitshala itshintshelwe kwingqesho esisigxina, ibhunga lolawulo malingenise isicelo sikatitshala nencwadi ebhaliweyo enezizathu ezamkelekileyo ezicacisa ukuba kungani na kungaxhaswayo ukutshintshwa kwengqesho.

9. Ootitshala ababambeleyo abasemsebenzini (*serving substitute educators*) banako ukuqwalaselelwa ukuqeshwa ngokusisigxina, ngokwemiqathango ecaciswe kule setyhula, ukuba isithuba eso sithe sangabi namntu lo gama babambeleyo kuso yaye utitshala makabe uyazifezekisa iimfuno ezimiselweyo. Makaqinisekise amabhunga olawulo neenqununu ukuba kusebenza imiqathango yokungabandakanywa kootitshala abathile echazwe kwingongoma 4.
10. ISebe iWCED linika ingqinisekiso yokuba inkqubo yokutshintshwa kwengqesho ngokwesiqendu 6(b) se-EEA, njengoko kucacisiwe, iyakuvumela ukutshintshwa kwengqesho jikelele kunyaka wokufunda.
11. Ootitshala bethutyana/bemvumelwano abanqwenela ukwenza isicelo sokutshintshwa kwengqesho yabo yethutyana itshintshelwe kwengqesho esisigxina ngokwesiqendu 6(b) se-EEA, mabangenise ifom *DPE1 form* (Ifom yokwenza isicelo sokuqeshwa) nencwadi ebhaliweyo enika izizathu ezamkelekileyo, **ngokuqala kugqithwe kwibhunga lolawulo** kwiSebe iWCED.
