Isihloko: Izimemo eziya kwiindwalutho okanye kwiindwendwe ezihloniphekileyo nomgaqo omawulandelwe

1. Le setyhula ihlaziyiwe yaye iyitshitshisa ngokupheleleyo iSetyhula 0018/2015.
2. Amaziko emfundo aseNtshona Koloni avamise ukutyelelwa ziindwalutho ezinjengabaphathiswa bamasebe kazwelonke okanye awephondo okanye ziindwendwe ezihloniphekileyo.
3. Nokuba indwalutho okanye undwendwe oluhloniphekileyo lumenywe liziko okanye nokuba indwalutho okanye undwendwe oluhloniphekileyo lucela ukutyelela iziko, kukho umgaqo othile omawulandelwe.
4. Lo mgaqo ulandelayo, omawulandelwe ngawo onke amaqela achaphazelekayo, unenjongo yokukhuthaza ukuthungelana ngokufanelekileyo kwengcaciso ngotyelelo olunjalo kuwo onke amasebe ephondo:
 - 4.1. Izimemo ezicela uMphathiswa wePhondo wezeMfundo (emva koku obizwa ngokuba "nguMphathiswa wePhondo") ukuba abe ngumsindleki wethoko, kufuneka kuvunyelwane ngazo yaye mazisayinelwe liSebe loMphathiswa wePhondo.
 - 4.2. Izimemo apho izikolo zisebenzisa khona igama likaMphathiswa wePhondo ukutsalela iindwendwe kwitheko labo, kufuneka kuvunyelwane ngazo yaye mazisayinelwe liSebe loMphathiswa wePhondo.

- 4.3. Makuthunyelwe isimemo esiya kuMphathiswa wePhondo ubuncinane kwiiveki eziyi-6 phambi kwetheko yaye makusoloko kungqinisiswa oko ngencwadi ebhaliweyo.
- 4.4. Isimemo masichaze uhlobo lwetheko elo, uhlobo lwesinxibo esilindelekileyo kwanokuba ingaba indwalutho okanye undwendwe oluhloniphekileyo kuya kulindeleka ukuba lwenze nayiphi na imisebenzi.
5. Xa indwalutho, enjengoMphathiswa wePhondo, icela ukutyelela iziko okanye icelwa ukwenjenjalo, inqununu mayazise iNtloko yeSebe leMfundo nomlawuli wesithili ochaphazelekayo ngotyelelo olucetywayo ngoko nangoko.
6. **ITheyibhile yoLuhlu lweZikhundla ngokoBaluleko lwazo (Official Table of Precedence)**
- 6.1 Kuya kunikwa ingqwalaselo uluhlu lolandelelwano lwezikhundla ngokobaluleko lwazo olumiselweyo kwiTheyibhile yoLuhlu lweZikhundla ngokoBaluleko lwazo eqhotyoshelwe apha kuyo yonke imisebenzi yaseburhulumenteni evunyiweyo.
- 6.2 ITheyibhile yoLuhlu lweZikhundla ngokoBaluleko lwazo isebenza kwezo ndidi zeendwalutho ezidweliswe kule theyibhile.
- 6.3 Xa kudraftwa iprogram yetheko laseburhulumenteni, makuqatshelwe ukuba okona kunokwenziwa kufanelekileyo kukuba loo ndwalutho ichaziweyo yenani elisezantsi lodidi lwesikhundla kwi-Official Table of Precedence, mayibe siSithethi esiBalulekileyo. Ukuba kuthetha iindwalutho ezininzi, indwalutho yelona nani lisezantsi lodidi lwesikhundla mayithethe ekugqibeleni.
7. **Amalungiselelo anxulumene nokutyelela kukaMphathiswa wePhondo**
- 7.1 UMphathiswa wePhondo, xa emenyiwe, kufuneka anikwe iprogram eyidrafft ubuncinane kwiintsuku eziyi-14 phambi kwetheko, neprogram ekuvunyelwene ngayo yokugqibela, kwiintsuku ezisixhenxe phambi kwetheko.
- 7.2 Kwitheko, eyona ndawo yokupaka ikufutshane kwisango kufuneka igcinelwe uMphathiswa wePhondo.
- 7.3 Ekufikeni kwakhe, abathunywa abamamkelayo kufuneka babe linani eliphakathi kwegosa elinye ukuya kwamane, ekufuneka babandakanye inqununu, uSihlalo webhunga lolawulo, umlawuli wesithili (apho kufanelekileyo), neNtloko yeSebe leMfundo (apho kufanelekileyo), ekufuneka ibekho phambi kokufika koMphathiswa wePhondo.
8. Ukuba indwalutho okanye undwendwe oluhloniphekileyo luliLungu lesiGqeba soLawulo (Member of the Executive Council) (MEC) lelinye isebe lephondo, inqununu kufuneka yazise uMphathiswa wePhondo, iNtloko yeSebe leMfundo kunye nomlawuli wesithili ochaphazelekayo.

9. Ukuba indwalutho etyelelayo nguMphathiswa weSebe leMfundo esiSiseko, makakhatshwe ubuncinane ngomnye waba bantu balandelayo: uMphathiswa wePhondo weMfundo, iNtloko yeSebe leMfundo, uMlawuli oyiNtloko weZithili okanye umlawuli wesithili ochaphazelekayo.
10. Ukulandelwa kwesi sikhokelo ngawo onke amaqela achaphazelekayo esisebenza kuwo kuya kufaka igalelo ekuthungelaneni okufanelekileyo kwengcaciso kunye nakwimpumelelo yamalungiselelo enziwayo xa amaziko emfundo etyelelwa ziindwalutho ezihloniphekileyo okanye ziindwendwe ezihloniphekileyo.

No.	Categories of Dignitaries
1	The President of the Republic of South Africa or the Acting President
2	The Deputy President and the President-elect (for the period between his or her election and assumption of office)
3	The Chief Justice or the Acting Chief Justice and the President of the Supreme Court of Appeal and the Acting President of the Supreme Court of Appeal
4a	Former Presidents of the Republic of South Africa, in order of seniority
4b	Former Deputy Presidents, in order of seniority
5	Cabinet Ministers, the Speaker of the National Assembly, the Chairperson of the National Council of Provinces and Premiers of the respective provinces, in order of seniority
6a	Ambassadors Extraordinary and Plenipotentiary (officiating), High Commissioners and Apostolic Nuncios or Pro-Nuncios, in order of seniority

7c	The Chief Whip of the majority party in the National Assembly and the Chief Whip of the National Council of Provinces, and Deputy Speakers of Provincial Legislatures, the Chairperson of the Standing Committee on Public Accounts in the National Assembly and the Parliamentary Counsellor of the President, in order of seniority
8	The Secretary of the Cabinet and the Chief of the National Defence Force (see rule 3)
9a	Chargé d'Affaires ad interim of embassies, in order of seniority
