ISihloko: *Ukuhlaziywa kwe-Accounting Officer's System ne-Supply Chain Management Delegations*

1. Le setyhula yenzelwe ikhupha ii-*Accounting Officer's System (AOS) and Supply Chain Management (SCM) Delegations* ezihlaziyiweyo ezisebenza kwiSebe leMfundo leNtshona Koloni (WCED). I-AOS ne-SCM *Delegations* zeSebe iWCED ziqhotyoshelwe apha yaye makuqaliswe ukuphunyezwa kwazo ukuqalela ngoku.
2. ISebe iWCED malilandele mbo iSahluko 16A se-*Western Cape Provincial Treasury Instructions (PTIs)*, eyakhutshwa ngowe-23 Septemba 2019 nesaqala ukusebenza ukususela ngowe-01 Oktobha 2019.
3. Umhlathi 3.1.1 weSahluko 16A sePTIs ucacisa ukuba "igosa elimele ukuphendula ngosetyenziso lwemali okanye abasemagunyeni ekusetyenzisweni kwemali beziko ekusebenza kulo le Miyalelo, mabenze, barekhode, balondoloze yaye baphumeze isistim esebenza ngempumelelo yolawulo lwesisitim yoqhagamshelwano nabathengi nabathengisi".
4. Ngokwesiqendu 38(1)(a)(iii) soMthetho woLawulo lweMali kaRhulumente, 1999, (uMthetho 1 ka-1999) (*Public Finance Management Act, 1999 (Act 1 of 1999)*):
(1) "igosa elimele ukuphendula ngosetyenziso lwemali (*accounting officer*) lesebe, le-entithi yorhwebo (*trading entity*) okanye leziko i-constitutional institution—
(a) maliqinisekise ukuba isebe okanye i-entithi yorhwebo okanye iziko

i-constitutional institution, linayo yaye liyayilondoloza—

(iii) isistim efanelekileyo yokuthengwa nokubonelelwa kweempahla neenkonzoyenziwa ngobulungisa, esekuhleni nekhuthaza ukhuphiswano neyonga iindleko;”.

5. ISistim i-*Accounting Officer's System (AOS)* yenziwa ngokungqinelana nale miyalelo ikhankanyiweyo ye-Ofisi kaNondyabo wePhondo nePFMA nokuqinisekisa ukuthotyelwa kwemigqaliselo yayo.
6. ISebe iWCED ngamathuba athile malizijongisise ii-AOS neSCM *Delegations* ukuqinisekisa ukubasemthethweni nokugqibeka kwazo. Ngowe 09 Disemba 2019, iNtloko yezeMfundo yazivuma izilungiso ezifakelwe kwi-AOS nakwi-SCM *Delegations*.
7. Niyacelwa ke ngoko ukuba niqinisekise ukuba zonke iipraktishina zeSCM zizilandela ngokukhawuleza iinkqubo zeSCM ezihlaziyiweyo ngokungqinelana ne-AOS neSCM *Delegations* esele zikhankanyiwe. Iikopi ezihlaziyiweyo ze-AOS neSCM *Delegations* ziqhotyoshelwe apha.
8. Kucelwa kwaziswe okuquluthwe kule setyhula bonke abachaphazelekayo ukuze bakuthathele ingqalelo.
