Isishwankathelo esifutshane: *Imigaqo yokungeniswa kwezeloko zokuthengwa kwefanitshala nezinye izixhobo (kubandakanya neze-ICT) ukulungiselela uNdlinkulu nee-ofisi zezithili.*

1. Le setyhula ihlaziyiwe yaye iyitshintsha ngokupheleleyo iSetyhula 0068/2015, yomhla we-02 Disemba 2015.
2. Konke ukuthengwa kwefanitshala nezinye izixhobo makwenziwe ngokuqala kugqithwe kwiCandelo loLawulo loKuthengwa kweeMpahla neeNkonzo kwaNdlinkulu, zingathathelwanga ngqalelo iindleko ezichaphazelekayo. Oku kuya kuqinisekisa ukuba:
 - a) kusetyenziswe i-Item Control Number (ICN) kwi-LOG/S;
 - b) kufakwe ibhakhowudi kwi-ayithem yakuba izisiwe;
 - c) inkcazo echanekileyo, ixabiso nendawo ziyabhalwa kwiRejista yee-Asethi (Asset Register); yaye
 - d) iRejista yee-Asethi ichanekile yaye ihlaziyiwe.
3. Makulandelwe la manyathelo alandelayo uku-odola ifanitshala nezinye izixhobo:
 - 3.1 Makuzaliswe i- LOG 1 requisition form
 - 3.1.1 Xa ngaba kusarhoxisiwe ukuthengwa kwefanitshala (moratorium on the acquisition of office furniture) yakwaNdlinkulu, makufunyanwe imvume kuqala kwiNtloko yezeMfundu. Ngokumalunga nezixhobo zazo zonke ikhomponenti ezikwiProgram 1, makufunyanwe imvume yenkxaso-mali yoku kuthengwa kwezi zixhobo kulolu hlolo

kuSekela Mlawuli-Jikelele weeNkonzo zeZiko yaye imvume elolu hlobo mayiqhotyoshelwe kwirikhwizishini.

- 3.1.2 Kwikholam yenkcazo (*description column*), makuchazwe ngokupheleleyo i-ayithem efunekayo yaye makufundwe iinkcukacha eziyichazayo (*specification*) (ukuba ziqhotyoshelwe).
- 3.1.3 Makufakwe ubungakanani bezo zithengiwego nobungakanani bezo zivunyiweyo.
- 3.1.4 Makuboniswe apho ifanitshala/izixhobo ziya kufunyanwa khona kwi-“Inventory/Personnel No.” column. Umzekelo, u-500E uchaza umphathi ojongene nestokhwe (i-Cost Centre) kulandele u-06-30 omele inombolo yegumbi engu-30 kumgangatho we-6. Inombolo i-door barcode number efakwa nguNdunkulu kwii-cost centres mayirekhodwe ukuba iyindawo ekhoyo.
- 3.1.5 Apho ku-odolwe ngaphezu kwe-ayithem enye efanayo, umphathi ojongene nestokhwe (*responsibility manager*) makaxele indawo apho i-ayithem nganye iya kufumaneka khona. Umzekelo, ukuba ku-odolwe izitulo ezibini yaye esinye sisetyenziswa kwiGumbi 1, esinye isitulo sisetyenziswa kwiGumbi 2, la magumbi ke ngoko iya kuba ngamagumbi amabini ahlukaneyo. Apho kukho isithuba esinganelanga kwi-LOG 1 form, makwenziwe ilisti eyahlukaneyo ize iqhotyoshelwe.
- 3.1.6 Makuqinisekiswe ukuba ilisti eqhotyoshelwe kwifom yerikhwizishini, ayigqithi kwii-ayithem zemigca elishumi. Ukuba kufuneka ii-ayithem ezingaphezu kwezemigca elishumi, makungeniswe ifom yerikhwizishini eyahlukaneyo.
- 3.1.7 Makuzaliswe iikholam i-“Replacement Quantity” okanye i-“Increase in Capacity”. U-“Replacement” ubhekisa kwii-ayithem ezilahlekileyo/ezibiweyo/eziza kukhutshwa ezincwadini ezingasasyenziswayo (*lost/stolen/to be written off*) yaye ukuthi “Increase in Capacity” kuthetha ii-ayithem ezongezelelweyo zenkcazo efanayo eseles zikuloo ndawo.
- 3.1.8 Ukuthengwa kwefanitshala nezinye izixhobo ngokumalunga namacandelo aqhagamshelene nebajethi yeProgram 1 kuxhomekeke ekufumanekeni kwebhajethi ngumphathi weprogram yaye ngoko ke irikhwizishini mayisayinwe nangumphathi weprogram.
- 3.2 Makuzaliswe i-LOG 1 requisition form ngokumalunga nefanitshala nezinye izixhobo yaye mayisayinelwe ngumphathi ojongene nestokhwe nayii-SCM champion yaye mayithunyelwe kuMlawuli oNcedisayo: weSupply Chain Management Policy, Planning and Performance Management kumgangatho we-6 kwiGumbi 6-12 e-Grand Central Towers ukwenzela iinjongo zokurekhodwa kwayo.
- 3.3 Makuqhotyoshelwe i-PGWC 002 BAS allocation form kwifom yerikhwizishini yaye makuboniswe ibhajethi efumanekayo yezo zinto zithengwayo. Le fom mayitshekishwe

yaye isayinwe ligosa eliyi-SCM champion. ICandelo loLawulo loLwabiwo noSetyenziso-mali (Management Accounting) makuthethwane nalo ngokumalunga nesitraktsha senkcitho esichanekileyo emasisetyenziswe.

4. linkcukacha zee-ayithem (*specifications*) neerikhwizishini ezingazaliswanga ngokupheleleyo zizizathu ezixhaphakileyo ezibangela ukulibaziseka ekusingathweni kwenkubo yokuthengwa kwee-ayithem (*processing of requisitioned items*). Ezinye ii-ayithem kufuneka zenziwe ngabathengisi ngokwexesha elimisiwego eliphakathi kokuqaliswa ukwensiwa nokugqitywa kwazo (*set lead time*) yaye ke ngoko ezi ayithem azinako ukufumaneka kwangoko xa ziceliwe. Ngaphezu koko, izixhobo ze-*Information and Communication Technology (ICT)* zixhomekeke ekungenisweni kwazo kweli lizwe (*importation*) yaye umntu kufuneka athathele ingqalelo ixesha elithathwa yi-*Original Equipment Manufacturer (OEM)* kwiRiphabliki yoMzantsi Afrika (RSA) ukufaka i-odolo phesheya kolwandle, elokuba yensiwe (*assembled*), isiwe kwinkqubo yezerhafu (*customs process*) ejongene neemveliso ezingeniswa kweli lizwe ukuze emva koko ifike apha eMzantsi Afrika (RSA) emva kokuba kufezekekiswe iimfuno ezimiselwego zokungeniswa kweemveliso kweli lizwe (*importation requirements*). Kuya kuba kusemva koku ukuba ongumthengisi kwakhona (*reseller*) abenako ukuyisa kulo ndawo isetyenziswa kuyo. Kukwabalulekile nokukhumbula ukuba ukuthengwa kanye kanye kwezixhobo ze-*ICT* kugunyazisa ngokoMthetho we-State *Information Technology Agency (SITA)*, 1998 (uMthetho 88 ka-1998), ngoko ke, ukuba i-SITA ayikenzi malungiselelo emvumelwano yosetyenziso ngawo onke amasebe kaRhulumente ngokumalunga nokuthengwa kwee-ayithem eziqhelekileyo (*supply of standard items*), ukuthengwa kwazo makwensiwe ngokuqala kugqithwe kwi-SITA yaye oku kunexesha lako elimisiwego.
5. Ngenxa yeso sizathu makurekhodwe oku kulandelayo:
 - 5.1 li-ayithem zemvumelwano zii-ayithem ezifumanekayo kwiimvumelwano ezibandakanya amanye amasebe (*transversal contracts*) zeSITA kaZwelonke okanye eyePhondo (*National or Provincial or SITA transversal contracts*), nezibandakanya:
 - a) ukuthengwa kweebrendi ezikhethhekileyo (*specific brands*) neendidi zoomatshini abazii-shredders neebrendi ezikhethhekileyo zee-data video projectors (kucelwa uthetha-thethane noMlawuli oNcedisayo (*Assistant Director*) weSpecifications and Quotations ngokumalunga nezi brendi ukumisela ukufaneleka kwazo;
 - b) ukurentwa koomatshini bokufotokopa nokuvvelisa amaxwebhu (*reprographic machines*), izixhobo ezizii-standard *ICT equipment* (ii-desktop PCs, ii-laptops nee-printers, njl.njl.); kunye
 - c) ne-*ICT software* eqhelekileyo.
 - 5.2 Abaphathi abajongene nestokhwe mabaqinisekise ukuba, ngokumalunga nezixhobo ze-*ICT* ne-software, imvume ye-*ITOPSCOM* ihamba kunye nerikhwizishini evuniyiweyo. I-*ITOPSCOM* yeSebe leMfundo leNtshona Koloni (WCED) ikhuphe le listi iqhotyoshelwego ibonisa ukuba zeziphi na ii-ayithem ezifuna imvume ye-*ITOPSCOM*.

- 5.3 Kucetyiswa ukuba kwii-ayithem ezifumaneka ngemvumelwano nakwezo zixhomekeke ekwenziweni kwazo ngabavelisi, ixesha eliphakathi kokuqalwa nokugqitywa ukwenziwa kwazo (*lead time*) leenyanga ezintathu (3) ubuncinane, licwangciselwa ukuziswa kwe-ayithem okulindelekileyo.
- 5.4 Ii-ayithem ezingezizo ezemvumelwano (*non-contract items*): Ezi zi-ayithem ezingafumanekiyo nakweyiphi na imvumelwano nezo kufuneka kufunwe umthengisi wazo ngeenkubo ezifanelekileyo (nokuba kungendlela yeziniki-maxabiso emiselweyo (*a formal tender*) enokuqhutywa ithuba leenyanga ezintathu (3) okanye ngendlela yokufumana iikowuteshini nge-*Integrated Procurement Solution (IPS)*). Nangona le ndlela yamva (inesixa esiqingqiweyo esiyinkcitho efikelela ku-R500 000) inexesha elifutshane lokugaqitywa kwayo yonke inkubo yezentengo (*turn-around time*), intengiso isaxhomekeke ekwenziweni kwayo ngumvelisi okanye ekuthengweni kwayo kumazwe angaphandle (*manufacturing or importation*) yaye ke ngoko apha kusebenza iinyanga ezintathu ekucetyiswa ngazo apha.
6. ISebe iWCED linyanzelekile ukuba lihambe mbo ngokweMiyalelo ye-Ofisi kaNondyebo (*Treasury Instructions*) ngokumalunga nee-inventri yaye iRejista yee-Asethi iya kuhlaziya ngokuqhubekekayo. Mayixininiswe into yokuba yonke ifanitshala nezihobo ezizisiweyo kulowo uza kuzisebenzisa (*end user*), ziselugcinweni nakulondolozo lomphathi ojongene nestokhwe kwaye oko kuya kuhlala kuluxanduva lwalo mphathi ujongene nestokhwe uchaphazelekayo. Ifanitshala nezihobo ezilolu hlobo, emva kokuziswa kwazo, mazigcinwe kwindawo enqatyisiweyo de kube lelo xesha lokukhutshwa kwazo zinikwe umsebenzisi ngamnye yaye apha kufanelekileyo mazifikwe yi-Centre for e-Innovation (CEI). Oku kubaluleke gqitha ngokumalunga ne-*Annual ICT Refresh programme* apha, emva kokuba zi-odolwe ii-ayithem, umthwalo usiwa ngqo kulo mphathi ujongene nestokhwe sele esaziwa. Apha ii-ayithem ezininzi (*multiple items*) ze-ayithem enye zithengelwa ukusetyenziswa ngabantu ngabodwa nanini na naxa ziyimfuneko, umphathi ojongene nestokhwe makagcine irejista yerisithi yokukhutshwa/yokufunyanwa kwazo ukulungiselela iinjongo zokuphicothwa kweencwadi. Umzekelo wale meko kukusetyenziswa kwee-notebook computers okanye iikhompyutha.
