**Isihloko: Ifom yeSicelo soHambo eHlaziyiweyo (isigunyaziso soHambo) elungiselelwe ukukhutshwa kwezithuthi zeGG**

1. Le setyhula ihlaziye yaye ikwatshitshisa yaye ithatha indawo yeSetyhula 0025/2015, yowe-10 Apreli 2015, ngokupheleleyo.
2. Ifom yeSicelo soHambo (GMT 2019-01) ihlaziye yiGovernment Motor Transport (GMT) yaye ukwenjenje iqhotyoshelwe apha ukulungiselela ukuba iqalise ukusetyenziswa ngoko nangoko.
3. Kugunyaziswa la magosa alandelayo ngokwemigqaliselo namagunya agqithiselweyo kuwo ukuba avume izigunyaziso zeehambo:
  - AmaSekela Balawuli okanye abaphezulu kunabo kwaNdlunkulu nakwii-ofisi zezithili; kunye
  - NeeNtloko zamaCandelo kumaziko.
4. Sakuba sivunywe isigunyaziso sohambo, umphathi makazise umqhubi wesithuthi seGG ukuba abe nolwazi ngokupheleleyo ngemigqaliselo njengoko ibhaliweyo kwiSetyhula 3/3/4/P yeSebe leNkulumbuso, yowe-23 Disemba 2013.
5. Abaqhubi bezithuthi zeGG bathatha uxanduva olupheleleyo lwalo naluphi na ulwaphulo-mithetho yendlela abalwenzileyo lo gama besebenzisa izithuthi yaye mabasebenzise iithegi ezi-Orenji zeVDO zomqhubi ngamnye ngawo onke amaxesha, nje ukuba iithegi ziqalise ukusetyenziswa yiGMT.
6. Amagosa asebenzisa izithuthi zeGG makaqhoboshele ikopi yelayisensi yokuqhuba yawo yakutshanje exhuzulelwe amanqaku ngokophula umthetho wendlela (*driver's*

*licence demerit points*) nje ukuba kuqaliswe ukusetyenziswa ngokupheleleyo koMthetho i-Administrative Adjudication of Road Traffic Offences Act, 1998 (Act 46 of 1998), njengoko ufakelwe izilungiso, liSebe lezoThutho likaZwelonke.

7. Isigunyaziso sohambo esiphathelele ekwabelweni izithuthi zeGG ngokusisigxina sisebenza ngokusemthethweni ithuba lenyanga enye yekhalenda yaye masikhatshwe sisicwangciso sokusisebenzisa esimiselweyo. Sisemthethweni kuphela isigunyaziso sohambo kumagosa awenze imisebenzi esemthethweni yaye ngabakhweli babucala abagunyaziswe ngokusemthethweni ukuba bahambe namagosa agunyazisiweyo.
8. Isigunyaziso sisebenza ngokusemthethweni kuphela ukuba inombolo yesigunyaziso yesebe ikhutshiwe ligosa lezoThutho elichaphazelekayo kwaNdlunkulu okanye kwi-ofisi yesithili. Izigunyaziso ezinezitampu zentsusa mazigcinwe kwisithuthi seGG ngawo onke amaxesha yaye mazifumaneka xa zifunwa.
