Isishwankathelo esifutshane: Le setyhula yazisa amagosa ekufuneka asebenzise izithuthi zeGaraji kaRhulumente (Government Garage (GG)) ngemfuneko yepemithi yokuqhuba i-professional driving permit (PrDP) efuneka kwiimeko ezithile.

ISihloko: Imfuneko yokufumana i-PrDP yeendidi ezithile zezithuthi

1. Le setyhula ihlaziyiwe ngako oko itshitshisa yaye iyithathe ngokupheleleyo indawo yeSetyhula 0044/2015, yomhla we-18 Agasti 2015.
2. Ukuqhuba kwindlela kawonke-wonke eMzantsi Afrika nokuthutha imithwalo okanye imithwalo eyingozi okanye abakhweli ngenjongo yengeniso, kufuneka ubenayo i-PrDP.
3. KwiSahluko 4 kwisiqendu 32 soMthetho we-National Road Traffic Act, 1996 (Act 93 of 1996), owaqala ukusebenza ngowe-01 Agasti 2000, kucaciswa ukuba abaqhubi bazo naziphi na iindidi zezithuthi ezidweliswe apha ngezantsi (nokuba bona banganini bezithuthi okanye akunjalo nokuba bakhwelise abakhweli okanye akunjalo) kwindlela kawonke-wonke, mababe banayo i-PrDP.

3.1 Unokufaka isicelo se-PrDP kulo naliphi na iziko lokuvavanyelwa ilayisensi yokuqhuba (*driving licence testing centre*). Izicelo mazibandakanye la maxwebhu ayimfuneko neentlawulo abizwa:

- Uxwebhu olusisazisi esamkelekileyo (ID)/ikhadi elisisazisi;
- Iifoto ze-ID ezimbini zomenzi-sicelo;
- Ilayisensi yomqhubi eyintsusa;
- I-Medical Certificate (i-MC form);
- Ifom yokwenza isicelo i-PrDP (ifomu ye-PD1); kunye
- neNgxelo yokucoca konke (*clearance report*) yeNkonzo yamaPolisa oMzantsi Afrika .

3.2 Ezi fom zikhankanywe apha ngentla ziyafumaneka kulo naliphi na iziko lokuvavanyelwa ilayisensi yokuqhuba (*driver's licence testing centre*).

4. Imiqathango yoMthetho i-NRT Act ibophelela bonke abemi yaye ke ngoko nabo bonke abaqeshwa beSebe leMfundo leNtshona Koloni namaziko aphantsi kolawulo lweSebe. KwiSahluko 4, isiqendu 32 salo Mthetho ukhankanyiweyo ke ngoko sikwasebenza nakubaqhubi bezithuthi ze-GG kwezi ndidi zichazwe ngasentla. Iintloko zalo maziko asebenzisa naluphi na udidi lwesithuthi maziqinisekise ukuba bonke abaqhubi banayo i-PrDP eyimfuneko. Iindleko ezichaphazelekayo zimelwe ukuhlawulelwa kwibhajethi yeziko elo.
