## 1. Intshayelelo

ISigqibo 7 se-*Public Service Coordinating Bargaining Council (PSCBC)* sango-2015, somhla we-27 Meyi 2015, saqalisa i-GEHS esiskim ukukhuthaza ukuba abasebenzi benkonzo karhulumente babe ngabanini-makhaya. ISebe leMfundo leNtshona Koloni linqwenela ukunazisa ukuba BONKE abaqeshwa abafumana isibonelelo okanye abaceba ukufikelela kwiinkonzo ezibonelelwa siSkim i-GEHS, mababhalise kwiSkim i-GEHS.

## 2. Iinjongo zeSkim i-GEHS zezi zilandelayo:

- 2.1 Ukuqalisa iSkim i-GEHS ngokwegatya 4.2 leSigqibo 4 se-PSCBC sango-2010, igatya 3.3 leSigqibo 2 se-PSCBC sango-2011 negatya 19 leSigqibo 1 se-PSCBC sango-2012;
- 2.2 Ukunika inkxaso, ukufundisa nokucebisa abaqeshwa ngeendidi namathuba abanokukhetha kuwo okuba nezindlu;
- 2.3 Ukwandisa amathuba okufikelela kwabaqeshwa kwizindlu ezifikelekayo;

- 2.4 Ukukhuthaza ukuba ngabanini-makhaya kwabaqeshwa nokuququzelela ukhuseleko lwee-asethi kubaqeshwa;
- 2.5 Ukuncedisa abaqeshwa ngokufikelela kwiimali-mboleko zezezindlu neemali ezifikelelekayo;
- 2.6 Ukuncedisa abaqeshwa barente izindlu ngenjongo yokuzithenga nokuba ngabanini-makhaya; kunye
- 2.7 Nokubonelela ngamalungiselelo otshintsho malunga neSkim i-GEHS.

### 3. **Ubhaliso olunyanzelekileyo**

Ngokwegatya 4.1.4 leSigqibo 7 se-PSCBC sango-2015, KUNYANZELEKILE ukuba babhalise aba baqeshwa balandelayo:

- 3.1 Abaqeshwa abaqeshwa phambi kowe-27 Meyi 2015 nabekufaneleka ukuba bafumana isibonelelo sezezindlu kodwa bengenazo izindlu (abaqeshi abarenta izindlu abanemvumelwano yokurenta esemthethweni) nabaqhubekayo ukufumana i-R900 ngenyanga. Isixa esingumahluko esiyi-R556.94 phakathi kwesibonelelo sezezindlu sisonke se-R1456.94 sihlawulwa yaye sigcinwe kwi-*Individual-Linked Savings Facility (ILSF)*; kunye
- 3.2 Nabaqeshwa abaqeshwe ngowe okanye emva kowe-27 Meyi 2015 nabakufaneleyo ukufumana isibonelelo sezezindlu kodwa bengenazo izindlu (abaqeshi abarenta izindlu abanemvumelwano yokurenta esemthethweni) nalapho isibonelelo sezezindlu esiphelileyo sihlawulwa kwiSkim i-GEHS: *ILSF*.
