Short summary: *Increase in amounts payable for boarding, transport and private boarding subsidies and personnel subsidies to hostels and schools.*

**Subject: Increase in amounts payable for boarding, transport and private boarding subsidies and personnel subsidies to hostels and schools**

**1. Hostel boarding, private boarding and private transport subsidies**

1.1 Approval has been granted for an increase in the following subsidies with effect from **01 April 2022:**

1.1.1 Hostel boarding subsidies

The maximum boarding subsidy payable to needy learners in hostels attached to ordinary public schools has been increased from R10 330,00 to R10 770,00 per learner, per annum.

1.1.2 Private boarding and private transport subsidies

The maximum private boarding and transport subsidies payable to needy learners in the West Coast, Cape Winelands, Eden and Central Karoo, and Overberg education districts have been increased from R2 425,00 to R2 530,00 per learner, per annum.

1.2 Please note that the above subsidies have been calculated according to the approved means test (see Institutional Management and Governance Planning Minute 0001/2018, dated 09 March 2018) and the criteria set out in Circular 0143/1998, dated 06 November 1998, and Circular 0029/2001, dated 13 March 2001.

## 2. Personnel subsidies

2.1 Approval has also been granted for increases in the following personnel subsidies with effect from **01 April 2022**:

2.1.1 The personnel subsidy payable to ordinary public schools with an enrolment of fewer than 201 learners, for the employment of administrative and general services staff, has been increased from R680,00 to R 710,00 per learner, per annum. A minimum of R25 960,00 will be paid per school.

2.1.2 The personnel subsidy payable to ordinary public school hostels with fewer than 50 boarders, for the employment of administrative staff, has been increased from R10 330,00 to R10 770,00 per learner, per annum.

2.2 Please note that personnel subsidies have been calculated according to the criteria set out in Circular 0117/2000, dated 03 September 2000, and Circular 0025/2011, dated 11 October 2011.

2.3 A personnel subsidy will not be paid to ordinary public schools with an enrolment of 200 or fewer learners, or to ordinary public schools with an enrolment of 50 or fewer boarders in the hostels attached to it, if it is confirmed that the school has excess public service staff.

3. Funds will only be paid over to a school if the district office certifies it to be financially sound based on the financial activities of previous quarters. Furthermore, if a school is not certified as financially sound on or before the end of the financial year, the school may forfeit its transfer payment funding.
