ISebe iWCED kufuneka lithobele imiqathango yale setyhula, i-National Treasury Regulations and Instructions, i-Provincial Treasury Instructions, i-Accounting Officer's System, i-Supply Chain Management and the Financial Delegation of Powers, ezimalunga neenkqubo zokuthengwa kweempahla neenkonzo neentlawulo, ukuphepha nayiphi na inkcitho engekho mthethweni, engagunyaziswanga, engenanzuzo ekukudyakraza neyilahleko.
