Isishwankathelo esifutshane: *Inkqubo-sikhokelo yeSebe leMfundo leNtshona Koloni (iSebe WCED) ukulungiselela ukwenziwa kweentlawulo ezikolweni/kwamanye amaziko karhulumente.*

Isihloko: Inkqubo-sikhokelo yeSebe iWCED ukulungiselela ukwenziwa kweentlawulo ezikolweni/kwamanye amaziko karhulumente

1. Le setyhula yongeza okubhalwe kwiSetyhula 0021/2022 yomhla we-05 Meyi 2022.
2. Kufuneka iSebe i-WCED liqinisekise ukuba yonke inkcitho-mali iyimfuneko, ifanelekile, iziindleko ezifanelekileyo, yaye irekhodiwe yaye kwenziwa nengxelo ngayo, njengoko kumiselwe kwinkqubo-sikhokelo yemithetho echaphazelekayo.
3. Le nkqubo ilandelayo yamkelwe liSebe i-WCED yaye iyasebenza ngokumalunga neentlawulo ezenziwa ngoomatshini ezikolweni:
 - 3.1 ISebe i-WCED likuvumile ukulungelelaniswa kweentlawulo ezenziwa ngoomatshini ezikolweni ukwenzela ukuphunyezwa kweeprojekthi kwinqanaba lesikolo, kuthathelwa ingqalelo le misebenzi inokwenziwa zizikolo ilandelayo neyabelwe izikolo ngokoMthetho weZikolo zaseMzantsi Afrika, 1996 (uMthetho 84 ka-1996) (ekubhekiswa kuwo apha ngokuba ngulo Mthetho):
 - 3.1.1 apho isebe linqwenela ukwenza igalelo kwiinkqubo eziqhubekayo zesikolo kunye nokuxhasa ngokukodwa iprojekthi, ngokungqinelana neembophelelo zesebe ngokubanzi nezo zichazwe kwisiqendu 34 salo Mthetho;
 - 3.1.2 apho isikolo sabelwe imisebenzi eyongezelelweyo ngokwesiqendu 21 salo Mthetho, equka ukulondolozwa nokuphuculwa kwepropathi yesikolo, ukumisela imisebenzi yesikolo eyenziwa emva kweyokufundisa, izifundo abanokukhetha kuzo, ukuthenga iincwadi zezifundo/iimathiriyeli/izixhobo zokufunda, iintlawulo zeenkonziso zesikolo, kuqukwa neefizi zikamasifundisane, kunye nawo nawuphi na omnye umsebenzi ofanelekileyo ongqinelana nalo Mthetho; kunye

- 3.1.3 nalapho iSebe i-WCED lifikelele kwimvumelwano nesikolo ngokumalunga nokuba isebe liya kwenza igalelo kwiprojekthi ngokwenza intlawulo eyenziwa ngoomatshini kwi-akhawunti ebhalisiweyo yesikolo ukulungiselela iprojekthi leyo.
- 3.2 liprojekthi ezivunyiweyo ezisezikolweni, nakuba oko kungaphelelanga apho, zenzelwe igalelo kwiinkqubo eziqhubekayo esikolweni, inkxaso yabafundi nemisebenzi yokufundisa (kuquka iimviwo zesikolo), ungenelelo ngoncedo kwikharityhulam, iimathiriyeli zokufunda nokufundisa, ifenitshala nezixhobo zesikolo, ngokunjalo neeprojekthi zokulondolozwa okanye ukuphuculwa kwepropathi yesikolo.
- 3.3 liprojekthi zezikolo ezivunyiweyo ukuba zenzelwe iintlawulo ezenziwa ngoomatshini azihambelani nazo naziphi na iinkonzo nezinto eziphambili emazeniwe lisebe ngokwemigaqo yesicwangciso sentsebenzo sesebe.
- 3.4 Zonke iintlawulo ezenziwa ngoomatshini ezivunyiweyo eziya ezikolweni mazihlolwe ngokungqongqo, kusetyenziswa isicwangciso sokwenziwa komsebenzi (*business plan*) esenziwe sisikolo, yaye kuboniswe nenkxaso-mali efunwa sisikolo ukuphumeza iprojekthi.
- 3.5 Naliphi na ibhunga lolawulo, malifake isicelo kwiNtloko yeSebe leMfundo, ngencwadi ebhaliweyo njengenxalenye yesicelo sesicwangciso sokwenziwa komsebenzi, ukuze labelwe umsebenzi ochaphazelekayo, ngokwesiqendu 21 salo Mthetho, ukuba loo msebenzi awabelwanga ibhunga lolawulo. Imvume elolu hlobo, ukuba ivunyiwe, iya kuphelela kuphela kwiinkonzo nezinto zeprojekthi eziza kwenziwa njengoko kucacisiwe kwisicelo sesicwangciso sokwenziwa komsebenzi sesikolo.
- 3.6 Iintlawulo ezenziwa ngoomatshini ezenzelwa le njongo ingasentla zifuna i-*Transfer Payment Agreement (TPA)*, ebandakanya okubhalwe kwiikhontenti zedrafti ye-*TPA* eqhotyoshelweyo (eqhotyoshelwe **njengesiHlomelo A**), nemayingeniswe ngokusayinwa ngawo omabini amaqela achaphazelekayo phambi kokuba kuqale iprojekthi ethile yesikolo eso. Umntu onegunya lokusayina weSebe i-WCED, ubuncinane makabe kwisikhundla sokuba nguMlawuli.
4. Ezi nkqubo zilandelayo zimalunga neendibano ezisemthethweni ezilungiselelwe ukwenziwa kwaNdlunkulu nakwii-ofisi zezithili.
- 4.1 Izikolo zeSebe i-WCED okanye nalo naliphi na iziko likarhulumente linokusetyenziselwa kuphela ukubambela kulo indibano esemthethweni yeSebe i-WCED, ukuba ifasilithi leyo ifumaneka ngaphandle kwentlawulo.
- 4.2 Nangona kunjalo, ukuba azikho iifasilithi ezifanelekileyo ezingahlawulwayo kwizikolo zeSebe i-WCED kunye/okanye kwamanye amasebe karhulumente okanye koomasipala, kuya kusebenza iinkqubo zokuthengwa kweempahla neenkonzo zikarhulumente eziqhelekileyo zokufumana iifasilithi nezokutyiswa kwabantu abakwindibano.
- 4.3 Nazo naziphi na iimpahla neenkonzo ezilolu hlobo ezifunekayo zingathengwa ngokwemimiselo yokuthengwa kwempahla neenkonzo ngokungqinelana nemiqathango ye-*Supply Chain Management (SCM)* emisela:
- imfuno yokupapashwa kwempahla neenkonzo kwimalike evulelekileyo;
 - ukuba umboneleli-nkonzo kufuneka abhalise kwi-*Central Supplier Database (CSD)*; kunye
 - nokufumana iikoteshini ezintathu ubuncinane.

- 4.4 linkonzo ezilolu hlobo zingathengwa ngenkqubo yokuthengwa kwempahla neenkonzoz ezikolweni zeSebe i-WCED kunye/okanye kwamanye amasebe karhulumente okanye koomasipala, ukuba la maziko abhalisiwe kwiziko le-CSD. Iziko i-CSD lichaza iqela lababoneleli-nkonzo ekufuneka kuthengwe kubo ngenkqubo yokuthengwa kwempahla neenkonzoz, yaye la maziko kufuneka akhethe ukuthatha inxaxheba kwinkqubo elandelwayo yokuthengwa kwempahla neenkonzoz karhulumente evulelekileyo yokukhuphisana kwababoneleli-nkonzo.
- 4.5 Zonke iindibano ezisemthethweni neenkonzoz ezinxulumene nazo ezilungiselelwe inkqubo yothengiselwano ukulungiselela ukusetyenziswa kwaNdlunkulu nakwii-ofisi zezithili zalatha iimpahla neenkonzoz, ingezizo iintlawulo ezenziwa ngoomatshini njengokuba iimali zingabonwa njengeziza kuqhubela phambili imisebenzi ezenziwa zizikolo (okanye lelinye iziko likarhulumente elifanelekileyo) endaweni yoko, ibonwa njengekwezela isebe iinkonzoz isebe.
- 4.6 ISebe i-WCED kufuneka lithobele imiqathango yale setyhula, i-National Treasury Regulations and Instructions, i-Provincial Treasury Instructions, i-Accounting Officer's System, i-SCM and ne-Financial Delegation of Powers ezimalunga neenkqubo ezilandelwayo zokuthengwa kwempahla neenkonzoz neentlawulo ukuthintela nayo nayiphi na inkcitho-mali engaqhelekanga, engagunyaziswanga, nengenanzuzo kunye/okanye eyilahleko.

- 5.1 Yonke inkcitho-mali elungelene neemfuno zokurekhodwa (recognition) kwentlawulo eyenziwa ngoomatshini ngokwenkqubo-sikhokelo:
- 5.1.1 Iya kuhlolwa ngokungqongqo ngokwesicwangciso sokwenziwa komsebenzi sesikolo, esib onakalisa inkxaso-mali efunwayo sisikolo ukuze senze iprojekthi;
- 5.1.2 Iya kusetyenziselwa iprojekthi yesikolo kuphela enganxulumananga nayo nayiphi na imisebenzi ephambili emayenziwe yesebe ngokwesicwangciso sentsebenzo yesebe;
- 5.1.3 Iya kuhlelwa njenge-*Transfers and Subsidies* kuxwebhu i-general ledger nakwiingxelo-mali (*financial statements*) zesebe; yaye
- 5.1.4 Iya kufuna uxwebhu i-TPA olungqinisiweyo ngokusemthethweni elisayinwe ngamaqela achaphazelekayo omabini, kuqukwa nesiqinisekiso esibhaliweyo ngokwecandelo 38(1)(j) loMthetho i-*Public Finance Management Act, 1999 (Act 1 of 1999)*, ukuba isikolo seSebe i-WCED okanye nalo naliphi na elinye iziko likarhulumente eliphumeza ulawulo lwezemali ngokuyimpumelelo neesistim zolawulo lwangaphakathi ezisebenzayo, phambi kokuba kwenziwe iintlawulo.
- 5.2 Yonke inkcitho-mali elungelene neemfuno zokurekhodwa kweeMpahla neeNkonzo ngokwenkqubo-sikhokelo kuya kufuneka ukuba zifezekise oku kulandelayo:
- 5.2.1 Impahla neenkonz zingathengwa ngenkqubo yokuthengwa kwempahla neenkonz kuphela ngokungqinelana neemfuno zemiqathango ye-SCM emisela:
- a) ukuba imfuno yeempahla neenkonz kufuneka ipapashwe kwimalike evulelekileyo (*open market*);
- b) ukuba umboneleli-nkonzo kufuneka abhalise kwiZiko i-CSD; kunye
- c) nokuba kufuneka kufunyanwe iikoteshini ezintathu.
- 5.2.2 Kunokusetyenziswa izikolo zeSebe iWCED okanye naliphi na elinye iziko likarhulumente kuphela ukuba:
- a) indawo enjalo ifumaneka ngaphandle kwentlawulo okanye
- b) iziko libhalise kwiZiko i-CSD, elichaza iqela lababoneleli-nkonzo ekufuneka kuthengwe kubo ngenkqubo elandelwayo yokuthengwa kwempahla neenkonz, yaye la maziko kufuneka akhethe ukuthatha inxaxheba kwinkqubo elandelwayo yokuthengwa kwempahla neenkonz karhulumente evulelekele kukhuphiswano lwababoneleli-nkonzo.
- 5.2.3 Kufuneka ibe yiprojekthi yesebe yaye inxulumane nemisebenzi ephambili emayenziwe kwisebe ngokwesicwangciso sentsebenzo sesebe.
- 5.2.4 Inkcitho-mali kufuneka ihlelwe njengenkcitho-mali yangoku (IiMpahla neeNkonzo) ebhalwe kuxwebhu i-general ledger nakwiingxelo-mali (*financial statements*) zesebe.
