**Isihloko: Ukuphunyezwa koMgaqo-nkqubo wokuNgcungcuthekiswa kwiNdawo yoMsebenzi kaRhulumente weNtshona Koloni (Western Cape Government (WCG) Workplace Harassment Policy)**

1. URhulumente weNtshona Koloni (WCG) uzibophelele ekwenzeni indawo yomsebenzi ibe yengenazo zonke iintlobo zokungcungcuthekiswa ngokukhuthaza indlela yokuziphatha ekumgangatho ophezulu kakhulu kubasebenzi nangokuqinisekisa ukuba bonke abaqeshwa bakaRhulumente weNtshona Koloni (WCG) bayazazi yaye bayaziqonda iintlobo zokungcungcuthekiswa kwindawo yomsebenzi.
2. Ukungcungcuthekiswa kwindawo yomsebenzi luhlobo lokucalucalulwa okungamkelekanga yaye akuvumelekanga ngokumalunga nobuni (sex) kunye/okanye isini (gender) kunye/okanye nokuzazi nokubanomdla wokwabelana ngesondo nesini esithile (sexual orientation).
3. Naluphi na uhlobo lokungcungcuthekiswa luthathwa njengokunyashwa kwamalungelo abantu, into echasene nomthetho eMzantsi Afrika, ngoko ke, oko akuvumelekanga kuRhulumente we-WCG.

4. Injongo yoMgaqo-nkqubo wokuNgcungcuthekiswa kwiNdawo yoMsebenzi kaRhulumente weNtshona Koloni:
  - 4.1 kukwenza ukuba bonke abaqeshwa bakaRhulumente weNtshona Koloni (WCG) bazazi iintlobo zokungcungcuthekiswa kwindawo yomsebenzi noxanduva lwabo ekuzithinteleni nasekuzilawuleni izehlo ezilolu hlobo, ukungqinelana nemigqaliselo yomthetho nemiqathango yomgaqo-nkqubo echaphazelekayo;
  - 4.2 kukunika iingcebiso malunga nemigaqo nenkqubo yokuqwalaselwa kwezityholo zokungcungcuthekiswa; kunye
  - 4.3 nokuzama ukufezekisa injongo yokwenza indawo yomsebenzi ibe yengenazo zonke iintlobo zokungcungcuthekiswa.
5. Umhlathi 2 (g) ke ngoko, kwiMigaqo engoKulawulwa noKunikwa kweNgxelo ngokuZiphatha kakubi ngokweZesondo weSebe leMfundo leNtshona Koloni (*Protocol for Managing and Reporting Sexual Misconduct of the Western Cape Education Department*), (makufundwe iSetyhula 15 yowama-2023, yomhla we-06 Apreli 2023), uyatshitshiswa ngokwenjenje, yaye indawo yawo ithathwa nguMgaqo-nkqubo i-WCG *Workplace Harassment Policy of 2022*, (makufundwe iSetyhula 13 yowama-2023 kaRhulumente we-WCG, yomhla we-26 Meyi 2023).
6. Kucelwa iinqununu/iisuphavayiza/abaphathi bazise bonke abasebenzi ngokuqulethwe yile setyhula noMgaqo-nkqubo i-WCG *Workplace Harassment Policy* oqhotyoshelweyo, ukuze bakuthathele ingqalelo.
