Short summary: Revision of the Accounting Officer's System, Supply Chain Management

Delegations and Addendums to the Accounting Officer's System, applicable

to the Western Cape Education Department.

Subject: Revision of the Accounting Officer's System, Supply Chain Management Delegations and Addendums to the Accounting Officer's System

- 1. This circular serves to issue the approved Accounting Officer's System (AOS), Supply Chain Management (SCM) Delegations and Addendums to the AOS, applicable to the Western Cape Education Department (WCED). The AOS, SCM Delegations and Addendums to the AOS were approved on 22 March 2024 and will come into effect on 02 May 2024.
- 2. The WCED must adhere to Chapter 16A of the Western Cape Provincial Treasury Instructions (PTIs), issued on 23 September 2019, and effective from 01 October 2019.
- 3. Paragraph 3.1.1 of Chapter 16A of the PTIs states that "the accounting officer or accounting authority of an institution to which these Instructions apply must develop, document, maintain and implement an effective and efficient supply chain management system".
- According to section 38(1)(a)(iii) of the Public Finance Management Act (PFMA), 1999 (Act 1 of 1999):
 - "the accounting officer for a department, trading entity or constitutional institution—
 (a) must ensure that the department, trading entity or constitutional institution has and
 - maintains—
 - (iii) an appropriate procurement and provisioning system which is fair, equitable, transparent, competitive and cost effective;".

5. The AOS was developed in line with the aforementioned PTIs and the PFMA to ensure

compliance with the prescripts.

6. The WCED must periodically review the AOS and SCM Delegations and Addendums to the

AOS to ensure their validity and completeness.

7. You are therefore requested to ensure that all officials, including the SCM practitioners and SCM Champions within the respective branches, Chief Directorates, and directorates

adhere to the approved SCM processes in accordance with the AOS, SCM Delegations and

Addendums to the AOS.

8. The AOS, SCM Delegations and Addendums to the AOS will be effective as from

02 May 2024. All previous approved versions are herewith repealed.

9. Kindly bring the contents of this circular to the attention of all concerned.
