Isishwankathelo esifutshane: Isikhokelo esibonelelwa nguMlawuli-Jikelele weSebe leMfundo esiSiseko (iSebe i-DBE) emasaziswe kuzo zonke izikolo, ukunceda iinqununu kulawulo lwekhefu lootitshala abasezikolweni

Isihloko: Isikhokelo sokulawula ikhefu lootitshala abasezikolweni ukulungiselela iinqununu

1. Kuphicotho-zincwadi lwamacandelo, uMphicothi-Zincwadi Jikelele waseMzantsi (AGSA), ufumanise ukuba inkqubo yokulawulwa kwekhefu lootitshala abasezikolweni kumasebe emfundo amaphondo ayisebenzi ngokufanelekileyo. Iziphumo zoMphicothi-Zincwadi (AGSA) ezichazwe ngqo ziquke oku:
 - (a) ootitshala abathatha iintsuku zekhefu lokugula ezingaphezulu kunezivumelekileyo kwinkqubo yokulawulwa kwekhefu lokugula yabo;
 - (b) ootitshala abangekhoyo esikolweni nabangazizalisiyo iifom zokuthatha ikhefu;
 - (c) ootitshala abangayizalisiyo irejista yokubakhona qho ngosuku esikolweni; kunye
 - (d) neemeko apho ootitshala bathatha ikhefu lokugula elongezelelweyo, kodwa bangalithathi ikhefu lokungakwazi ukusebenza okwethutyana ngenxa yokungaphili ngokoMgaqo-nkqubo we-*Policy and Procedure on Incapacity Leave for Ill-health Retirement (PILIR)*, 2021).
2. ISebe i-DBE lizibophelele ekubeni libonelele ngesikhokelo sokulawula ikhefu lootitshala abasezikolweni njengenxalenye yenkqubo yokuza nesisombululo sezolawulo esiyimpendulo yoku kuMphicothi-Zincwadi u-AGSA. Esi sikhokelo sijoliswe kwinqununu njengomphathi onoxanduva lokuphendula ngalo msebenzi kwinqanaba lesikolo.

3. ISahluko H kuxwebhu lwe-*Personnel Administrative Measures (PAM)*, 2022), siyalucacisa uninzi lwemiqathango yekhefu esebenzayo kootitshala. Ukongeza koku, uMgaqo-nkqubo i-PILIR, ongumgaqo-nkqubo osebenza phakathi kwamasebe ngokubanzi kwinkonzo karhulumente, uyalicacisa ikhefu lokungakwazi ukusebenza okwethutyana nangokusisigxina ngenxa yokungaphili (*temporary and permanent incapacity*). Ngoko ke, esi sikhokelo masifundwe kunye ne-PAM ne-PILIR.
4. Isikhokelo asifakeli zilungiso kwimimiselo ekhoyo okanye asazisi nayiphi na imiqathango yomgaqo-nkqubo okanye yenkqubo eyenziwayo entsha, yaye asenzelwanga ukutshintshwa okanye ukulungiswa kwemisebenzi yenqununu njengoko kucacisiwe kwiinkcazo zomsebenzi ezivunyiweyo ezichazwe kwi-PAM nakwizigqibo zothethathethwano nemibutho yabasebenzi ezinxulumene noku.
5. Ngaphezu koko, iziphumo zoMphicothi-Zincwadi (AGSA) zikwalatha nokuba kukho imfuno yokuba kuqinise inkqubo yokubekwa esweni kokuphunyezwa komgaqo-nkqubo wekhefu kwinqanaba lesikolo ngabo benza lo msebenzi wokubeka esweni kwezikolo kwinqanaba lesekethe, lesithili nelakwaNdlunkulu. ISebe i-DBE, ngoko ke, lilindele ukuba eli phulo liya kwenziwa ligqibelele ngokomelezwa kokubekwa esweni nayinkxaso yezikolo nokuphunyezwa kolawulo lokuthathwa kwamanyathelo olawulo afanelekileyo xa ingathotyelwanga imiqathango emiselweyo apho iinqununu kunye/okanye ootitshala befunyaniswe bengayithobelanga imiqathango echaphazelekayo.
6. Ukongezelela kwesi sikhokelo, esilungiselelwe ngokukodwa ukunika iingcebiso okanye imathiriyeli engaphezulu enokusetyenziselwa ukuququzelela ukuphunyezwa kwemigaqo-nkqubo nemiqathango, iCandelo laMalungelo aVela kwiiNkonzo lenza ikhosi yoqeqesho yeentsuku ezintathu e-Cape Teaching and Leadership Institute (CTLI). Le khosi ijolise kwiiinqununu ezisanda kuqeshwa kwakunye nakwiiKomiti zoLawulo zeZikolo (SMTs) engoLawulo lokuNgabikho eMsebenzi okuZingileyo (*Management of Leave and Chronic Absenteeism*) phakathi kwezinye izinto. Isehoni yoqeqesho yeentsuku ezintathu eya kuqhutywa amaxesha amathandathu icwangciselwe owama-2024. Ukubakho kwezi seshoni zoqeqesho kuya kuba negalelo elihle ekuqinisekiseni uzinzo esikolweni sakho.
7. ISebe leMfundo leNtshona Koloni (iSebe i-WCED) ngokwenjenje lihambisa isikhokelo esiqhotyoshelweyo kuzo zonke izikolo zesebe ukulungiselela iinqununu njengoko kuceliwe nguMlawuli-Jikelele weSebe i-DBE. Amaxwebhu ekhefu achaphazelekayo, iifom neevidiyo nazo ziyafumaneka kwiiKomiti ze-SMT nakwabanye abaqeshwa kwiziko lewebhu leSebe i-WCED.
