1. Ngowe-19 Septemba 2023, iBhunga eliQuquzelela iNkonzo kaRhulumente (*Coordinating Chamber of the Public Service*) neBhunga eliQuquzelela uThethathethwano (*Coordinating Bargaining Council*) lePhondo leNtshona Koloni abonisene ngokufanelekileyo ngoMgaqo wokuZiphatha kumaKhasi oNxibelelwano we-WCG.
2. Injongo yoMgaqo wokuZiphatha kumaKhasi oNxibelelwano we-WCG kukwazisa abaqeshwa ngoxanduva lomntu abanalo xa bepowusta izinto kumaqonga amakhasi onxibelelwano abo yaye baqinisekise ukuba izinto abazipowustayo (*posts*) kungenzeka ukuba azifanelekanga nokuba ziyingozi nokuba zibeka igama elibi kuRhulumente we-WCG, kubaqeshwa okanye kubemi bakhe.
3. Iinjongo linjongo zalo Mgaqo wokuZiphatha kukwazisa abaqeshwa okulindelwe ngumqeshi ngokuluxanduva lomntu lwabaqeshwa lwaxa besebenzisa amaqonga amakhasi onxibelelwano njengomntu onoxanduva kunye nokunika intsingiselo yoxanduva lwabathathi-nxaxheba.
4. Ukuziphatha Ukuziphatha kakubi kumakhasi onxibelelwano (*Social media misconduct*) kootitshala bezikolo zikarhulumente kulawulwa nguMthetho weNgqesho yooTitshala, 1998 (uMthetho 76 ka-1998), ngakumbi i-Schedule 2, esiqulethe uMgaqo wezoHlwayo neMiqathango yooTitshala (*Disciplinary Code and Procedures for Educators*). I-Schedule 2 kufuneka ifundwe kunye ne-Schedule 8 (*Code of Good Practice Dismissal*) yoMthetho woBudlelwane eMsebenzi (*Labour Relations Act*), 1995 (uMthetho 66 ka-1995).

5. *UMgaqo-nkqubo woNxibelelwano kaRhulumente (Government Communication Policy)*, okhutshwe liSebe loNxibelelwano neeSistim zeNgcaciso zikaRhulumente (*Department of Government Communication and Information Systems*) ngowama-2019, ucacisa ukuba zonke iindlela zonxibelelwano kunye namajelo eendaba (*news media*), kuqukwa inkcazelo okanye ibali elilungiselelwe ukukhutshwa kwijelo leendaba ligosa likarhulumente (*media releases*) iinkcazelo okanye izimvo, udliwanondlebe,amacandelo ezimvo neeleta eziya kumhleli, zifakwa phantsi kwemisebenzi yothethathethwano yamajelo eendaba karhulumente. Indima yothethathethwano yamajelo eendaba yeSebe leMfundo leNtshona Koloni (iSebe iWCED)yabelwe kuphela iCandelo loNxibelelwano.
- 5.1 Izithethi ezinikwe igunya ziquka:
- (a) UMphathiswa wePhondo weSebe leMfundo kunye negosa elisisithethi sakhe (iGosa loNxibelelwano lwaMajelo eeNdaba/ lweMidiya) (*Media liaison officer*) ;
 - (b) Intloko yeSebe leMfundo (*HoD*);
 - (c) UMlawuli weCandelo lezoNxibelelwano;
 - (d) Izithethi ezinika inkxaso nabasebenzi abachongwe ngaphakathi kwiCandelo lezoNxibelelwano; kunye
 - (e) Nezithethi zobugcisa (*Technical spokespersons*) ezichongwe nguMlawuli weCandelo lezoNxibelelwano.
- 5.2 Inkqubo eyenzelwe uthethathethwano lwamajelo eendaba/lwemidiya:
- (a) Imibuzo yamajelo eendaba enxulumene neSebe iWCED, equka zonke izikolo zikarhulumente, kufuneka iqale idluliselwe kuMlawuli weCandelo lezoNxibelelwano okanye kwizithethi ezinikwe igunya ukuze ziyithathele ingqalelo.
 - (b) Makufunyanwe imvume yokwenza uthethathethwano kunye namajelo eendaba ngemiba enxulumene nezikolo.
 - (c) Imvume inako ukufunyanwa ngesicelo se-imeyili esiya kuMlawuli weCandelo lezoNxibelelwano.
 - (d) Ukufota okanye ukwenza ividiyo yamajelo eendaba (*Media photography or videography*) ezikolweni kufuna ukuba kuqale kufunyanwe imvume kwi-HoD okanye kotyunjwe nguye.
 - (e) Zonke iindlela Zonke iindlela zothethathethwano namajelo eendaba mazibephantsi kokuthotyelwa koMthetho *i-Protection of Personal Information Act*. Ifom yokunika imvume echaphazelekayo kufuneka ifunyanwe ukulungiselela iinjongo zokufota (*photographic*) okanye zokwenza ividiyo (*video graphic*).
6. Iintloko zamaziko nabaphathi abachaphazelekayo kufuneka bazise bonke abasebenzi ngokuqulethwe yile setyhula nanguMgaqo wokuZiphatha kumaKhasi oNxibelelwano we-WCG oqhotyoshelwe apha.
