Isihloko: Iskim seebhasari zokufunda ngokungesosigxina sabaqeshwa benkonzo karhulumente (kunyaka wokufunda ka-2018)

1. ISebe leMfundo leNtshona Koloni (iWCED) licela bonke abaqeshwa benkonzo karhulumente abanqwenela ukwenza izifundo ngokungesosigxina ngo-2018 benze isicelo seebhasari zokufunda ngokungesosigxina.
2. Ukungqinelana noMthetho i-National Qualifications Framework Act, 2008 (uMthetho 67 ka-2008), ofakelwe izilungiso, neemfundo ezimiselweyo zokungena kwizithuba zabaphathi abaphakathi nabaphathi abakhulu (*middle management and senior management*), iSebe iWCED liya kuqala likhethe abaqeshwa benkonzo karhulumente abanqwenela ukuphucula amabanga emfundo abo abe kwinqanaba lesidanga (*degree-level*) (NQF 7) okanye abanqwenela ukwenza izifundo ezibakhokelela kwinqanaba lesidanga sokuqala (NQF 7).

 - 3.4 banobungqina bokuba basenzile isicelo okanye banekopi yerisithi yentlawulo evela kwi-HEI) ukwenzela unyaka wokufunda ka-2018;
 - 3.5 bazimisele ukwenza izifundo ngokungesosigxina ngo-2018;
 - 3.6 bafundela ukuzuza ibanga lemfundo ye-*undergraduate qualification* okanye eye-*post graduate qualification*; yaye
 - 3.7 akukho enye ibhasari karhulumente okanye nayiphi na enye ibhasari abayifumanayo.

 - 4.3 Ubulungisa kwezengqesho (ngokohlanga, isini, ukhubazeko);
 - 4.4 Ukuba ngaba abenzi-sicelo basuka kwiindawo zasemaphandleni na okanye kwezasezidolophini;
 - 4.5 Ukufaneleka kwezifundo kwinkcazo yomsebenzi othile;
 - 4.6 Amanqanaba omvuzo nokufumaneka kwemali;
 - 4.7 Amabanga emfundo okuqala ethelekiswa namabanga emfundo esibini; kunye
 - 4.8 Nengcebiso yesuphavayiza, nekufuneka ukuba iqhotyoshelwe kwisicelo.

 - 5.4 Nobungqina besicelo okanye ikopi yerisithi yentlawulo evela kwi-HEI.
6. Aziyi kuqwalaselwa izicelo ezifike emva kwexesha elibekiweyo, ezingazaliswanga ngokupheleleyo nezithunyelwe ngefeksi okanye apho ingabonakaliyo into ebhalwe kuzo.
