Isihloko: Ukubuyiswa kweZafikethi zeMatriki zikaZwelonke ezingabangwanga (unclaimed certificates) zeminyaka edlulileyo (ukususela ngo-1992 ukuya ku-2017)

1. Kucelwa bonke abathathi-nxaxheba kuqukwa iinqununu zezikolo eziphakamileyo/izikolo ezizisekondari, kwakunye nabaphathi baMaziko eMfundo oLuntu (*Community Learning Centres*), ukuba baqwalasele oku kulandelayo:
 - (a) Zonke izatifikethi ezingabangwanga zimele ukufunyanwa yaye zibuyiselwe kwaNdlunkulu weSebe leMfundo leNtshona Koloni emva kwethuba leenyanga eziyi-12 ukususela kumhla amaziko okubhalela iimviwo azifumana ngawo.
 - (b) Izatifikethi zeemviwo zangoNovemba 2017, ezahanjiswa ngo-2018, mazibuyiselwe kwaNdlunkulu ungalulanga owe-31 Julayi 2019. Le nkqubo mayiphindwe qho ngonyaka.
2. Izatifikethi ezingabangwanga ziya kugcinwa kwindawo ekhuselekiyo nenqatyisiweyo kwaNdlunkulu kangangethuba leminyaka emithathu ukulungiselela ukuthathwa kwazo okunokwenzeka ngabaviwa. Ukuba azithathwanga kwelo thuba leminyaka emithathu ziya kutshatyalaliswa.
