Subject: Circulation of "Declaration of Confidentiality, Impartiality and Interest" forms for members of SCM committees

- 1. National Treasury issued the Code of Conduct for Supply Chain Management Practitioners as Practice Note No. SCM 4 of 2003, dated 05 December 2003, and the Western Cape Provincial Treasury issued the Code of Ethics for Supply Chain Practitioners in paragraph 3.8.1 of the Western Cape Provincial Treasury Instructions (PTIs), issued on 23 September 2019, which must be adhered to by all officials and other role players involved in Supply Chain Management (SCM).
- 2. Paragraph 2.1 of the said Practice Note states that: "SCM practitioners, to the extent required by their position, should declare any business, commercial and financial interests or activities undertaken for financial gain that may raise a possible conflict of interests".
- 3. Paragraph 3.4.1 of the PTIs requires that SCM units of the Western Cape Education Department (WCED) comprise of at least the following committees:
 - a) Bid Specification Committee;
 - b) Bid Evaluation Committee;
 - c) Bid Adjudication Committee (the WCED has a Departmental Bid Committee);
 - d) Stock Take Committee; and
 - e) Disposal Committee.
- 4. The "Declaration of Confidentiality, Impartiality and Interest" forms for members are hereby circulated for implementation with effect from 01 October 2019.
- 5. It is trusted that the instructions contained in this minute will be adhered to at all times.
