1. INtloko yeSebe leMfundo iluvumile utshintsho lobume bengqesho yabaqeshwa benkonzo karhulumente.
2. Utshintsho lwengqesho yethutyana ukuya kwingqesho esisigxina lwenziwa ngengqiqo (*discretion*) yeNtloko yeSebe leMfundo leNtshona Koloni (iSebe iWCED).
3. Umqeshwa wethutyana ngumsebenzi oqeshwe ithutyana kwisithuba esivunyiweyo esihlawulelwayo nesingenamntu (*approved substantive vacant post*), kangangethuba eliqingqiweyo (*closed period*). Le nkcazo-gama ayibachaphazeli abasebenzi benkonzo karhulumente abaqeshwe kwisithuba ezingenabantu ezihlawulelwayo zonyuselo-sikhundleni (*vacant substantive promotion posts*) njengababambeleyo.

 - 4.2 Makuqeshwe isigxina kwisithuba esihlawulelwayo esingenamntu kwaye eso sithuba masibhalwe phantsi kwini labaqeshiweyo elabelwe iziko okanye isebe ngo-2019.

4.3 Umqeshwa ochaphazelekayo makabe ngoqeshwe ithutyana, obesoloko eqeshiwe okokoko (*continuous service*) (ingakhange iqhawuke inkonzo yakhe) iinyanga ezintathu kwiSebe iWCED, umhla wakhe wengqesho ube phambi okanye ube ngumhla we-01 Januwari 2019.

4.4 Ukuqwalaselwa kuqala kokumataniswa nokufakwa kwizithuba kwabasebenzi abangaphezu kwemfuneko.

4.5 Izicelo zotshintsho lobume bengqesho azisayi kuvunywa kumaziko okanye kumasebe apho abaqeshwa bachazwe njengabangaphezu kwemfuneko kwinani kwinqanaba elifanayo.
