1. ISaveyi yaQho ngoNyaka ka-2019 yeSebe leMfundo leNtshona Koloni (iWCED) yezikolo zemfundo eenemfundo ezizodwa iya kuqhutywa **nge-05 Septemba 2019**. Kuya kufuneka iinqununu zikusayinele ukuchaneka kwedatha yabafundi neyootitshala kwi-CEMIS. Umhla osikiweyo kwiintloko zokunika inkxaso kubafundi ukusayinela iSaveyi yaQho ngoNyaka ngowe-**12 Septemba 2019**.
2. Phambi kokusayinelwa kwesaveyi kwi-CEMIS, inqununu okanye ummeli wayo makaqinisekise ukuba oku kulandelayo kuboniswe ngokuchanekileyo kwi-CEMIS.
 - 2.1 Bonke abafundi ababhaliweyo nabahamba isikolo ngo-2019, bafakwe kumabakala achanekileyo, kwiiklasi nakudidi lolwimi lokufunda nokufundisa (*language of learning and teaching*) (LoLT).
 - 2.2 Kugqityiwe ukukhutshelwa kwabafundi (abamkelwayo nabakhutshwayo esikolweni).
 - 2.3 Utshintsho ngokwamabakala lwenziwe lwagqitywa.
 - 2.4 Zichanekile iinkcukacha ezingokukhubazeka kwabafundi.
3. Inqununu mayiqinisekise ukuba ilisti yootitshala ekwi-CEMIS ihlaziya iinkcukacha zayo kwaye ingqinisiswe kwangokunjalo neminyaka yamava, amabakala nezifundo ebezifundisa ngo-2019 (mazisuswe iinkcukacha zamabakala nezezifundo ebezifundisa kwiminyaka edlulileyo ukuba azifanele kubakho kumthwalo katiitshala ka-2019).
4. Ukuncedisa ekungqinisisweni kwedatha yabafundi nootitshala, kukho iingxelo zeemposiso eziliqela ezifumanekayo ukucacisa ngedatha efakiweyo (*data*)

captured) kwi-CEMIS. Makuqinisekiswa ukuba zonke iimposiso, njengoko zibonisiwe zezi ngxelo, zisonjululwa kwangaphambi kokusayinelwa kwazo.

5. Icandelo elisayinwayo lesaveyi malizaliswe njengenqubo yokuvunywa kokungqiniswa kwedatha njengelibonisa ngokuchanekileyo ubhaliso lwabafundi nenani lootitshala ngowe-**05 Septemba 2019**.
6. Izikolo ezikwizibhedlela kuya kufuneka zizalise ikopi eliphepha yesaveyi. Le saveyi iya kunikwa izikolo ngqo.
7. Emva kokusayinelwa kwayo isaveyi yinqununu ngowe-**05 Septemba 2019**, kuya kwenziwa i-*snapshot* sayo yonke idatha yabafundi nootitshala yaye iimposiso eziye zangalungiswa, mazilungiswe phambi kokusayinelwa kwayo ziintloko zokunika inkxaso kubafundi (*learner support heads*) ngowe-**12 Septemba 2019**.
8. Inqununu, njengegosa le-EMIS leziko, mayilawule iinqubo zokufaka idatha ekhompnyutheni ukuqinisekisa ukuba ubungqina bokuqinisekisa kunye neesignintsha zabasebenzi ekudluliselwe kubo amagunya okutshekisha idatha bunokunikwa xa bucelwa ngabaphicothi-zincwadi. Mayirekhodwe inqubo yomsebenzi wokufaka idatha ye-EMIS ukuqinisekisa ukuphendula malunga nokuchaneka kwedatha, njengoko iinkcukacha ezo kufuneka kwenziwe uphicotho-zincwadi kuzo. Kucelwa ufunde iNgcaciso eMfutshane yeCandelo loLawulo loLwazi neNgcaciso 0003/2012, yowe-10 Agasti 2012, ukufumana ingcaciso engaphezulu. Kukhunjuzwa iinqununu kwakhona ukuba ukususela ngo-2014, ukuchaneka kwedatha ye-CEMIS ngumqathango ophambili ekuya kuxhomekeka kuwo ukufumana kwezikolo intlawulo yesabelo-mali yesibini ngokwemimiselo nemiqathango yokuxhaswa ngemali (iSetyhula 0044/2013, yowe-29 Oktobha 2013).
9. Kunyanzelekile kusetyenziswe inombolo yesazisi kazwelonke (*ID*) ngabo bonke abafundi kuzo zonke iisistim zasekhompnyutheni zezolawulo nokuphathwa kwezikolo. Ikho ngxelo ye-CEMIS efumanekayo ukuqaphela abafundi abangenazo iinombolo zesazisi nokulungiselela ukufakwa ekhompnyutheni kweenombolo zesazisi ezingekhoyo. Ukuba umfundi akanayo inombolo yesazisi esemthethweni, MAYINGAFAKWA inombolo ye-*ID* engekhomthethweni. Kucelwa ukuba kucetyiswe abazali ngenqubo yokwenza isicelo se-*ID* kwiSebe leMicimbi yaseKhaya (*Department of Home Affairs*) (*DHA*). Kucelwa iinqununu zibancedise abazali apho kunako ukwenzeka oko, ngokuququzelela inqubo yaseDHA.
10. Uphando lwakutshanje oluyi-*Education Data Quality Audit* (*EDQA*) oluqhutywe kwiKota 2 ka-2018, lwaqaqambisa ukuba izikolo azigcini zirekhodi zichanekileyo. Ngako oko, iSebe iWCED liya kubeka esweni ukuthotyelwa kwale nqubo nomgangatho wedatha yawo onke amaxwebhu angenisiweyo eSaveyi yaqho

ngoNyaka yaye liya kunika ingxelo nezenzo zokungathotyelwa kwayo, ukungangqinelani nokungapheleli kwedatha kwiNtloko yeSebe leMfundo.

11. Ziyakhunjuzwa izikolo ezizimeleyo ukuba mazibe nolwazi ngemiqathango yazo yobhaliso. Kucelwa uqaphela ukuba ukulandela mbo ezi mfundo zedatha zimiselweyo zeSebe iWCED kuyinxenye yale miqathango, yaye ukungathotyelwa kwale nkqubo kunokukhokelela ekubeni umfundi akhutshwe ezincwadini zobhaliso (*deregistration*).
