1. Bonke abathathi-nxaxheba, kuqukwa iinqununu zezikolo zemfundo ephakamileyo/ezeesekondari, kwakunye nabaphathi bamaZiko okuFunda asekuHloleni (*Community Learning Centres*), kufuneka bathathele ingqalelo oku kulandelayo:
  - a) Zonke izatifikethi ezingabangwanga kufuneka zikhutshwe kwakhona kwaye zibuyiselwe kwaNdlunkulu emva kwethuba leenyanga eziyi-12 ukususela ngomhla wokwamkelwa kwazo ngamaziko(*centres*); kwaye
  - b) Izatifikethi zemviwo zangoNovemba 2018, ezahanjiswa ngo-2019, kufuneka zibuyiselwe kwaNdlunkulu ungasululanga owe-30 Oktobha 2020. Le nkqubo kufuneka iphindwe ngonyaka ngamnye.

  - d) Izatifikethi kufuneka zithathwe njengezixabiseke kakhulu kwaye mazigcinwe ngokunqatyisiweyo ngalo lonke ixesha kwaye,
  - e) Abaviwa kufuneka baziswe xa izatifikethi zikulungele ukuthathwa kwaye ukuhanjiswa kwazo kufuneka kwenziwe phantsi kwemeko ezikhuselekileyo.
