**Isihloko: linkqubo ezifanayo zokunika iingxelo ngeentlawulo, iimali eziyingqokelela yenzala nezotyalo-mali (accruals) neemali ezingekahlawulwa zethuba elifutshane (payables)**

1. Injongo yale ngcaciso imfutshane kukunika isikhokelo neenkqubo ezimalunga nemiba ebaluleke gqitha kunye namanyathelo amakathathwe ngabo bonke abadlali-ndima abachaphazelekayo kwiSebe leMfundo leNtshona Koloni (WCED) ngokubanzi, ukunika iingxelo ngeemali eziyingqokelela yenzala nezotyalo-mali (accruals) neemali ezingekahlawulwa zethuba elifutshane (payables).
2. **Isikhokelo semithetho esebenzayo**
  - 2.1 Le ngcaciso imfutshane ikhutshwa ngokoMthetho woLawulo lweMali kaRhulumente, (uMthetho 1 ka-1999), (Public Finance Management Act) (PFMA), 1999 (Act 1 of 1999)), yaye mayifundwe kunye:
  - 2.2 neMimiselo 8.1 no-8.2 ye-National Treasury Regulations (NTR), eyakhutshwa ngowe-15 Matshi 2005, ngokwecandelo 76 le-PFMA; kwakunye
  - 2.3 neSetyhula ye-Ofisi kaNondyabo wePhondo 0035/2014, yowe-27 Agasti 2014, ngokumalunga nokunika ingxelo ngeentlawulo ezidlulelwe lixesha (late payments) ii-invoyisi ezingahlawulwanga nokunika ingxelo ngeemali eziyingqokelela yenzala nezotyalo-mali (accruals) neemali ezingekahlawulwa zethuba elifutshane (payables).
3. **Ingcaciso enika imvelaphi**
  - 3.1 INGcaciso eMfutshane yeCandelo loLawulo lweMicimbi yezeMali 0004/2012, yowe-06 Septemba 2012, iyatshitshiswa ukwenjenje yaye itshintshwa ngokupheleleyo ngenxa yeemfuno ezimiselweyo ezintsha zokunika ingxelo ngemicimbi yezemali.

3.2 Isetyhula ye-Ofisi kaNondyabo wePhondo 0036/2010, yowe-23 Septemba 2010, ifuna amasebe anike ingxelo **qho ngekota** ngeemali zeenjongo ezithile ezimiselwe ukuhlawulwa kwixa elizayo (*commitments*) neemali eziyingqokelela yenzala nezotyalo-mali (*accruals*).

#### 4. **IsiHlomelo**

4.1 **IsiHlomelo A:** Irejista yeemali eziyingqokelela yenzala nezotyalo-mali (*accruals*) inika isikhokelo ngeentlawulo, ukuzaliswa kweefom ii-*input forms* kunye namaxwebhu ahamba naso.

5. **Amagosa ekudluliselwe kuwo amagunya anoxanduva lokuqinisekisa ukuba abagunyazisi be-BAS bayazithobela iimfuno ezimiselweyo ezichazwe kule ngcaciso imfutshane.**

#### 6. **Ukunika iingxelo ngeemali eziyingqokelela yenzala nezotyalo-mali (*accruals*)**

6.1 **Iimali eziyingqokelela yenzala nezotyalo-mali (*accruals*)** zimele iimpahla okanye iinkonzo ezifunyenweyo okanye ezithengiweyo kodwa ezingekahlawulwa nezingakabi nazo ii-invoyisi okanye ekuvunyelenwe ngazo ngokuqingqiweyo nomthengi, kuqukwa izixa ezimele ukuhlawulwa kubaqeshwa.

6.2 **Iimali ezingekahlawulwa zethuba elifutshane (*payables*)** zimele iimpahla okanye iinkonzo ezifunyenweyo okanye ezithengiweyo nesele zinazo ii-invoyisi okanye ekuvunyelenwe ngazo nomthengi ngokuqingqiweyo.

6.3 Ii-ofisi ezijongene nee-invoyisi kunye/okanye neentlawulo mazigcine iirejista zeemali eziyingqokelela yenzala nezotyalo-mali (*accruals*) neze-*payables* ezizimali ezingekahlawulwa zethuba elifutshane (makufundwe **isiHlomelo A**) ukwenzela iinjongo zokunika iingxelo.

6.4 Makwenziwe iingxelo ngeemali eziyingqokelela yenzala nezotyalo-mali (*accruals*) qho ngekota ngokungeniswa kwikhompyutha kwerejista yeemali eziyingqokelela yenzala nezotyalo (*accruals*) ezaliswe ngokupheleleyo nehlaziyiweyo (*a fully completed and up-to-date standardised accruals register*)) kwi-*Batch Control Unit* **kwiintsuku zekhalenda ezintlanu qho emva kokuphela kwikota nganye.** Kwimeko yee-zero *accruals*, makungeniswe i-*nil return* ukwenzela iinjongo zezolawulo.

6.5 Ingcaciso ngeemali eziyingqokelela yenzala nezotyalo-mali (*accruals*) isetyenziswa licandelo le-*DFA* ukwenzela iingxelo ezishwankathelwayo zaqho ngekota ukwenzela

ukuzingenisa kwi-Ofisi kaNondyabo wePhondo yaye iyabandakanywa kwingcaciso ehamba kunye neengcaciso zeengxelo-mali (*disclosure notes*).

7. Kubaluleke gqitha ukuba okukule ngcaciso imfutshane kwaziswa onke amagosa ajongene nokulungiswa, ukusingathwa nokugunyaziswa kweentlawulo zeejenali kwiisistim zezemali. Iyathakazelelwa intsebenziswano yakho ngokumalunga noku.
