Le ngcaciso imfutshane mayifundwe neNgcaciso eMfutshane yoLawulo lweMicimbi yezeMali (*Financial Accounting Minute*) 0003/2020 engeenkqubo zokuvalwa kwe Basic Accounting System (BAS) ukwenzela unyaka-mali ka-2019/20.

2. Ngokwesiqendu (40)(1)(c) soMthetho woLawulo lweMali kaRhulumente, uMthetho 1 ka-1999, (*Public Finance Management Act*) (*PFMA*), 1999, (*Act 1 of 1999*)), njengoko ufakelwe izilungiso nguMthetho 29 ka-1999, iGosa eliMele ukuPhendula ngoSetyenziso lweMali (*Accounting Officer*) kufuneka lilungise iingxelo-mali zonyaka-mali ngamnye lize lizingenisele ukuba ziphicothwe, zingadlulanga iinyanga ezimbini zokuphela konyaka-mali, kuMphicothi-zincwadi Jikelele (*Auditor-General*) (*AG*) nakuNondyebo wePhondo (*Provincial Treasury*), oya kulungisa iingxelo-mali ezidityanisiweyo (*consolidated financial statements*). Oku kuthetha ukuba iingxelo-mali zeSebe iWCED ezigqityiweyo zaza zasayinwa mazingeniswe ungadlulanga owe-31 Meyi 2020, Ngenxa yethuba lemiqathango yokuma ngxi kwezinto yeCovid-19, wandisiwe lo mhla ukuya kwi-31 Julayi 2020. Nakuba kunjalo, iseti epheleleyo yeengxelo-mali zethutyana mayingeniswe kuNondyebo wePhondo (*Provincial Treasury* (*PT*)) ungadlulanga owe-17 Julayi 2020.
3. Ukuvalwa kukanyaka-mali weSebe iWCED, kwenziwe ngowe-15 Meyi 2020. Ukwenzela ukuba iCandelo leMicimbi yezeMali lizithobele iimfuno ezingummiselo zePFMA, kubaluleke gqitha ukuba abantu abakolu luhlu luqhotyoshelwe apha, bangenise amagalelo abo kweli candelo **ungadlulanga owe-05 Juni 2020, ukuba akaxhomekekanga ekuvalweni konyaka-mali yaye ungadlulanga nowe-23 Juni 2020 ukuba axhomekeke ekuvalweni konyaka-mali**. Kucelwa niyiqaphela imfuno emiselweyo kaNondyebo yokuba onke amagalelo namaxwebhu axhasayo, makangeniswe eziikopi ezingamaphepha (*hard copies*) nangokuthunyelwa ngekhompyutha (*electronic format*). Kuseyimfuno engummiselo nokuba onke amagalelo, makangqinisiswe njengachanekileyo (*certified as correct*) aze asayinelwe ngumlawuli okanye yisuphavayiza echaphazelekayo. Onke amagalelo makahanjiswe kunye namaxwebhu axhasayo apho kufanelekileyo. Kukwacetyiswa nokuba iphepha elineesignitsha zabantu abenza lo msebenzi maliskenwe yaye lingeniswe ngekhompyutha kunye namanye amaxwebhu, likwifomathi engu-Excel okanye engu-Word format.
4. Ukwenza kube lula oku, iinguqulelo ezisekhompyutheni zeekopi ezizi-extracts zeethemplethi emazisetyenziselwe ukuqulunqa iingxelo-mali kwicandelo ngalinye, ziya kuthunyelwa nge-imeyili kubantu abakuluhlu oluqhotyoshelweyo apha.
