1. Oku kumalunga nomhlathi 3.1 weSetyhula 0035/2019 neSetyhula 0036/2019, zomhla we-26 Septemba 2019.
2. ISebe leMfundo leNtshona Koloni (WCED) linike inkxaso zonke izikolo ukuthenga iimpahla zokuzikhusela (*personal protective equipment (PPE)*) emva kwethuba lokuqala lemiqathango yokumiswa ngxi kweentshukumo. ISebe iWCED liya kuqhubeka ngokubonelela ngee-PPE ezongezelelweyo ezikolweni, ngokuxhomekeke ekufumanekeni kwezimali.
3. Nakuba kunjalo, izikolo zimele ukuzongeza iimfuno zazo ze-PPE, apho kusebenzayo oku, ngokusebenzisa izabelo-mali zemimiselo nemigangatho yolwabiwo-mali (*norms and standards (N&S)*) zazo phantsi kwe-ayithem engu-**local purchases**, **ezizinto ezithengwa kulo ndawo sikuyo isikolo**. Izinto ezithengwa kulo ndawo isikolo sikuyo ziya kwandiswa ukwenzela ukuba ziquke ii-PPE ukwenzela i-COVID-19.
4. Kucetyiswa izikolo ukuba ziziqwalasele ngokuphangeleleyo iibhajethi zazo yaye emva koko ziziphathe ngendlela izabelo-mali ze-N&S ukuqinisekisa ukufumaneka kwezimali ezaneleyo ukulungiselela iimfuno zazo ze-N&S.
