ISihloko: Uqeqesho nokuphunyezwa kweNkqubo yoLawulo loMgangatho (Quality Management System (QMS) ukwenzela ootitshala abasezikolweni

1. Isigqibo ngeNkqubo yoLawulo loMgangatho (*Quality Management System (QMS)*) ukulungiselela ootitshala abasezikolweni, kwagqitywa ngayo ngo-2019 njengeSigqibo soThetha-thethwano neMibutho yeBasebenzi (*Collective Agreement*) Number 2 sika-2014 kwiBhunga lezeMfundo lezoBudlelwane eMsebenzini (*Education Labour Relations Council (ELRC)*).
2. Injongo yesigqibo phakathi kwezinye izinto, kukomeleza ukusebenza ngobuchule nangempumelelo kootitshala kwanokuba noxanduva lokuphendula ngokuqhubekayo kumsebenzi wokufundisa.
3. I-QMS yenziwe yalungela iimeko zokusebenza yaye iyitshintshile iNkqubo yoLawulo loMgangatho eHlangeneyo (*Integrated Quality Management System (IQMS)*). I-QMS yaqulunqwa kwi-ELRC ngokubambisana kweSebe leMfundo esiSiseko (*Department of Basic Education (DBE)*) neemibutho yeemanyano zootitshala ukulinganisela intsebenzo yootitshala ngokungqinelana neendima zabo nemisebenzi yabo abayenzayo.
4. IsiHlomelo kwisigqibo sothetha-thethwano nemibutho yabasebenzi (*collective agreement*), esisayinwe nge-10 Septemba 2019, sicacisa ukuba:
 - 4.1 Uqeqesho nokuxhotyiswa ngezakhono kwabo bonke abasebenzisi be-QMS luya kuqhutywa ukususela ku-Januwari 2020 ukuya kuDisemba 2020; yaye
 - 4.2 noKuphunyezwa ngokupheleleyo kwe-QMS, kuya kuqala ngoJanuary 2020.
5. Kunyaka ka-2020, kucelwa zonke izikolo ziqhubeke nokuphumeza i-IQMS yangoku njengoko zazazisiwe kwiSigqibo *ELRC Collective Agreement Number 8* sango-2003.

6. ISebe iWCED liya kutyumba amagosa, aziingcaphephe kuqeqesho nakwizakhono zokuququzelela uqeqesho, kwaNdlunkulu nakwinqanaba lesithili kwakunye nabaphathi beesekethe ukuba basebenze njengabaququzeleli be-QMS kwiikomiti zoqeqesho zikazwelonke nezephondo.
7. Ishedyuli yoqeqesho iya kubonelelwa kuzo zonke izikolo ngokugqitha kwii-ofisi zezithili zazo yaye luya kuqhutywa phakathi ko-Apreli noSeptemba 2020.
