1. Injongo yale ngcaciso imfutshane kukwazisa amagosa ngethemplethi i- *business case template* ehlaziyiweyo emayizaliswe ukulungiselela zonke ii-ayithem ezingaphezu kwe-R100 000 nezidweliswe kwisicwangciso i-*Annual Procurement Plan* ngokwe-*demand management system* nesicwangciso sokuthengwa kweempahla neenkonzo.
2. Apha kuqhotyoshelwe uxwebhu oluyithemplethi eyi-*business case template* oluhlaziyiweyo nomaluzaliswe ngabaphathi abajongene nestokhwe (*responsibility managers*) abathi qho ngonyaka baqaphele ii-ayithem emazithengwe ngurhulumente.
3. Uxwebhu i-*business case template* luhlaziyiwe ngokusekelwe kumaxabiso azii-*threshold values* ngokumalunga ne-*National Treasury Supply Chain Management (SCM) Instruction No. 02 of 2021/22*, yomhla we-08 Juni 2021.
4. ISebe leMfundo leNtshona Koloni (WCED) lifuna ukuqaphela iimpahla neenkonzo eziyimfuneko ukufikelela kwiziphumo ezicetywayo kwisiCwangciso i-*Strategic Plan* seSebe iWCED. Lo ngumsebenzi omawenziwe ngumsebenzisi oyi-end user (umphathi weprogram/umphathi ojongene nestokhwe) ngokudibene neprakhtishina eyi-*supply chain practitioner*, ngoncedo lwengcali eyi-*technical strategic sourcing specialist/analyst* njengoko naxa kuyimfuneko. Injongo kukuqinisekisa ukuba kufikelelwe kwixabiso lemali. Iimfuno zangoku nezexesha elizayo mazimiselwe ngokusekelwe kwi-WCED's *Strategic Plan* yaye mazibandakanywe kwi-*Annual Procurement Plan* evunyiweyo.

5. Ezi mfuno zimelwe ukubhalwa phantsi ngabaphathi abajongene nestokhwe zikwimo yoxwebhu oluyi-*business case* xa bengeniswa kwi-*Supply Chain Unit* iirikhwizishini zabo zazo zonke ii-ayithem ezidweliswe kwisiCwangciso i-*Annual Procurement Plan* esivunyiweyo. Uxwebhui-*business case* kufuneka luqulunqwe ngumphathi ojongene nestokhwe yaye, malungeniswe kwiNtloko yeCandelo eliKhulu/kuSekela Mlawuli-Jikelele okanye kwigosa elimele ukuphendula ngokusetyenziswa kwemali ukulungisela ukuvunywa kwalo.
6. Ngokwe-*Accounting Officer's System* evunywe liSebe iWCED, uxwebhu i-*business case* malubandakanye oku kulandelayo:
  - a) *High level statement of needs*
  - b) *Links between the needs and the programme's strategic outcomes*
  - c) *Comprehensive understanding of the market and operating environment*
  - d) *Indication of whole-of-life costs*
  - e) *Costs/benefits/risks analysis.*
7. Uxwebhu i-*business case template* malusetyenziswe kuzo ZONKE iimeko apho kusetyenziswa inkqubo yokukhuphisana ngamaxabiso eqingqiweyo (*limited bidding*) njengendlela yokuthenga iimpahla neenkonziso. Ngaphezu koko iimvumelwano ii-*provincial transversal contracts* mazixhaswe yi-*business case* evunyiweyo yaye mazilandele indlela eyi-*strategic sourcing methodology* emayilawulwe ziimfuno ezimiseliweyo zolawulo lwabathengi nabathengisi (*supply chain management*).

Onke amagosa eSebe iWCED makathobele imiqathango yale ngcaciso imfutshane, iMimiselo neMiyalelo kaNondyabo kaZawelonke (*National Treasury Regulations and Instructions*), iMiyalelo ii-*Western Cape Provincial Treasury Instructions*, ii-*Accounting Officer's System* nee-*SCM Delegations* ngokumalunga neenkqubo zokuthengwa kweempahla neenkonziso zikarhulumente ukunqanda ukungathotyelwa kwemigaqo.
