### Isihloko: ISaveyi ye-SNAP yezikolo zemfundo eneemfundo ezizodwa yango-2021

1. ISaveyi ye-SNAP yeSebe leMfundo leNtshona Koloni (WCED) yezikolo zemfundo eneemfundo ezizodwa iya kuqhutywa ngowe- **02 Matshi 2021**.
2. Inqununu kuya kufuneka ukuba zisayinele ukuchaneka kwedatha yabafundi neyootitshala kwi-CEMIS. Umhla omisiweyo owenzelwe ukusayinelwe kwedatha yeSaveyi ye-SNAP ngaBaphathi beProgram yePhondo, ziiNtloko zoLawulo noKuphathwa kwamaZiko, nangamagosa ezoCwangciso ngowe-**12 Matshi 2021**.
3. Phambi kokuba isayinelwe kwi-CEMIS iSaveyi, inqununu okanye lowo kudluliselwe kuye amagunya, makaqinisekise ukuba oku kulandelayo kubonakala ngokuchanekileyo kwi-CEMIS:
  - a) Bonke abafundi ababhalisileyo nabahamba isikolo ngo-2021 bayavela ngokuchanekileyo kumabakala, kwiiklasi nakudidi lolwimi lokufunda nokufundisa.
  - b) Kuzaliswe ukubhaliswa kwabafundi abatshintshwayo (abangenayo nabaphumayo) esikolweni (*Learner transfers (in and out)*)
  - c) Abafundi abaswelekileyo mababe bakhutshiwe kuluhlu lwababhalisiweyo kwaye "umhla wokusweleka" urekhodwe njengoko ubhaliwe kwisatifikethi sokusweleka (*death certificate*).
  - d) Kuzaliswe ukutshintshwa kwamabakala.
  - e) Kuzaliswe ukutshintshwa kwezifundo.
4. Inqununu okanye lowo kudluliselwe kuye amagunya makaqinisekise ukuba ihlaziyiwe yaye ingqinisiwe ilisti yootitshala kwi-CEMIS, kwakunye neminyaka yamava, amabakala nezifundo ezifundiswa ngo-2021. Makasuswe amabakala nezifundo

ebezifundiswa kwiminyaka engaphambili ukuba azifanelekanga kumsebenzi katitshala wango-2021.

5. Ukuncedisa ukungqinisiswa kwedatha yesikolo yabafundi nootitshala, kukho iqela leengxelo zemposiso (*several error reports*) ezifumanekayo ukucacisa nokuqinisekisa ukuba idatha efakwe kwi-CEMIS yechanekileyo. Kucelwa niqinisekise ukuba zonke iimposiso eziboniswe zezi ngxelo ziyasonjululwa phambi kokuba zisayinelwe iingxelo.
6. Icandelo lokusayinelwa kwesaveyi malizaliswe ukuvuma ukungqinisiswa kwedatha njengebonakalisa ngokuchanekileyo inani lobhaliso labafundi nenani labasebenzi (*staff*) njengokuba enjalo ngowe-**02 Matshi 2021**.
7. Izikolo zezibhedlele kuya kufuneka ukuba zizalise ikopi yesaveyi esephepheni yaye ziyingenise kuMnu Chasfred Ahrends, apha: 18<sup>th</sup> Floor, Golden Acre Building, Cape Town. Amaxwebhu esaveyi aya kubonelelwa ngqo ezikolweni.
8. Njengegosa le-*Education Management Information Systems (EMIS)* leziko, inqununu mayilawule iinkqubo zedatha ukuqinisekisa ukuba ubungqina bokungqinisiswa neesignitsha zabasebenzi ekudluliselwe kubo amagunya okutshekisha idatha zinokunikwa abaphichothi-zincwadi xa kuceliwe oko. Inkqubo yedatha ye-EMIS yesikolo mayirekhodwe ukuqinisekisa uxanduva lokuphendulela ukuchaneka kwedatha, njengokuba ingcaciso inokuphicothwa.
9. Iyafumaneka ingxelo ye-CEMIS ukulungiselela ukuqaphela abafundi abangenazo iinombolo zeeNcwadi zeZazisi (*ID*) nokuququzelela ukufakwa kwikhompyutha kweenombolo zezazisi ezingekhoyo. MAYINGAFAKWA inombolo ye-ID engekho mthethweni ukuba umfundi akanayo inombolo ye-ID esemthethweni. Niyacelwa nibacebise abazali ngenkqubo yokwenza isicelo se-ID kwiSebe leMicimbi yezeKhaya (*Department of Home Affairs*). Ziyacelwa iinqununu zibancedise abazali apho kufanelekileyo ngokuthi ziyiququzelele le nkqubo kwiSebe leMicimbi yezeKhaya.
10. ISebe i-WCED liya kongamela ukuthotyelwa kwale nkqubo nokuqinisekiswa komgangatho wedatha yawo onke amaxwebhu angenisiweyo eSaveyi yaQho ngoNyaka yaye liya kunika ingxelo kwiNtloko yezeMfundo ngazo naziphi na izenzo zokungathotyelwa, ukungangqinelani nokungapheleli kwedatha.
11. Ziyakhunjuzwa izikolo ezizimeleyo zemfundo eneemfuno ezizodwa ukuba mazibe nolwazi ngemiqathango yazo yobhaliso. Makuqatshelwe ukuba ukuzilandela mbo iimfuno ezimiselweyo zedatha zeSebe i-WCED kuyinxalenye yale miqathango yaye ukungathotyelwa kwayo kunokukhokelela ekukhutshweni ezincwadini zobhaliso kwabafundi.
