Isihloko: ISaveyi yeZikolo yaQho ngoNyaka (Annual School Survey (ASS)) ka-2021 yeSebe leMfundo leNtshona Koloni (WCED) kwizikolo zikarhulumente eziqhelekileyo nakumaziko azimeleyo e-Early Childhood Development (ECD))

1. ISaveyi yeZikolo yaQho ngoNyaka i-ASS mayizaliswe kwaye isayinelwe yinqununu kwi-CEMIS nge-**02 Matshi 2021** (ngoLwesibini wokuqala kuMatshi). Inqununu kuya kufuneka ukuba zisayinele idatha yabafundi nabasebenzi (*staff*) echanekileyo kwi-CEMIS. Umhla omisiweyo wokusayinelwa kwedatha ye-ASS ngabaphathi be-ECD ngowe-**08 Matshi 2021**.
2. Phambi kokuba isayinelwe kwi-CEMIS iSaveyi, inqununu mayiqinisekise oku kulandelayo:
 - a) Bonke abafundi ababhalisileyo nabahamba isikolo kwiziko ngo-2021 bayavela kwi-CEMIS ngokuchanekileyo kumabakala, kwiiklasi nakudidi lolwimi lokufunda nokufundisa.
 - b) Ulwimi lwenkobe lomfundi malube lutshekishiwe kwaye luhlaziyiwe.
 - c) Utshintsho lwabafundi (abangenayo nabaphumayo esikolweni (*Learner transfers in and out*)) malube lugqityiwe.
 - d) Abafundi abaswelekileyo mababe bakhutshiwe ezincwadini zobhaliso lwabafundi kwaye "umhla wokusweleka" urekhodwe njengoko ubhaliwe kwisatifikethi sokusweleka (*death certificate*).
 - e) Ilisti yootitshala/yeepraktishina kwi-CEMIS ihlaziyiwe yaye ingqinisisiwe. Mayibe ihlaziyiwe iminyaka yamava, amabakala kwakunye nezifundo ezifundiswa ngo-2021. Makasuswe amabakala nezifundo ebezifundiswa kwiminyaka engaphambili, ukuba azifanelekanga kumsebenzi katitshala wango-2021.
 - f) Mazingqinisiswe zonke izikrini zokubonisa nokufaka idatha neengxelo zeemposiso phambi kokuba kufumaneke icandelo lokusayinelwa kwesaveyi.

- g) Iinqununu maziqinisekise ngaphezu koko ukuba amanani abafundi afakwe kwi-ASS ngachanekileyo njengokuba amanani angachanekanga amele abafundi aya kuthathwa njengomsebenzi wobuqhinga.
- Ukuncedisa ukungqinisiswa kwedatha yesikolo yabafundi nootitshala, kukho iqela leengxelo zemposiso (a number of error reports) ezifumanekayo eziya kunika isikhokelo sokuchaneka kwedatha ekhoyo efakwe kwi-CEMIS.
 - Lyafumaneka ingxelo ye-CEMIS ukulungiselela ukuqaphela abafundi abangenazo iinombolo zesazisi (ID) nokuququzelela ukufakwa kwikhompyutha kweenombolo zesazisi (ID) ezingekhoyo. Ukuba umfundi akanayo inombolo yesazisi (ID) esemthethweni. MAYINGAFAKWA inombolo yesazisi (ID) engekho mthethweni. Niyacelwa nibacebise abazali ngenkqubo yokwenza isicelo sesazisi (ID) kwiSebe leMicimbi yezeKhaya (Department of Home Affairs) (DHA). Ziyacelwa iinqununu zibancedise abazali apho kufanelekileyo ngokuthi ziyiququzelele le nkqubo kwiSebe i-DHA.
