Isihloko: Ukusetyenziswa kwesistim yokulandelela ukuhamba kweefayili i-jTRACK system

1. Intshayelelo

- 1.1 Isistim yokulandelelwa kweefayili i-jTRACK system yaqaliswa kwiSebe leMfundo leNtshona Koloni (WCED) ngoMatshi 2007 yaye ithathe indawo yesistim yokulandelelwa kweefayili ngekhompyutha yangaphambili ekubhekiselelwe kuyo kwiNgcaciso eMfutshane DLS/0014/2007, yomhla we-15 Agasti 2007.
- 1.2 Isistim i-jTRACK system yirejista yeefayili ekwikhompyutha eyenzelwe iifayili eziphathekayo ezenziweyo nezisetyenziswa kuzo zonke iirejistri zeSebe iWCED. Le sistim ibonelela ngeseti yezixhobo ekulula ukuzisebenzisa zokubeka esweni nokunika ingxelo, eyenza babenako abasebenzisi beSebe iWCED ukulandelela zombini iindlela zokuhanjiswa kweefayili ngezandla kwakunye nokufumana iindawo ezikuyo iifayili kusetyenziswa isistim echaziweyo yabasebenzisi.
- 1.3 Isistim i-jTRACK system icwangciswe (configured) ngeepharamitha ezizodwa kwiindawo ezahlukeneyo zerejistri kwaye itranzekhsini nganye ifakwe isitampu esinexesha. Le sistim iphethe ingcaciso ebhekiselele kumqali wesicelo (originator) nendawo efumaneka kuyo ifayili ephathekayo nanjengoko isistim i-jTRACK system isisixhobo solawulo esinoku-odithwa (auditable management tool) esikwiSebe iWCED.
- 1.4 Isistim i-jTRACK system yenza ukuba amagosa abenako ukufumanisa ngokukhawuleza ukuba indawoni ifayili kwaye inika inkcazo ngokulandelelwa kweefayili okuyimpumelelo ekulawuleni indlela ezenziwa ngayo nezilawulwa ngayo iirekhodi zeSebe iWCED. Oku kuqinisekisa ukuba iirekhodi ezithembekileyo zigcinwe kakuhle emva kwexesha elithile njengobungqina bokwenziwa komsebenzi

waseburhulumenteni ukulungiselela injongo yokuba noxanduva lokuphendula (*accountability*) ngokuqhubekayo, ukuqhubeka kokwenziwa komsebenzi (*operational continuity*), imigaqo-nkqubo nezixhobo zokufumaneka kweziseko zethekhinoloji (*disaster recovery*) nedatha eyindibanisela yeqela labantu (*institutional memory*).

1.5 Onke amagosa asebenza kwaNdlukulu kwiSebe iWCED **mawasebenzise isistim i-jTRACK system** xa esenza isicelo seefayili, ezamkela naxa ezithumela iifayili kwiirejistri ezahlukeneyo kwakunye naxa ezithumela iifayili kwabanye abasebenzi abasebenza nabo nakwamanye amagosa ukwenzela ukuba iSebe iWCED libenako ukwenza ingcaciso eyimbali yokuhanjiswa kwazo zonke iifayili zaseburhulumenteni.
