**Isihloko: Isicelo sokubuyisela iifayili ezineebhakhowudi zaseburhulumenteni/iirekhodi nembalelwano eya kumacandelo olawulo lweerekhodi ahlukeneyo kwizakhiwo i-Grand Central ne-Golden Acre Buildings**

1. Injongo yale ngcaciso imfutshane kukuchaza ngenkqubo yokubuyiselwa kweerekhodi ezineebhakhowudi nembalelwano eya kumacandelo olawulo lweerekhodi ahlukeneyo afumaneka kwizakhiwo i-Grand Central kunye ne-Golden Acre Buildings phambi kokufuduka kukaNdlunkulu weSebe leMfundo leNtshona Koloni (iSebe iWCED) ukuya e-2 Lower Loop Street, okusele kuqale ngowe- 07 Apreli 2021.
2. Ukuncedisa uMphicothi-zincwadi Jikelele ekunikeni ingcaciso, nokunceda ekukhuculeni nokucoca ngokupheleleyo konke kwi-ofisi yeyunithi yakho, njengoko nifudukela kuNdlunkulu weSebe iWCED omtsha, iCandelwana loLawulo lweeRekhodi licela uncedo lomqeshwa ngamnye ekuqinisekiseni ukuba zonke iifayili ezineebhakhowudi zamacandelo olawulo lweerekhodi zibuyiselwa kumacandelo olawulo lweerekhodi ahlukeneyo phambi kokuba nifudukele kwesi sakhwiwo sitsha.
3. Ngokuphathelele koku, kucelwa kuqinisekiswa ukuba zonke iifayili ezineebhakhowudi zaseburhulumenteni zibuyiselwa kumacandelo olawulo lweerekhodi ahlukeneyo. Niyacelwa nizibuyisele iifayili kumacandelo eerekhodi ukwenzela ukugcinwa kwazo ngokunqatyisiweyo. .

4. ICandelwana loLawulo lweeRekhodi, lilungiselela ukubonelelwa qho ngonyaka kwezicelo zengcaciso njengoko ziceliweyo nguMphicothi-zincwadi Jikelele kwanokuqinisekisa ukuba iifayili ezicelwe ngabaphicothi-zincwadi ziyafumaneka ngenene yaye zidluliselwa kubo engadlulanga amaxesha amiselweyo aqingqiweyo njengoko kuchaziweyo ngabaphicothi-zincwadi. Uncedo nentsebenziswano yabo bonke abaqeshwa iya kuthakazelelwa kakhulu ukuqinisekisa ukuba ukufumaneka kwengcaciso ngoko nangoko ukulungiselela ithuba lexesha lophicotho-zincwadi yaye kuthunyelwa imbalelwano kumacandelo olawulo lweerekhodi ukulungiselela ukufayilishwa nokugcinwa kweefayili.
5. Ngokukhokelwa ngumthetho i-*National Environmental Management Waste Act, 2008* (uMthetho 59 ka-2008) nomthetho i-*Provincial Archives and Record Services of the Western Cape Act, 2005* (uMthetho 3 ka-2005), iphepha elise-ofisini lahlulwe
  - Laliphepha elingenamsebenzi eliyingasafunekiyo kunye
  - Nephepha elingenamsebenzi eliyingasafunekiyo elinengcaciso eyimfihlelo.
6. Njengoko abasebenzi befudukela kwisakhiwo esitsha kucelwa ukuba imbalelwano isotwe ibe ziindidi ezintathu:

**a) Amaphepha angenamsebenzi angasafunekiyo:**

La maxwebhu okanye ezi ntlobo zamaphepha azinaxabiso lokufakwa kwii-akhayivu okanye lokulondolozwa; la ngamaphepha angengowaseburhulumenteni (enziwe zijungqe okanye angenziwanga zijunge) yaye anokusetyenziselwa injongo yokuwasebenzisa ngokutsha (*recycling*). Akukho satifikethi sakuwatshabalalisa sifunekayo ukususa amaphepha angenamsebenzi/angasafunekiyo ngokubanzi.

**b) lirekhodi zaseburhulumenteni ezinxulunyaniswe nesicwangciso seefayili esivunyiweyo (esivunywe nge-01 Oktobha 2016):**

Isicwangciso seefayili seSebe iWCED savunywa nge-01 Oktobha 2016 yaye siqulethe ukuhlelwa ngamaqela (*classification*) ukulungiselela izalathiso zoluhlu 01-15, oluqhotyoshelwe njengesihlomelo A. Ngenxa yokuba amaxwebhu ebubungqina beerekhodi, kubaluleke gqitha ukuba ezi rekhodi zilondolozwe. lirekhodi ziya kugcinwa kangangoko ukuba zifuneka ukwanelisa iimfuno zomsebenzi, ezomthetho, ezolawulo, ezophando okanye iimfuno ezingummiselo zembali. Imbalelwano yaseburhulumenteni mayabelwe inombolo yefayili. Imbalelwano yaseburhulumenteni kufuneka ibekwe ngokweebhetshi, isotwe yaye mayiqulathe umyalelo omnye kuphela oya kumacandelo olawulo lweerekhodi ahlukeneyo wokuba "Uyacelwa uyifayilise imbalelwano". Kufuneka ikhatshwe yisignitsha nomhla ukusuka kulowo wenzelwa inkonzo (*client*) omakafezekise umyalelo. Kufuneka emva koko isiwe kumacandelo olawulo lweerekhodi ahlukeneyo ukuze ifayilishwe.

**c) Amaphepha angenamsebenzi angasafunekiyo engcaciso eyimfihlelo**

Ngokuphathelele kwimbalelwano yaseburhulumenteni neerekhodi ezingasafunwayo yi-ofisi, i-ofisi kufuneka inike umhla wokutshatyalaliswa kwazo nethuba lokugcinwa kwazo, njengababhali beerekhodi. Isicelo "Request for the disposal of records", ekubhekiswa kuso kwisiHlomelo A masizaliswe ngowenzelwa iinkonzo. ICandlwana loLawulo lweeRekhodi liya kuqhubeka ukuququzelela le nkqubo ukuqinisekisa ukwenziwa kwesicelo sokutshatyalaliswa kweerekhodi sivunyiwe yi-Western Cape Archives and Record Services (WCARS). Kwakuba kufunyenwe imvume egunyazisa ukutshatyalaliswa kweerekhodi esuka kwicandelo le-Western Cape Archives and Record Services, umboneleli-nkonzo otyunjwe lisebe uya kuqalisa ngenkqubo yokutshatyalaliswa kweerekhodi.
