- 4.5 Abenzi-sicelo abenza isicelo sokumakisha i-History Paper 1 no-2 mababe bawafundise onke amacandelo ekharityhulam yeHistory.
- 4.6 Abantu abaqeshelwe ukumakisha, phantsi kwazo naziphi na iimeko baya kukhululwa ngemihla yokumakisha. Bonke abamakishi kuya kufuneka ukuba bafumaneke kude kuphele ixesha lokumakisha xa **zonke** iincwadi zeempendulo **zimakishiwe zaze zatshekishwa.**


