Isihloko: ISaveyi yaQho ngoNyaka yeSebe iWCED ka-2022 yamaziko karhulumente namaziko azimeleyo e-Early Childhood Development (ECD))

1. ISaveyi yaQho ngoNyaka iya kuzaliswa yaye isayinelwe yinqununu kwi-CEMIS ngowe-**01 Matshi 2022** (ULwesibini wokuQala kuMatshi). Ziya kucelwa iinqununu ukuba zikusayinele ukuchaneka kwedatha yabafundi nedatha yootitshala kwi-CEMIS. Umhla omisiweyo kubaphathi be-ECD wokusayinelwa kwedatha yeSaveyi yaQho ngoNyaka ngowe-**11 Matshi 2022**.
2. Phambi kokuba isayinelwe kwi-CEMIS iSaveyi, inqununu kufuneka iqinisekise oku kulandelayo:
 - a) Bonke abafundi ababhalisiweyo nabahamba isikolo kwiziko le-ECD ngo-2022 bayavela kumabakala, kwiiklasi nakudidi lolwimi lokufunda nokufundisa (LoLT) oluchanekileyo kwi-CEMIS .
 - b) Zitshekishiwe yaye zihlaziyiwe iilwimi zeenkobe zabafundi.
 - c) Izalisiwe idatha yokubhaliswa kwabafundi abangenayo nabakhutshiweyo esikolweni (*Learner transfers (in and out)*).
 - d) Abafundi abaswelekileyo bakhutshiwe kuluhlu lwababhalisiweyo yaye "umhla wokusweleka" urekhodwe njengoko ubhaliwe kwisatifikethi sokusweleka (*death certificate*).
 - e) Zihlaziyiwe yaye zangqinisiswa iilisti zootitshala/zeepraktishina ezikwi-CEMIS. Iminyaka yamava, amabakala nezifundo ezifundiswayo ngo-2022 nayo ihlaziyiwe. Makasuswe amabakala nezifundo ebezifundiswa kwiminyaka engaphambili ukuba azifanelekanga kumsebenzi katitshala wango-2022.

- f) Mazingqinisiswe zonke izikrini ii-displays nee-capture screens kwakuny neengxelo ii-error reports phambi kokuba kufumanekile icandelo lokusayinelwa kwesaveyi.
- g) Iinqununu maziqinisekise ukuba amanani abafundi afakiweyo achanekile, njengoko ukungafakwa ngokuchanekileyo kwedatha yamanani abafundi kunokuthathelwa ingqalelo njengesenzo sobuqhophololo.
3. Ukuncedisa ukungqinisisa kwedatha yabafundi nootitshala be-ECD, kukho iqela leengxelo zeemposiso (*error reports*) ezifumanekayo kwi-CEMIS eziya kukhokela iinqununu ngokuchaneka kwedatha ekhoyo efakiweyo.
4. Kunyanzelekile kusetyenziswe inombolo yesazi kazwelonke (*national identity (ID) number*) kubo bonke abafundi abakwiisitim zolawulo nokuphathwa kwezikolo ezikwikhompyutha (*computerised school administration and management systems*). Iyafumaneka ingxelo ye-CEMIS ukulungiselela ukuqaphela abafundi abangenazo iinombolo zesazisi (*ID numbers*) nokuququzelela ukufakwa kwikhompyutha kweenombolo ze-ID ezingekhoyo. Ukuba umfundi akanayo inombolo yesazisi esemthethweni, MAYINGAFAKWA inombolo yesazisi engekho mthethweni. Niyacelwa nibacebise abazali ngenkqubo yokwenza isicelo sesazisi kwiSebe lweMicimbi yezeKhaya (*Department of Home Affairs (DHA)*). Ziyacelwa iinqununu zibancedise abazali apho kufanelekileyo ngokuthi ziyiququzelele le nkqubo kwiSebe leMicimbi yezeKhaya.
5. Apho kuye kwakho naziphi na iingxaki ekuzalisweni kwale saveyi, niyacelwa niqhagamshelane nomphathi we-ECD ochaphazelekayo okanye nomphathi weprogram yenkxaso (*SPA*) odweliswe apha ngezantsi:
