Isihloko: Ukuqeshwa kwabagadi babaviwa ukwenzela iimviwo zeSatifikethi seMatriki sikaZwelonke (NSC) nezeSatifikethi seMatriki (SC) zangoJuni 2023.

1. Ngokwemimiselo ii-Regulations Pertaining to the Conduct, Administration and Management of National Senior Certificate examination, eyapapashwa kwiGazethi kaRhulumente No. 37651 ye-16 Meyi 2014, njengoko ifakelwe izilungiso ngowe-30 Apreli 2019, **amasebe emfundo amaphondo makatyumbe inqununu yesikolo njengomgadi wabaviwa oyintloko weemviwo zeNSC.**
2. Iinqununu nabaphathi bamaziko emfundo yabadala banokuwudlulisela lo msebenzi, ngencwadi ebhaliweyo, kwilungu leKomiti yoLawulo yeSikolo (School Management Team) (SMT)) eliqeshwe liSebe leMfundo leNtshona Koloni (WCED). Nakuba kunjalo, inqununu/umphathi weziko uya kulwamkela ngokupheleleyo ekugqibeleni uxanduva nokuphendula ngokubhalwa kwazo zonke iimviwo kwisikolo/kwiziko akulo.
3. Umgadi wabaviwa oneqhuzu uya kusebenza njengomgadi wabaviwa oyintloko kwiimviwo zeNSC nezeSC eziya kubhalwa ngoMeyi/Juni i 2023.
4. Kucelwa iinqununu/abaphathi bamaziko emfundo yabadala bafune abantu basekuhlaleni abafanelekileyo (ngokweekhrayitheriya ezikumhlathi 8) abaya kusebenza njengabagadi babaviwa abaneqhuzu kunye nabagadi babaviwa kwezi mviwo zikhankanywe ngentla.

5. Abantu basekuhlaleni **abanakuqeshwa** njengabagadi babaviwa yaye, ukuba baqeshiwe abayi kuhlululwa, ukuba :
 - baqeshwe liSebe iWCED ngokusisigxina okanye bakwisithuba semvumelwano.

 - bathatha ipakheji i-voluntary severance package
 - bathatha umhlalaphantsi ngenxa yokungaphili; okanye
 - baneminyaka engaphezu kweyi-65 okanye baya kuba neminyaka/baneminyaka eyi-65 ngexesha leemviwo
 - akanayo imatriki enyanisekileyo/eqinisekisiweyo.
6. Inqununu/umphathi weziko uviwo okanye lowo kudluliselwe kuye amagunya makaqinisekise ukuba kuzaliswa zonke ezi zihlomelo zilandelayo ziqhotyoshelwe kule ngcaciso imfutshane yaye makungeniswe amaxwebhu ayintsusa ungalulanga umhla omisiweyo.

 - 7.1 Inqununu/umphathi weziko okanye lowo kudluliselwe kuye amagunya makaqinisekise ukuba bonke abagadi babaviwa batshekishiwe ukuqinisekisa ukufaneleka kwabo, yaye batyunjwe ngokoMmiselo Regulation 57(1)(c) of the Public Service Regulations, 2016 epapashwe kwiGazethi kaRhulumente No. 40167 ye-29 Julayi 2016.
 - 7.2 IsiHlomelo F (MIE Personal Credential Disclosure Form) masizaliswe ngabo bonke abagadi babaviwa abaqeshiweyo ukulungiselela:

7.3 Makuqatshelwe ukuba isiHlomelo F sibalulekile yaye masizaliswe ngokupheleleyo nangokunyanisekileyo.

8. Iikhrayitheriya zokuqeshwa kwabagadi babaviwa

8.1 Umntu unokuqwalaselelwa ukuqeshwa kuphela njengomgadi wabaviwa oyintloko, umgadi wabaviwa oneqhuzu okanye umgadi wabaviwa xa ngaba:

- a) uneminyaka eyi-23 ubuncinane kodwa angabikho ngaphezulu kweminyaka eyi-65 ;
- b) akanaye umntwana wakhe/umntwana amgcinayo obhala iimviwo
- c) akasiso isizalwane somviwa obhala iimviwo okanye;
- d) akanguye umyeni okanye inkosikazi yesizalwane somgadi wabaviwa oyintloko;
- e) ungummi waseMzantsi Afrika; yaye
- f) unebanga lemfundo leNSC/SC ubuncinane.

8.2 Ukongeza kumgadi wabaviwa oyintloko, **makuqeshwe umgadi wabaviwa abe mnye kwi-30 nganye yabaviwa. Onke amagumbi makasetyenziswe ngokomthamo wawo opheleleyo phambi kokuba kusetyenziswe elinye igumbi elongezelelweyo.**

8.3 Kwiiseshoni apho kukho kuphela inani elincinane labaviwa (ababini ilelona nani lisezantsi), ziya kwanela iinkonzo zomgadi wabaviwa omnye. Kwiimeko ezilolu hlobo, umgadi wabaviwa oneqhuzu okanye oyintloko akasayi kwenza misebenzi yesiqhelo yokugada abaviwa, kodwa uthwele uxanduva lokulawula yonke imisebenzi yezolawulo yeseshoni yoviwo nokuphumza umgadi wabaviwa amakakhaphe umviwa ukuya kwigumbi langasese.

8.4 Umgadi wabaviwa oyintloko makaqinisekise ukuchaneka kwesini somgadi wabaviwa kuyo nayiphi na iseshoni echaphazelekayo. Ukuba bonke abaviwa ngamadoda, kucetyiswa ukuba umgadi wabaviwa oyintloko, umgadi wabaviwa oneqhuzu nabagadi babaviwa mababe ngamadoda ngokunjalo. Ukuba bonke abaviwa ngamabhinqa, kucetyiswa ukuba umgadi wabaviwa oyintloko, umgadi wabaviwa oneqhuzu nabagadi babaviwa mababe ngamabhinqa. Ukuba kukho abaviwa abangamadoda nabangamabhinqa yaye umgadi wabaviwa oyintloko ngumntu oyindoda, ubuncinane omnye wabagadi babaviwa makabe libhinqa, okanye, ukuba umgadi wabaviwa oyintloko libhinqa, ubuncinane omnye wabagadi babaviwa makabe yindoda.

8.5 Xa kufuneka iinkonzo zabagadi babaviwa abongezelelweyo ukulawula amagumbi okubhalela iimviwo (ngeseshoni nganye) amabini okanye ngaphezulu ngaxeshanye, umgadi wabaviwa oyintloko akasayi kwenza misebenzi yesiqhelo yokugada abaviwa, koko kuya kufuneka ukuba enze imisebenzi yomgadi wabaviwa oyintloko kuwo onke amagumbi ekubhalelwa kuwo.

9. Ukutyunjwa kwabagadi babaviwa

9.1 Iimviwo zeNSC nezeSC zangoJuni 2023

9.1.1 Ukulungiselela iiseshoni zoviwo lwe-NSC neze-SC, inqununu/umphathi weziko makaqinisekise ukuba yi-100% engabantu basekuhlaleni.

9.1.2 Inqununu/umphathi weziko okanye lowo kudluliselwe kuye amagunya uya kutyunjwa njengegosa lezoviwo eliyintloko (*chief examination officer*) yaye uya kuphendula ngokumalunga nokulawulwa nokusingathwa kweemviwo ze-NSC neze-SC zangoJuni 2023. Umgadi wabaviwa oneqhuzu (umntu wasekuhlaleni) makalancedise igosa leemviwo eliyintloko ekuqhutyweni kweemviwo ze-NSC neze-SC zangoJuni 2023. Umgadi wabaviwa oneqhuzu uya kuqeshwa njengomgadi wabaviwa oyintloko.

9.1.3 Inqununu/umphathi weziko, uya kutyumba ngencwadi ebhaliweyo, abantu abangamalungu asekuhlaleni abaya kuba besebenza njengomgadi wabaviwa oyintloko nanjengabagadi babaviwa kwiimviwo ze-NSC neze-SC zangoJuni 2023.

9.1.4 Inqununu/umphathi weziko uviwo makaqhube udliwano-ndlebe kunye nomntu otyunjwe njengomgadi wabaviwa oneqhuzu ukuvavanya ubuchule bokufunda, ukubhala nokuva nokubanako ukubona komntu otyunjiweyo, kwakunye nemeko yempilo yakhe ngokubanzi. Abantu abatyunjiweyo mababenako ukuyiqonda ngokucacileyo yaye bayiphumeze imiyalelo yoviwo.

9.1.5 Inqununu/umphathi weziko makasayine ileta yokwamkela ukuqeshwa, emva kokuba inqununu/umphathi weziko uviwo enelisekile kukuba umgadi wabaviwa oneqhuzu ngumntu onako ukwenza imisebenzi efunekayo, makasayine ileta yokuqeshwa ukulungiselela umgadi wabaviwa oneqhuzu.

9.1.6 Umgadi wabaviwa oyintloko (Inqununu/umphathi weziko/iomntu olilungu le-SMT) nomgadi wabaviwa oneqhuzu makaxelelwe ukuba kumele beze kwiseshoni yoqeqesho lwabagadi babaviwa eqhutywa liSebe iWCED.

9.1.7 Uluhlu lwabo bonke abantu abangamalungu asekuhlaleni abaqeshwe njengabagadi baviwa kwezi mviwo malungeniswe kwi-ofisi yesithili ungalulanga **uLwesiHlanu we-14 Apreli 2023**.

9.1.8 UMququzeleli woVavanyo neeMviwo kwi-ofisi yesithili makadibanise iifom zabatyunjiweyo ezifunyenweyo kuwo onke amaziko okubhalela iimviwo yaye zingeniswe iifom kwaNdlunkulu ngebhetshi enye edityanisiweyo ungalulanga **uLweSithathu, we-19 Apreli 2023**.

10. Imisebenzi yabagadi babaviwa abaziintloko, eyabagadi babaviwa abaneqhuzu neyabagadi babaviwa

- 10.1 Abagadi babaviwa mabangabancedisi abaviwa kuyo nayiphi imisebenzi etenxileyo (*irregular activities*) ngethuba lokubhalwa koviwo. ISebe WCED) alisayi kulibazisa ekubekeni izimangalo zokwaphulwa komthetho ngakuye nawuphi na umgadi wabaviwa ofunyenwe enetyala lwako nakuphi ukubandakanyeka kwisitenxo (*irregularity*).
- 10.2 Abagadi babaviwa abaziintloko, abagadi babaviwa abaneqhuzu nabagadi babaviwa mabaphathe **izazisi zabo, iirekhodi zezifundo zakutshanje abazipasileyo neemvumelwano zengqesho** ngalo lonke ithuba lokubhalwa kweemviwo.
- 10.3 Iinqununu/abaphathi bamaziko mabenze ithayimthebhile yokugada abaviwa ize ingeniswe kumphathi weseke the ochaphazelekayo nje ukuba kuvunywe ukuqeshwa kwabagadi babaviwa.
- 10.4 Ithayimthebhile yokugada abaviwa mayibandakanye abagadi babaviwa kunye nabagadi babaviwa ababambeleyo kwiseshoni yoviwo nganye.

11. Uqeqesho lwabagadi babaviwa beemviwo zeNSC nezeSC

- 11.1 Ucweyo lwee-invigilators zoviwo lukaMeiy/ noJuni luza kuba ntlantlo-mbini.
- 11.2 Isebe iWCED liya kuthumela ikhonkco likagoogole nenkcazo-ntetho yoqeqesho erekhodiweyo kuwo onke amaziko okubhalela iimviwo. Izithili maziqinisekise ukuba uqeqesho luqhutywa kweli thuba, **17 – 21 Apreli 2023**.
- 11.3 Kuya kulungiselelwa iseshoni yoqeqesha yomntu omnye kumaziko amatsha/abaqalayo/okanye iinqununu/eziqala ngqa iinqununu/nabaphathi bamaziko nge-**19Apreli 2023** kwiSithili seMfundo seMetro North.
- 11.4 Abagadi babaviwa abaneqhuzu abahlala **kumgama we-75 km** ukusuka esikolweni okanye kwiziko apho kuqhutywa khona uqeqesho **baya kuhlululwa iseshoni enye eyongezelelweyo** ukwenzela imbuyiselo yeendleko zeehambo.
- 11.5 Abagadi babaviwa abaneqhuzu abahlala **kumgama ongaphezulu kwe-75 km** ukusuka kwindawo apho kuqhutywa khona uqeqesho **baya kuhlululwa iiseshoni ezimbini ezongezelelweyo** ukwenzela imbuyiselo yeendleko zeehambo.
- 11.6 Iinqununu/abaphathi bamaziko mabaqinisekise ukuba bonke ootitshala nabantu abangamalungu asekuhlaleni abaqeshwe njengabagadi babaviwa, baqeqeshwe ngokupheleleyo ekwenzeni imisebenzi yabo yokugada abaviwa.

- 11.7 Inqununu/abaphathi bamaziko nabagadi babaviwa abaziintloko **mabalugqithisele** uqeqesho kubo bonke abagadi babaviwa abangekayi kwiseshoni yoqeqesho yakwaNdlunkulu.
- 11.8 Iirejista zababekho kuqeqesho mazizaliswe njengobungqina kwinqanaba lesikolo yaye mazibonise umhla nendawo ekwakuqhutyelwa kuyo uqeqesho namagama abagadi babaviwa ababekwiseshoni leyo.
- 12. Ukutyunjwa nokuvunywa kwamagama abagadi babaviwa abaziintloko, abagadi babaviwa abaneqhuzu nabagadi babaviwa ukulungiselela zonke iimviwo**
- 12.1 Inqununu/umphathi weziko **makazalise isiHlomelo A (Z83) no-B**. Umphathi wesekethe uya kungqinisa amagama abatyunjiweyo acebise ngokutyunjwa kwabo emva koko agqithisele la maxwebhu kuMququzeleli woVavanyo neeMviwo kwaNdlunkulu ukwenzela ukuvunywa kwawo kokugqibela nokuqeshwa kwabo. **IsiHlomelo C (Summary of invigilators)** masizaliswe emva koko yaye sisayinwe yinqununu/ngumphathi weziko.
- 12.2 **IsiHlomelo G (Attendance register)** masizaliswe yaye masisayinwe yinqununu/ngumphathi weziko **ukungqinisa** inani leeseshoni ezigqityiweyo *ngenisia kuphela iform yebango*.
- 12.3 Amagama abagadi babaviwa abaneqhuzu abatyunjiweyo, makahanjiswe neekopi ezingqinisiweyo zesazisi somntu ngamnye otyunjiweyo, isivi (*curriculum vitae*) elikhasi elinye (enengxelo yamabanga emfundo akhe), **emayiquke ubuncinane isatifikethi seBakala 12**.
- 12.4 Kukhethwa ukuba mabangaqwalaselelwa ukuqeshwa abenzi-sicelo okanye abatyunjiweyo ababefake izicelo zokuqeshwa ngokusisigxina kwezinye iindawo.
- 12.5 Kuphela ngumntu ekuvunyiweyo ukutyunjwa kwakhe nguNdlunkulu onokwenza imisebenzi njengomgadi wabaviwa. Akuvumelekanga naphantsi kwazo naziphi iimeko ukuba abagadi babaviwa batyumba abagadi babaviwa ababambeleyo nakweyiphi inxenye yomsebenzi wabo.
- 12.6 Ukuba iimeko ziyamthintela umgadi wabaviwa oyintloko, umgadi wabaviwa oneqhuzu okanye umgadi wabaviwa ukuba agade abaviwa kuviwo, inqununu/umphathi weziko, ngokuthetha-thethana nomphathi wesekethe, makenze amalungiselelo okuqeshwa komgadi wabaviwa obambeleyo kwaye malaziswe ngolo tshintsho ngoko nangoko iCandelo loLawulo lweeMviwo. Abagadi babaviwa ababambeleyo nabo mabangenise ngokunjalo **isiHlomelo D no-H** ezizaliswe ngokupheleleyo. **Makuqatshelwe ukuba ngamaxwebhu ayintsusa kuphela angeniswayo aya kwamkelwa.**
- 13. Imvumelwano yokwenziwa kwenkonzo**

15. Ukuhlawulwa kwabagadi babaviwa

15.1 ISebe iWCED liya kubatyumba yaye libahlawule abagadi babaviwa abangabantu basekuhlaleni ngokungqinelana nemimiselo ye-*Personnel Administration Measures (PAM)* eyapapashwa kwiGazethi kaRhulumente No. 46879 yomhla we-09 Septemba 2022.

15.2 **Izikolo ezizimeleyo, iikholeji neentolongo, zinoxanduva lokuhlawula abagadi babaviwa bazo.** Nakuba kunjalo, iinqununu zezikolo ezizimeleyo, iintloko zeekholeji nezeentolongo maziqaphele ukuba **kunyanzelekile ukuzalisa iziHlomelo A, B, C no-E yaye zibuyiselwe kwiSebe iWCED** nangona abagadi babaviwa bala maziko bengahlawulwa liSebe i-WCED.

- 15.3 **Abasebenzi benkonzo karhulumente noofitshala (abaqeshwe ngokwemvumelwano nabasisigxina) abafumana umvuzo kwiSebe iWCED nabasebenza njengabagadi babaviwa, ABAYI kuhlalulwa liSebe iWCED ngemisebenzi yokugada abaviwa abayenzileyo.**
- 15.4 Ireyithi yentlawulo yokugada abaviwa ngoku (esengatshintsha) yi-**R2680, 80 ngeseshoni nganye kumgadi wabaviwa oneqhuzu** yaye ibe yi-**R179, 20 ngeseshoni nganye kumgadi wabaviwa.**
- 15.5 **Abagadi babaviwa abasayi kuhlalulwa phantsi kwazo naziphi iimeko ngeendleko zeehambo eziphathelele ekwenzeni imisebenzi yokugada abaviwa.** Iinqununu/abaphathi bamaziko, ngoko ke, mabaqeshe abagadi babaviwa abangabantu basekuhlaleni abafumana iinkonzo kweso sikolo okanye kwelo ziko.
- 15.6 Imimiselo (IRP10) engokuhlalulwa kwerhafu yomqeshwa imisela ukuba yonke imivuzo yabantu abaqeshwe ngokungesosigxina mayitsalelwe irhafu ye-25%. ISebe iWCED liya kuthi, ngoko ke, litsale **i-25% eyirhafu yezixa zentlawulo yabagadi babaviwa ngeenkono abazenzileyo.** Ngoko ke, **ukungeniswa komyalelo werhafu yabaqeshwa (tax directive) (IRP 3) akusasebenzi.**
- 15.7 Abagadi babaviwa abafanele ukuxolelwa ngokupheleleyo okanye ngokuyinxenye kwintlawulo yerhafu yomqeshwa, mabathi emva kokuba befumene izatifikethi ze-IRP 5 bazingenise kwi-ofisi yabo ye-South African Receiver of Revenue ekufutshane nabo, kwakunye nefom emiselweyo eyi-IT12 S form. Ii-IRP 5 certificates, ziya kuthunyelwa ngekhuriya ezikolweni ngoJuni okanye ngoJulayi kunyaka olandela lowo bebengabagadi babaviwa ngawo.
- 15.8 Ukwenzela ukuba kukhawuleziswe intlawulo yamabango kumgadi wabaviwa oneqhuzu okanye kumgadi wabaviwa, makabhale **inombolo yesazisi** yakhe kwifom yokwamkela ukuqeshwa baze baqhoboshele ikopi yesazisi eqinisekisiweyo. **IsiHlomelo D** ekubhalwe kuso kwakhona **inombolo yesalathiso yerhafu (tax reference number)** masizaliswe ngabo **bonke abagadi babaviwa abaneqhuzu nangabagadi babaviwa abangabantu basekuhlaleni.** Le fom mayizaliswe kwaye ingqinwe njengechanekileyo kwaye i-akhawunti yebhanki mayingqinwe njengesebenzayo yibhanki echaphazelekayo. **Makuqatshelwe: abagadi babaviwa mabaqinisekise ukuba ii-akhawunti zabo zebhanki zihlala zisebenza.**

- 15.9 Abagadi babaviwa abaqeshwe liSebe i-WCED kwizithuba ezisigxina okanye ezemvumelwano, abathatha ipakheji ngokuzithandela okanye abagxothwayo kwinkonzo yalo naliphi na isebe likaRhulumente waseMzantsi Afrika, baya kuvalwa (*blocked*) kwisistim yePesali (*Persal system*) yaye abayi kuzihlawulelwa iinkonzo abazenzileyo.
