1. Ngokwemimiselo ii-Regulations Pertaining to the Conduct, Administration and Management of National Senior Certificate examination, eyapapashwa kwiGazethi kaRhulumente No. 37651 ye-16 Meyi 2014, njengoko ifakelwe izilungiso ngowe-30 Apreli 2019, **amasebe emfundu amaphondo makatyumbe inqununu yesikolo njengomgadi wabaviwa oyintloko weemviwo zeNSC.**
2. linqununu nabaphathi bamaziko emfundu yabadala banokuwudlulisela lo msebenzi, ngencwadi ebhaliweyo, kwilungu leKomiti yoLawulo yeSikolo (School Management Team) (SMT) eliqeshwe liSebe leMfundu leNtshona Koloni (WCED). Nakuba kunjalo, inqununu/umphathi weziko uya kulwamkela ngokupheleleyo ekugqibeleni uxanduva nokuphendula ngokubhalwa kwazo zonke iimviwo kwisikolo/kwiziko akulo.

4. Kwiimviwo ze-NSC zangoNovemba 2023 umgadi wabaviwa oneqhuza (senior invigilator), ekufuneka abe ngumntu wasekuhlaleni, kulindeleke ukuba anike inkxaso umgadi wabaviwa oyintloko ekulawulweni nasekubhalweni kweemviwo. Akuvumelekanga, phantsi kwazo

naziphi iimeko ukuba umgadi wabaviwa oneqhuza makaluthathole kuye ngokupheleleyo uxanduva lwayo yonke imisebenzi yezolawulo enxulumene neemviwo zeNSC zangoNovemba 2023.

11. **Ukutyunjwa kwabagadi babaviwa**

- 11.2.3 Inqununu/umphathi weziko, uya kutyumba ngencwadi ebhaliwego, abantu abangamalungu asekuhlaleni abaya kuba besebenza njengomgadi wabaviwa oyintloko nanjengabagadi babaviwa kwiimviwo ze-NSC neze-SC zangoJuni 2024.
- 11.2.4 Inqununu/umphathi weziko uviwo makaqhube udliwano-ndlebe kune nomntu otyunjwe njengomgadi wabaviwa oneqhuzu ukuvavanya ubuchule bokufunda, ukubhala nokuva nokubanako ukubona komntu otyunjwe, kwakune nemeko yempilo yakhe ngokubanzi. Abantu abatyunjiwego mababenako ukuyiqonda ngokucacileyo yaye bayiphumeze imiyalelo yoviwo.
- 11.2.5 Inqununu/umphathi weziko makasayne ileta yokwamkela ukuqeshwa, emva kokuba inqununu/umphathi weziko uviwo enelisekile kukuba umgadi wabaviwa oneqhuzu ngumntu onako ukwenza imisebenzi efunekayo, makasayne ileta yokuqeshwa ukulungiselela umgadi wabaviwa oneqhuzu.
- 11.2.6 Umgadi wabaviwa oyintloko (Inqununu/umphathi weziko/umntu olilungu le-SMT) nomgadi wabaviwa oneqhuzu makaxeletloku ukuba kumele beze kwiseshoni yoqequesho Iwabagadi babaviwa eqhutywa liSebe i-WCED.
- 11.2.7 Uluhlu Iwabo bonke abantu abangamalungu asekuhlaleni abaqeshwe njengabagadi baviwa kwezi mviwo malungeniswe kwi-ofisi yesithili engadlulanga **ulwesihlanu we-22 Matshi 2024**.
- 11.2.8 UMququzeleli woVavanyo neeMviwo kwi-ofisi yesithili makadibanise iifom zabatyunjiwego ezifunyenwego kuwo onke amaziko okubhalela iimviwo yaye zingeniswe iifom kwaNdlunkulu ngebhethsi enye edityanisiwego engadlulanga **ulwesithathu, we-27 Matshi 2024**.
12. **Imisebenzi yabagadi babaviwa abaziintloko, eyabagadi babaviwa abaneqhuzu neyabagadi babaviwa**
- 12.1 Imisebenzi yabagadi babaviwa abaziintloko, eyabagadi babaviwa abaneqhuzu neyabagadi babaviwa, iyavela kwi-**Examination Procedure Manual, eqhotyoshelwe apha njengesiHlomelo I**.

- 12.2 Abagadi babaviwa mabangabancedisi abaviwa kuyo nayiphi imisebenzi etenxileyo (*irregular activities*) ngethuba lokubhalwa koviwo. ISebe i-WCED alisayi kulibazisa ekubekeni izimangalo zokwaphulwa komthetho ngakuye nawuphi na umgadi wabaviwa ofunyenwe enetyala lwako nakuphi ukubandakanyeka kwisitenxo (*irregularity*).

- 12.4 linqununu/abaphathi bamaziko mabenze ithayimthebhile yokugada abaviwa ize ingeniswe kumphathi weseke the ochaphazelekayo nje ukuba kuvunye ukuqeshwa kwabagadi babaviwa.
- 12.5 Ithayimthebhile yokugada abaviwa mayibandakanye abagadi babaviwa kune nabagadi babaviwa ababambeleyo kwiseshoni yoviwo nganye.

13. **Uqequeso lwabagadi babaviwa beemviwo ze-NSC neze-SC**

- 13.3 Kuya kulungiselelwa iseshoni yoqequeso bekhona abagadi babaviwa ukwenzela amaziko okubhalela iimviwo amatsha/aqalayo kune(okanye iinqununu/abaphathi bamaziko abatsha/abaqalayo. Umhla uya kwaziswa ngexesha elifanelekileyo.
- 13.4 Kunyanzelekile ukuba bonke abagadi babaviwa abaziintloko, abagadi baviwa abaneqhuzu, abantu abangamalungu asekuhlaleni nootitshala abaqeshiweyo bafumane uqequeso ekulawulweni nasekuqhutyweni kweemviwo.
- 13.5 Abagadi babaviwa abaneqhuzu abahlala **kumgama we-75 km** ukusuka esikolweni okanye kwiziko apho kuqhutywa khona uqequeso **baya kuhlawulwa iseshoni enye eyongezelwego** ukwenzela imbuyiselo yeendaleko zeehambo.
- 13.6 Abagadi babaviwa abaneqhuzu abahlala **kumgama ongaphezulu kwe-75 km** ukusuka kwindawo apho kuqhutywa khona uqequeso **baya kuhlawulwa iiseshoni ezimbini ezongezelwego** ukwenzela imbuyiselo yeendaleko zeehambo.

- 13.7 linqununu/abaphathi bamaziko mabaqinisekise ukuba bonke ootitshala nabantu abangamalungu asekuhlaleni abaqeshwe njengabagadi babaviwa, baqeqeshwe ngokupheleleyo ekwenzeni imisebenzi yabo yokugada abaviwa.
- 13.8 linqununu/abaphathi bamaziko nabagadi babaviwa abazintloko **mabalugqithisele** uqequesho kubo bonke abagadi babaviwa abangekayi kwiseshoni yoqequesho yakwaNdlinkulu.
- 13.9 lirejista zababekho kuqequesho mazizaliswe njengobungqina kwinqanaba lesikolo yaye mazibonise umhla nendawo ekwakuqhutyelwa kuyo uqequesho namagama abagadi babaviwa ababekwiseshoni leyo.
14. **Ukutyunjwa nokuvunywa kwamagama abagadi babaviwa abaziintloko, abagadi babaviwa abaneqhuzu nabagadi babaviwa ukulungiselela zonke iimviwo**
- 14.1 Inqununu/umphathi weziko **makazalise isiHlomelo A (Z83) no-B**. Umphathi wesekethe uya kungqinisa amagama abatyunjiweyo acebise ngokutunjwa kwabo emva koko agqithisele la maxwebhu kuMquazuzeleli woVavanyo neeMviwo kwaNdlinkulu ukwenzela ukuvunywa kwawo kokugqibela nokuqeshwa kwabo. **IsiHlomelo C (Summary of invigilators)** masizaliswe emva koko yaye sisayinwe yinqununu/ngumphathi weziko.
- 14.2 **IsiHlomelo G (Attendance register)** masizaliswe yaye masisayinwe yinqununu/ngumphathi weziko **ukungqinisa** inani leeseshoni ezigqityiweyo yaye zingeniswe nefom yebango.
- 14.3 Amagama abagadi babaviwa abaneqhuzu abatyunjiweyo, makahanjiswe neekopi ezingqinisisiweyo zesazisi (*ID*) zomntu ngamnye otyunjiweyo, isivi (*curriculum vitae*) elikhasi elinye (enengxelo yamabanga emfundo akhe), **emayiquke ubuncinane isatifikethi seBakala 12.**
- 14.4 Kukhethwa ukuba mabangaqwalaselelw ukuqeshwa abenzi-sicelo okanye abatyunjiweyo ababefake izicelo zokuqeshwa ngokusisigxina kwezinye iindawo.
- 14.5 Kuphela ngumntu ekuvuniweyo ukutyunjwa kwakhe nguNdlinkulu onokwenza imisebenzi njengomgadi wabaviwa. Akuvumelekanga naphantsi kwazo naziphi iimeko ukuba abagadi babaviwa batyumbe abagadi babaviwa ababambeleyo nakweyiphi inxenyne yomsebenzi wabo.
- 14.6 Ukuba iimeko ziyamthintel umgadi wabaviwa oyintloko, umgadi wabaviwa oneqhuza okanye umgadi wabaviwa ukuba agade abaviwa kuvivo, inqununu/umphathi weziko, ngokuthetha-thethana nomphathi wesekethe, makenze amalungiselelo okuqeshwa komgadi wabaviwa obambeleyo kwaye malaziswe ngolo tshintsho ngoko nangoko iCandelo loLawulo lweeMviwo. Abagadi babaviwa ababambeleyo nabo mabangenise ngokunjalo **isiHlomelo D no-H** ezizaliswe ngokupheleleyo. **Makuqatshelwe ukuba ngamaxwebhu ayintsusa kuphela angeniswayo aya kwamkelwa.**

- 17.5 **Abagadi babaviwa abasayi kuhlawulwa phantsi kwazo naziphi iimeko ngeendaleko zeehambo eziphathelele ekwenzeni imisebenzi yokugada abaviwa.** linqununu/abaphathi bamaziko, ngoko ke, mabaqeshe abagadi babaviwa abangabantu basekuhlaleni abafumana iinkonzo kweso sikolo okanye kwelo ziko.
- 17.6 Imimiselo (IRP10) engokuhlawulwa kwerhafu yomqeshwa imisela ukuba yonke imivuzo yabantu abaqeshwe ngokungesosigxina mayitsalelwe irhafu ye-25%. IsiSebe i-WCED liya kuthi, ngoko ke, litsale **i-25% eyirhafu yezixa zentlawulo yabagadi babaviwa ngeenkonzo abazenzileyo.** Ngoko ke, **ukungeniswa komyalelo werhafu yabaqeshwa (tax directive) (IRP 3) akusasebenzi.**
- 17.7 Abagadi babaviwa abafanele ukuxolelwa ngokupheleleyo okanye ngokuyinxenyne kwintlawulo yerhafu yomqeshwa, mabathi emva kokuba befumene izatifikethi ze-IRP 5 bazingenise kwi-ofisi yabo ye-South African Receiver of Revenue ekufutshane nabo, kwakunye nefom emiselweyo eyi-IT12 S form. li-IRP 5 certificates, ziya kuthunyelwa ngekhuriya ezikolweni ngoJuni okanye ngoJulayi kunyaaka olandela lowo weenkonzo abazenzileyo.
- 17.8 Ukwenzela ukuba kukhawuleziswe intlawulo yamabango kumgadi wabaviwa oneqhu okanye kumgadi wabaviwa, makabhale **inombolo yesazisi (ID)** yakhe kwifom yokwamkela ukuqeshwa baze baqhoboshele ikopi yesazisi eqinisekisiweyo. **IsiHlomelo D** ekubhalwe kuso kwakhona **inombolo yesalathiso yerhafu (tax reference number)** masizaliswe ngabo **bonke abagadi babaviwa abaneqhu** **nangabagadi babaviwa abangabantu basekuhlaleni.** Le fom mayizaliswe kwaye ingqinwe njengechanekileyo kwaye i-akhawunti yebhanki mayingqinwe njengesebenzayo yibhanki echaphazelekayo. **Makuqatshelwe:abagadi babaviwa mabaqinisekise ukuba ii-akhawunti zabo zebhanki zihlala zisebenza.**
- 17.9 Abagadi babaviwa abaqeshwe liSebe i-WCED kwizithuba ezsixgina okanye kwezemvumelwano, abathatha ipakheji ngokuzithandela okanye abagxothwayo kwinkonzo yalo naliphi na isebe likaRhulumente waseMzantsi Afrika, baya kuvalwa

(blocked) kwisistim yePesali (Persal system) yaye abayi kuzihlawulelwa iinkonzo abazenzileyo.
