1. Ingcaciso eMfutshane yeCandelo loLawulo lwaBasebenzi ngoBuchule 007/2019, yomhla we-29 Julayi 2019, imalunga noku.
2. Inkxaso ebonelelwayo ukwenzela izifundo zokuphucula umgangatho wamabanga emfundo igxininisa kubo bonke abaqeshwa beSebe leMfundo leNtshona Koloni (WCED) abaqeshwe ngokoMthetho weNkonzo kaRhulumente, 1994 (ISibhengezo 103 sika-1994 (*Public Service Act, 1994 (Proclamation 103 of 1994)*)), kuqukwa nabo baphantsi kwe-*Occupation Specific Dispensation (OSD)*. Kupapashwa iibhasari zaqho ngonyaka zamacandelo akhethekileyo ezifundo ahambelana neemfuno zeSebe iWCED. Ezi bhasari zihlawulela iindleko ezipheleleyo zezifundo (*full cost of tuition*). Ukongeza kwezi bhasari, kwenziwe amalungiselelo oKuatshelwa kwaMabanga eMfundo aPhuculweyo (*Improved Qualifications*) ngokweSigqibo i-*Public Service Coordinating Bargaining Council (PSCBC) Resolution No 1 sika-2012*, neSigqibo i-*General Public Service Sector Bargaining Council (GPSSBC) Resolution No. 5 sika-2014* nangokweSetyhula ye-*Department of Public Service and Administration's (DPSA) Circular HRD 3 ka-2015*, yomhla we-14 Agasti 2015.
3. Le ngcaciso imfutshane mayifundwe noku kulandelayo: iSigqibo *PSCBC Resolution No. 1 sango-2012*, iSigqibo *GPSSBC Resolution No. 5 sango-2014* neSetyhula i-*DPSA Circular HRD 3 ka-2015*, yomhla we-14 Agasti 2015.

4. NgokweSetyhula i-DPSA Circular HRD 3 yango-2015 yomhla we-14 Agasti 2015, umqeshwa onenjongo yokubhalisela ibanga lemfundo, othi akuliphumelela, anqwenele ukuqwalaselelwa ibhonasi eyimali, uya kuqala acele invume kwiNtloko yeSebe yokubhalisela elo banga lemfundo.
5. Umqeshwa weSebe iWCED obhalisele ukuphucula amabanga emfundo akhe emva komhla wokuphunyezwa kweSigqibo i-GPSSBC Resolution No. 5 sika-2014 naphambi kokuba iSebe iWCED limisele iikhrayitheriya ezizezalo, anganako ukufaneleka afumane ibhonasi eyimali ngokuxhomekeke ekubeni ibanga lemfundo eliphunyelelweyo liyazifezekisa iikhrayitheriya ezivunywe liSebe iWCED yakuba ifumaneka. Kuya kusebenza imiqathango njengoko ichaziwe kumhlathi 5 weSigqibo i-GPSSBC Resolution No. 5 sika-2014. Nakuba kunjalo, lo mgqaliselo, uyaphelelwa ngowama-**30 Novemba 2023**, into ethetha ukuba umqeshwa makafake isicelo phambi kokuba aqalise ukuphucula umgangatho webanga lemfundo lakhe, afumane invume yaye akuba ezigqibile izifundo zakhe, afake ubungqina ukwenzela ukuba afumane ibhonasi eyimali ngokungqinelana ne-RIQ.

8. Ibhonasi eyimali inokuhlawulelwa ibanga lemfundo eliphunyelelweyo elinye qwaba kuphela (makufundwe umhlathi 6.7 weSigqibo i-GPSSBC Resolution No. 5 sika-2014).
9. Nakuba kunjalo, inkqubo ye-RIQ ecaciswe apha ngentla ayithathi ndawo ye-*Public Service Bursary Scheme* esikhoyo kwiSebe iWCED. Ezi ziinkqubo ezimbini ezahlukeneyo yaye amagosa anokuzuzwa kwenye yazo kuphela, oko kukuthi kwi-*Public Service Bursary Scheme* okanye kwi-RIQ.
