Isihloko: **Isikhokelo sokuthengwa kwefenitshala nezixhobo zokusebenza ukulungiselela owama-2024**

- 1. Inkqubo yokubeka phambili ngokokubaluleka nokuthengwa kwefenitshala nezixhobo zokusebenza zezikolo**
 - 1.1 Ikhathalogu yokuthengwa kwefenitshala iquka ii-ayithem eziyi-30 zefenitshala yesikolo neekhomponenti eziyi-22 kuxwebhu oluqhotyoshelweyo (isiHlomelo A). Zonke izicelo zefenitshala nezixhobo zokusebenza ezsuka kwizikolo ezikhoyo mazingeniswe ngefom echanekileyo. Le fom yesicelo mayingeniswe kumphathi wesekethe wesikolo ungdululanga owama-12 Meyi 2023.
 - 1.2 Makwenziwe isicelo sefenitshala kwifom yeSebe leMfundu leNtshona Koloni (WCED 026A form (isiHlomelo B) yaye mayisayinwe ngabo bonke abasayinayo abachaphazelekayo.
 - 1.3 Izixhobo mazithengwe kwifom WCED 026B form (isiHlomelo C) yaye mayisayinwe ngabo bonke abasayinayo abachaphazelekayo.
 - 1.4 Ezi khomponenti zefenitshala zingentla (22) mazi-odolwe kuphela zizikolo ezineekhomponenti ezophukileyo/ezonakeleyo zeplanga (*broken/damaged wooden components*) ezifuna ukuzilungisa/ukuzenza ntsha kwakhona.
 - 1.5 Amagosa ezithili ekudluliselwe amagunya kuwo aya kuhlola izicelo zefenitshala nezezixhobo zokusebenza kwisekethe nganye yaye baqulunge uluhlu lwee-ayithem ezibalulekileyo ngokungqinelana nebhajethi efumanekayo. Olu luhlu lwee-ayithem ezibalulekileyo luya

kuthunyelwa kwiCandelo eliyiNtloko leZithili ungadlulanga owe- 9 Juni 2023 ukwenzela ukuvunywa kwalo.

- 1.6 Amagosa ekudluliselwe kuwo amagunya kwii-ofisi zezithili aya kwazisa izikolo ngencwadi ebhaliwego ukuba ngaba izicelo zazo okanye inxalenye yazo ivuniyiwe, zifakelwe izilungiso, okanye azivunywanga.
- 1.6 Ezi ayithem ziya kuthengwa kusetyenziswa inkqubo yeziniki-maxabiso yaye izikolo ziya kukwaziswa ngokunjalo.
- 1.7 Izikolo mazibalandelele abaphathi beesekethe abachaphazelekayo ukwenzela ukuba ziqonde ukuba yeyiphi na ifenitshala okanye izixhobo zokusebenza ezikuluhlu lwezinto ezibalulekileyo.
- 1.8 Ukufakwa kwee-odolo zefenitshala ezivuniwego nezixhobo zokusebenza kuya kuqaliswa ekuqaleni konyaka-mali omtsha (14 Juni 2023).

2. Ithuba lokusebenza kwewaranti nefenitshala eyonakeleyo

- 2.1 Ifenitshala nezixhobo zokusebenza zinewaranti yonyaka omnye ukususela kumhla wokusiwa kwazo ezikolweni.
 - 2.1.1 Izikolo ezifumana ifenitshala okanye izixhobo zokusebenza ezonakeleyo okanye ezophukileyo mazazise uNdlinkulu kwangethuba ngokungenisa ingxelo ebhaliwego kule dilesi ye-imeyili: Moya.Paterson@westerncape.gov.za.
 - 2.1.2 ISebe i-WCED liya kubonisana nomthengisi ukwenzela ukuba benze amalungiselelo okutshintsha ifenitshala nezixhobo zokusebenza ngokukhawuleza kangangoko kunako.
- 2.2 Ifenitshala okanye izixhobo zokusebenza ezonakeleyo ezinokulungiswa mazigcinwe kakuhle ukuthintela ukuba zingonakali kwakhona.
- 2.3 Izikolo zinoku-odola iikhomponenti kwikhathalogu yefenitshala ukuze zilungise nayiphi na ifenitshala enesiphene okanye eyonakeleyo ezinayo.
- 2.4 Ukuba izikolo zi-odola ifenitshala ngqo kumthengisi, isikolo siya kuba noxanduva lokuhlawula ezo odolo.
- 2.5 Izikolo zinokusebenzia isabelo sazo saqho ngonyaka semimiselo nemigangatho yolwabiwomali (*annual norms and standards allocation*) neemali zesikolo ukuthenga kunye(okanye ukulondoloza ifenitshala nezixhobo zokusebenza ebezingafakwanga kuluhlu lwezinto ezibalulekileyo zii-ofisi zezithili zazo.

3. Ukulawulwa kwefenitshala nezixhobo zokusebenza ezikolweni

- 3.1 Izikolo maziseke ikomiti yokusingatha ukuthengwa kweempahla neenkonzo (*procurement committee*) eya kuba noxanduva lokugcina iirekhodi ezhlaziyiweyo zefenitshala nezezixhobo zokusebenza.
- 3.2 Ifenitshala kanye/okanye izixhobo zokusebenza ezingasasetyenziswayo mazicinywe yaye zichithwe emva kokuba kuthathwe isigqibo ngazo kwintlanganiso engokuchithwa kweempahla. Imizuzu mayibonise isigqibo esilolu hlobo yaye mayigcinwe kwiirekhodi.
- 3.3 Ikopi yemizuzu ekubhekisa kuyo kumhlathi 3.2 mayithunyelwe kule dilesi ye-imeyili Moya.Paterson@westerncape.gov.za ukuqinisekisa ukuba iCandelwana leFenitshala neZixhobo zoKusebenza lizihlaziya qho iirekhodi ezikwikhompyutha zefenitshala nezixhobo zokusebenza ezikwi-CEMIS.

4. ISistim ye-CEMIS

- 4.1 Yonke ifenitshala nezixhobo zokusebenza ezisiwe ezikolweni ziya kufakwa kwikhompyutha kwisistim ye-CEMIS ngabasebenzi beCandelwana leFenitshala neZixhobo zoKusebenza.
 - 4.2 Izikolo mazizihlaziye iirekhodi ze-inventri zazo qho ngonyaka nekufuneka ziquke ifenitshala eyongezelelwego ethengwe ngeemali zazo, istokhwe esikhoyo nefenitshala echithiweyo (*disposed*) kwanezinto ezishotayo.
 - 4.3 Ezi rekhodi mazisetyenziselwe ukuqaphela imfuno yesikolo yokongezelela ifenitshala nezixhobo zokusebenza.
 - 4.4 Ukwenzela ukuba zigcinwe ngokukhuslekileyo zingabiwa ii-asethi, kukhuthazwa izikolo ukuba ziyibhale ngokucacileyo yonke ifenitshala nezixhobo zokusebenza.
