Curriculum and Assessment Management Minute: 0008/2024

To: Deputy Directors-General, Chief Directors, Directors, Chief Education Specialists, Deputy Chief Education Specialists, Senior Education Specialists and Principals of all schools

Subject: Implementation of the 2024 Programme of Assessment in public schools across the General Education and Training band (Grades 1–9)

- 1. The Department of Basic Education (DBE) released National Assessment Circular 01 of 2024, dated 05 April 2024, Annexure A, to indicate that Assessment Management Minute 0001/2023, dated 23 January 2023, on the Programme of Assessment (POA) for Grades 1–9, is still applicable in 2024.
- 2. The Revised Annual Teaching Plans (ATPs) and the revised weightings for School-based Assessment (SBA) and examinations were amended as follows:

PHASE	REVISED SBA/EXAMINATION WEIGHTINGS	CONTROLLED TEST/EXAMINATION
Foundation (Grades R-3)	100% SBA	
Intermediate (Grades 4–6)	80% (SBA): 20% (Examinations)	mid-year/June controlled tests and an end of year-controlled test
Senior (Grades 7–9)	60% (SBA): 40% (Examinations)	mid-year/June controlled tests /examination and an end-of- year full-scale examination for all subjects.

- 3. The content of the controlled tests must be based on work done stipulated in the Recovery ATPs. In principle, the June controlled tests should cover work from Terms 1–2 and the end of year-examination should cover work from Terms 3–4, unless the subject ATP specifies inclusion of content from other terms.
- 4. The POA is aligned to the 2023/24 Revised ATP for each of the subjects and grades in the General Education and Training (GET) band.

- 5. The types and number of tasks, including mark allocation and weighting of the tasks, per subject and grade, are summarised in the Annexures A, B and C of National Assessment Circular 0001/2024.
- 6. In the Intermediate and Senior phases, where weightings are not indicated for a subject, the weightings are distributed evenly among the tasks for the term.
- 7. This minute builds on the key principles of implementing quality assessment tasks in the GET band that were introduced in 2020 and follows on from processes around curriculum trimming and reorganisation. The focus of SBAs remains on utilising strategies aligned to an Assessment for Learning approach to assist learners to achieve the learning outcomes of each grade and subject.

## 8. Moderation of summative (formal assessment) tasks

- 8.1 The Western Cape Education Department (WCED) Circular 0042/2019, dated 13 November 2019, outlines the quality assurance of formal/summative assessment tasks in a subject by the departmental/subject head or a specialist teacher deemed to be competent in the subject, or a departmental/subject head from a neighbouring school, prior to the administration of the assessment task.
- 8.2 The moderator must also ensure that the task is accompanied by detailed and accurately formulated marking guidelines or a rubric. All moderation findings must be reported to the relevant educator(s) of that subject.
- 8.3 For class tests and controlled tests, educators of the same grade and subject should sample a few scripts and discuss the marking guidelines/rubric as a team to ensure that the marking is standardised. All scripts that have been marked by the educator must be submitted to the moderator who should sample a reasonable number of scripts for moderation.
- 8.4 Setting of high-quality assessment tasks for SBAs is important and schools must keep a record of all assessment tasks and the internal moderation reports as this may be subject to verification by the district and the province.

## 9. Assessment for learning (formative assessment)

9.1 Curriculum and Assessment Management Minute 0004/2020, dated 13 October 2020, provided guidance on assessment for learning/formative assessment which must inform the process of teaching and learning. This refers to informal, daily assessments that are done during the lesson by educators to improve the knowledge, understanding or skills of the learners.

- 9.2 The assessment for learning/formative assessment is a pedagogical approach to monitor the in-class teaching and learning process as well as identifying possible learning gaps of learners. Activities such as observations, questions, discussions, journals, multiple choice questions, practical presentations, etc. as stated in the WCED Guidelines to support teachers in improving assessment for learning, dated 13 August 2020, along with a set of infographics that can be accessed via the ePortal, can be used.
- 9.3 The assessment for learning approach should be used to support and prepare learners for summative assessments. This, in turn, will assist educators to obtain evidence for use in supporting learners to improve their knowledge, understanding and skills to improve learning.
- 9.4 Educators are encouraged to record trends observed in informal assessment activities to inform future teaching strategies.

## 10. Recording of learner performance

- 10.1 The WCED Grades 1–9 recording and reporting programmes on CEMIS are used for recording marks on the record sheets. Schools must ensure that all data captured is verified by the school management.
- 10.2 The weightings of individual SBA tasks are programmatically included in the recording and reporting programmes; schools will not be expected to make programmatic changes to the individual task weightings.
- 10.3 The recording and reporting programme contains a built-in functionality when an assessment is not administered, e.g. to capture valid absenteeism. Where necessary, use "A: Abs", as stated on the instruction sheet of the recording and reporting programme. This will contribute to an honest reflection of a learner's progress and performance.

## 11. School-based Support Teams (SBSTs)

- 11.1 It has been observed from the implementation of the POA in 2023 that there is a need for improvement in the early identification of learners displaying learning gaps. The failure of schools to identify learning gaps timeously and address them has disadvantaged learners to the extent that some of these learners must be retained.
- 11.2 It is therefore requested that SBSTs, as per the DBE's *Policy on Screening, Identification, Assessment and Support (SIAS)*, 2014, and as was outlined in Assessment Management Minute 0005/2017, dated 16 March 2017, should ensure that adequate and appropriate support is given to learners who display gaps or experience barriers to learning.
- 11.3 Accommodations and concessions should be applied for as early as possible to ensure that learners are not disadvantaged in any way. The process for application was outlined in Assessment Management Minute 0001/2019, dated 28 January 2019.

11.4 In line with the SIAS, the early identification of learners with learning barriers remains a

priority. As support to learners, application for assessment accommodations and concessions should be applied for as explained in Assessment Management Minute

0001/2019.

11.5 The support programme provided by the school must guide feedback to parents at regular

intervals during the academic year and must guide decisions on possible retentions and/or

support that could be provided to the learner in the next grade.

12. Schedules and reports

12.1 Final promotion schedules for all grades must be approved and signed off by the circuit

managers and captured on CEMIS until 11 December 2024.

12.2 The report cards provided to parents will show the code and percentage for all four terms

as well as the final promotion/progression code and percentage at the end of the

academic year.

12.3 Comments relating to learner performance are entered by the educators and are

automatically transferred to be reflected on the report card. Educators are encouraged to use commentary based on a holistic reflection of learners' capabilities and not just an

aggregation of the summative scores. It should also reflect evidence of learners'

capabilities that were observed through formative assessment and the assessment for

learning process.

12.4 It is necessary for schools to have sufficient evidence of communication to parents about

support to learners who have been identified as not ready to progress.

12.5 The WCED 2024 Grades 4–9 recording and reporting programmes on CEMIS have already

been adapted to cater for the special mark adjustment and condonation dispensation for 2024 (see Circular 0030 of 2023, dated 06 November 2023). This implies that the current

programmes on CEMIS can be used for the entire year.
