1. ISebe leMfundo leNtshona Koloni kutshanje lityumbe umboneleli-nkonzo omtsha wokubonelela nokulawula inkonzo yokupheka e-CTLI iminyaka emithathu.
2. Kuluvuyo ke ngoko ukunazisa ukuba ukususela nge-01 Julayi 2024, *I-Feedem Group (Pty) Ltd* ifumene isivumelwano sokubonelela ngazo zonke izidlo neziphungo kubasebenzisi beefasilithi ze-CTLI. Oku kuthetha ukuba abasebenzisi baya kunyanzeliswa ukuba basebenzise umboneleli-nkonzo olungiselela ukutya kwifasilithi ngokwemvumelwano enqamlezileyo yaye akukho batyisi bambi baya kuvunyelwa kwindawo leyo.
3. Kwakuba kungqinwe ukubhukisha e-CTLI, umenzi-sicelo makachaze iimfuno zakhe zokutya ngqo nalowo uqeshwe ngemvumelwano. Imenyu efanayo iya kufumaneka kubo bonke abasebenzisi yaye baya kunikwa iikhuphoni zokutya ezinokutshintshwa kufunyanwe ukutya/iiti, njl. njl. Ekupheleni komsitho, umsebenzisi ngamnye uya kunikwa i-invoyisi ngumthengisi (caterer) yaye iintlawulo ziya kusingathwa nge-*Procurement Management*, njengoko kumiselwe. Umboneleli-nkonzo okwifasilithi naye unokugunyaziswa ukuba abonelele ngokutya kwesebe ngaphandle kwendawo, ngaphandle kweenkqubo ezongezelelweyo zokuthenga. Iirejista eziqhelekileyo zokubakho emsebenzini kunye nee-invoyisi eziqinisekisiweyo maziqhotyoshelwe kwiziqinisekiso zentlawulo kuzo zonke iimeko.
