Isihloko: Kucelwa izicelo zesithuba sokuba ligosa elingumakhi-mkhanya (monitor) kwiimviwo zeSatifikethi seMatriki sikaZwelonke (NSC) nezeSatifikethi seMatriki (SC) zango-2024/2025

1. Ukuqinisekiswa komgangatho, ukuziphatha kakuhle, ulawulo nokusingathwa kweemviwo kubalulekile kuwo onke amanqanaba enkqubo yemfundo. Ukuqinisekisa ukuba iimviwo zeSatifikethi i-NSC/SC zithembekile, iSebe leMfundo leNtshona Koloni (iSebe i-WCED) liya kuba lisomeleza ukubekwa esweni kweemviwo kwiphondo liphela.
2. Imimiselo nemigangatho eyeyona isezantsi ekubekweni esweni kwamaziko ekubhalelwa kuwo iimviwo ngethuba leemviwo icacisiwe kumgaqo-nkqubo i-Regulations Pertaining to the Conduct, Administration and Management of the National Senior Certificate examination, owawupapashwe kwiGazethi kaRhulumente No. 31337 yowe-29 Agasti 2008 njengoko ufakelwe izilungiso.
3. ISebe i-WCED ngokwenjenje licela ootitshala ababeqeshwe ngaphambili (abadla umhlalaphantsi) okanye amagosa anamava ngokubhalwa nolawulo olufanelekileyo lweemviwo enze isicelo sokuba ligosa elingumakhi-mkhanya (monitor), ukubeka esweni iimviwo ze-NSC kunye/ okanye ze-SC zango-2024/2025.

isekela nqununu okanye igosa loviwo (umz., umlawuli oncedisayo, usekela mlawuli, umlawuli).

- 4.2 Ngonamava eminyaka emithathu ubuncinane njengegosa elingumakhi-mkhanya okanye ekubhalweni, ekulawuleni nasekuphathweni kweemviwo ze-NSC kunye/okanye ze-SC.
- 4.3 Ngongenalo irekhodi lolwaphulo-mthetho/ lendlela yokungakwazi ukuziphatha.
- 4.4 Ngongagqithanga kwiminyaka yobudala eyi-69 phambi okanye ngowe-31 Agasti 2024. Kuya kufuneka isatifikethi senkcazo yezonyango (*medical certificate*) esisuka kugqirha ukungqina ubume bempilo yakhe.

 - uvavanyo olumalunga neengxaki ezinokubakho ngawe (*your risk assessment*)/iprofayili iveza inkcazo (*legend*) yokungathembeki kwakho engu-“Risk”
