Subject: Implementation of Mother Tongue-based Bilingual Education (MTbBE) in 2025

1. The Department of Basic Education's (DBE) Circular 18/2024, dated 16 October 2024 (Annexure A), supports the use of trans-languaging in teaching and learning to empower learners through their home languages (mother tongue). The Western Cape Education Department (WCED) is pleased to announce the introduction of MTbBE in the Western Cape. The aim is to improve educational outcomes while fostering respect for learners' linguistic and cultural identities.

2. Implications of MTbBE implementation

The introduction of MTbBE in Afrikaans, English, and Xhosa for primary schools has several benefits. It is designed to enhance educational outcomes, promote cultural identity and strengthen social cohesion among learners.

3. Understanding MTbBE

4. Roles and responsibilities

Annexure C outlines the roles and responsibilities of various stakeholders to ensure the successful implementation of MTbBE.

5. Advocacy and awareness

To support the rollout of MTbBE, an advocacy process will begin in early 2025. This will include:

- Workshops and training: Informational sessions for stakeholders on MTbBE's benefits.
- Community engagement: Involving parents and community leaders to build support.

• Collaboration: Partnering with local organisations and nongovernmental organisations to raise awareness and gather feedback.
