1. Ngokwemimiselo ii-Regulations Pertaining to the Conduct, Administration and Management of National Senior Certificate examination, eyapapashwa kwiGazethi kaRhulumente No. 37651 yowe-16 Meyi 2014, njengoko ifakelwe izilungiso ngowe-30 Apreli 2019, **amasebe emfundo amaphondo makatyumbe inqununu yesikolo njengomgadi wabaviwa oyintloko weemviwo zeNSC.**
2. Iinqununu nabaphathi bamaziko emfundo yabadala banokuwudlulisela lo msebenzi, ngencwadi ebhaliweyo, kwilungu leKomiti yoLawulo yeSikolo (School Management Team) (SMT)) eliqeshwe ngokusisigxina liSebe leMfundo leNtshona Koloni (WCED). Nakuba kunjalo, inqununu/umphathi weziko uya kulwamkela ngokupheleleyo ekugqibeleni uxanduva nokuphendula ngokubhalwa kwazo zonke iimviwo kwisikolo/kwiziko akulo.
3. **Umgadi wabaviwa oneqhuzu** uya kusebenza **njengomgadi wabaviwa oyintloko KUPHELA** kwiimviwo ze-SC eziya kubhalwa ngoMeyi/Juni 2024. Inqununu ihlala **ingumgadi wabaviwa oyintloko** wemviwo zangoNovemba 2024.
4. Kwiimviwo ze-NSC zangoNovemba 2024 umgadi wabaviwa oneqhuzu (senior invigilator), ekufuneka abe ngumntu wasekuhlaleni, kulindeleke ukuba anike inkxaso umgadi wabaviwa oyintloko ekulawulweni nasekubhalweni kweemviwo. Akuvumelekanga, phantsi kwazo

naziphi iimeko ukuba umgadi wabaviwa oneqhuzu makaluthathele kuye ngokupheleleyo uxanduva lwayo yonke imisebenzi yezolawulo enxulumene neemiwiwo ze-NSC zangoNovemba 2024.

5. Kucelwa iinqununu/abaphathi bamaziko abakhethiweyo emfundo yabadala bafune abantu basekuhlaleni abafanelekileyo (ngokwekhayitheriya ezikumhlathi 10) abaya kusebenza njengabagadi babaviwa abaneqhuzu kunye nabagadi babaviwa kwezi mviwo zikhankanywe ngentla.
6. Kucelwa iinqununu/abaphathi bamaziko emfundo yabadala ukuba bagaye KUPHELA abantu abazifezekisayo iikhayitheriya ezichazwe kumhlathi 10.

- 10.2 Ukongeza kumgadi wabaviwa oyintloko, **makuqeshwe umgadi wabaviwa abe mnye kuma-30 ngalinye labaviwa. Igumbi malisetyenziswe ngokomthamo walo opheleleyo phambi kokuba kusetyenziswe elinye igumbi elongezelelweyo.**
- 10.3 Kwiiseshoni apho kukho kuphela inani elincinane labaviwa (ababini ilelona nani lisezantsi), ziya kwanela iinkonzo zomgadi wabaviwa omnye. Kwiimeko ezilolu hlobo, umgadi wabaviwa oneqhuzu okanye oyintloko akasayi kwenza misebenzi yesiqhelo yokugada abaviwa, kodwa uhlala esenza umsebenzi wokulawula yonke imisebenzi yezolawulo yeseshoni yoviwo nokuphumza umgadi wabaviwa amakakhaphe umviwa ukuya kwigumbi langasese.

Ukuba kukho abaviwa abangamadoda nabangamabhinqa yaye umgadi wabaviwa oyintloko ngumntu oyindoda, ubuncinane omnye wabagadi babaviwa makabe libhinqa, okanye, ukuba umgadi wabaviwa oyintloko libhinqa, ubuncinane omnye wabagadi babaviwa makabe yindoda.

10.5 Xa kufuneka iinkonzo zabagadi babaviwa abongezelelweyo ukulawula amagumbi okubhalela iimviwo (ngeseshoni nganye) amabini okanye ngaphezulu ngaxeshanye, umgadi wabaviwa oyintloko akasayi kwenza misebenzi yesiqhelo yokugada abaviwa, endaweni yoko, kuya kufuneka ukuba enze imisebenzi yomgadi wabaviwa oyintloko kuwo onke amagumbi ekubhalelwa kuwo.

11. **Ukutyunjwa kwabagadi babaviwa**

Umgadi wabaviwa oneqhuzu uya kuqeshwa njengomgadi wabaviwa oyintloko.

11.1.3 Inqununu/umphathi weziko, uya kutyumba ngencwadi ebhaliweyo, abantu abangamalungu asekuhlaleni abaya kuba besebenza njengomgadi wabaviwa oyintloko nanjengabagadi babaviwa kwiimviwo ze-NSC neze-SC zangoJuni 2024.

11.1.4 Inqununu/umphathi weziko makaqhube udliwano-ndlebe kunye nomntu otyunjwe njengomgadi wabaviwa oneqhuzu ukuvavanya ubuchule bokufunda, ukubhala nokuva nokubanako ukubona komntu otyunjiweyo, kwakunye nemeko yempilo yakhe ngokubanzi. Abantu abatyunjiweyo mababenako ukuyiqonda ngokucacileyo yaye bayiphumeze imiyalelo yoviwo.

- 11.1.5 Inqununu/umphathi weziko emva kokuba onelisekile kukuba umgadi wabaviwa oneqhuzu ngumntu onako ukwenza imisebenzi efunekayo, makasayine ileta yokuqeshwa ukulungiselela umgadi wabaviwa oneqhuzu.
- 11.1.6 Umgadi wabaviwa oyintloko (Inqununu/umphathi weziko/umntu olilungu le-SMT) nomgadi wabaviwa oneqhuzu makaxelelwe ukuba kumele beze kwiseshoni yoqeqesho lwabagadi babaviwa eqhutywa liSebe iWCED.
- 11.1.7 Uluhlu lwabo bonke abantu abangamalungu asekuhlaleni abaqeshwe njengabagadi babaviwa kwezi mviwo malungeniswe kwi-ofisi yesithili ungadlulanga **uLwesithathu we-18 Matshi 2024**.
- 11.1.8 UMququzeleli woVavanyo neeMviwo kwi-ofisi yesithili makadibanise iifom zabatyunjweyo ezifunyenweyo kuwo onke amaziko okubhalela iimviwo zize zingeniswe iifom kwaNdlunkulu ngebhetshi enye edityanisiweyo ungadlulanga **uMvulo, we-22 Matshi 2024**.
- 11.2 **Iimviwo ze-NSC zangoNovemba 2024**
- 11.2.1 Kwiiseshoni zeemviwo zeNSC, inqununu/umphathi weziko makaqinisekise ukuba **ama-50% abagadi babaviwa ngootitshala yaye ama-50% ibe ngabantu basekuhlaleni**.
- 11.2.2 Ootitshala abasebenza njengabagadi babaviwa **akuyomfuneko** ukuba bafakwe kwishedyuli ephelileyo yokugada abaviwa kwiseshoni nganye yoviwo. Nakuba kunjalo, umlinganiselo wobungakanani bootitshala kubagadi babaviwa basekuhlaleni mawugcinwe ngawo onke amaxesha.
- 11.2.3 Utitshala onomntwana wakhe/onomntwana amgcinayo obhala iimviwo zeNSC **esikolweni** apho utitshala aqeshwe khona, **makangatyunjwa** njengomgadi wabaviwa.
- 11.2.4 Kunyanzelekile ukuba utitshala angabandakanyeki ekubagadeni abafundi ababhala isifundo asifundisayo esikolweni.
- 11.2.5 Inqununu/umphathi weziko makatyumbe ngencwadi ebhaliweyo bonke ootitshala abaya kusebenza njengabagadi babaviwa kwiimviwo zeNSC. Ilisti yabo bonke ootitshala nabantu abangamalungu asekuhlaleni abatyunjwe njengabagadi babaviwa mayingeniswe kwi-ofisi yesithili **engadlulanga uLwesithathu, we-17 Julayi 2024**.
- 11.2.6. UMququzeleli woVavanyo neeMviwo kwi-ofisi yesithili makaqokelele yaye ahlanganise iifom zamagama atyunjiweyo (*nomination forms*) ezisuka kuwo onke amaziko okubhalela uviwo azingenise ezi fom kwaNdlunkulu zikwibhetshi enye ehlangeneyo (*one collated batch*) ungadlulanga **uMvulo, wama-29 Julayi 2024**.

12. **Imisebenzi yabagadi babaviwa abaziintloko, eyabagadi babaviwa abaneqhuzu neyabagadi babaviwa**

12.1 Imisebenzi yabagadi babaviwa abaziintloko, eyabagadi babaviwa abaneqhuzu neyabagadi babaviwa, iyavela kwi-**Examination Procedure Manual, yango-2016** eqhotyoshelwe apha.

12.2 Abagadi babaviwa mabangabancedisi abaviwa kuyo nayiphi imisebenzi etenxileyo (*irregular activities*) ngethuba lokubhalwa koviwo. ISebe i-WCED) alisayi kulibazisa ukufaka isimangalo solwaphulo-mthetho ngakuye nawuphi na umgadi wabaviwa ofunyenwe enetyala lwako nakuphi ukubandakanyeka kwisitenxo (*irregularity*).

12.5 Ithayimthebhile yokugada abaviwa mayibandakanye abagadi babaviwa kunye nabagadi babaviwa ababambeleyo kwiseshoni yoviwo nganye.

13.3 Ileshoni yoqeqesho enye eyenziwa umntu ekhona iya kulungiselelwa amatsha/aqalayo amaziko okubhalela iimviwo kunye/okanye eziqalayo/ezintsha iinqununu/abaphathi bamaziko. Umhla uya kwaziswa ngexesha elifanelekileyo.

13.4 Kunyanzelekile ukuba bonke abatyunjelwe ukuba ngabagadi babaviwa abaziintloko, abagadi babaviwa abaneqhuzu, abantu abangamalungu asekuhlaleni abaqeshwe njengabagadi babaviwa, oofitshala baqeqeshwe ngokupheleleyo ekwenzeni imisebenzi yabo yokugada abaviwa.

- 13.5 Abagadi babaviwa abaneqhuzu abahlala **kungama ongama-75 km** ukusuka kwisikolo/kwiziko lokubhalela iimviwo apho kuqhutywa khona uqeqesho **baya kuhlulwa iseshoni enye eyongezelelweyo** ukwenzela imbuyiselo yeendleko zeehambo.
- 13.6 Abagadi babaviwa abaneqhuzu abahlala kungama **ongaphezulu kwama-75 km** ukusuka kwindawo apho kuqhutywa khona uqeqesho **baya kuhlulwa iseshoni ezimbini ezongezelelweyo** ukwenzela imbuyiselo yeendleko zeehambo.
- 13.7 Iinqununu/abaphathi bamaziko okubhalela iimviwo mabaqinisekise ukuba bonke ootitshala namalungu asekuhlaleni aqeshwe njengabagadi babaviwa baqeqeshwe ngokupheleleyo ngokwenziwa kwemisebenzi yokugada abaviwa yabo.
- 13.8 Iinqununu/abaphathi bamaziko nabagadi babaviwa abaziintloko **mabalugqithisele** uqeqesho kubo bonke abagadi babaviwa abangekayi kwiseshoni yoqeqesho yakwaNdlunkulu/ yesithili.
- 1.3.9 Iirejista zababekho kuqeqesho mazizaliswe njengobungqina kwinqanaba lesikolo yaye mazibonise umhla nendawo ekwakuqhutyelwa kuyo uqeqesho namagama abagadi babaviwa ababekwiseseshoni leyo.
14. **Ukutyunjwa nokuvunywa kwamagama abagadi babaviwa abaziintloko, abagadi babaviwa abaneqhuzu nabagadi babaviwa ukulungiselela zonke iimviwo**
- 14.1 Abenzi-sicelo **mabazalise isiHlomelo A (Z83) yaye** inqununu/umphathi weziko **makazalise isiHlomelo B**. Umphathi wesekethe uya kungqinisa amagama abatyunjiweyo acebise ngokutyunjwa kwabo emva koko agqithisele la maxwebhu kuMququzeleli woVavanyo neMviwo kwaNdlunkulu ukwenzela ukuvunywa kwawo kokugqibela nokuqeshwa kwabo. **IsiHlomelo C (Summary of invigilators)** masizaliswe emva koko yaye sisayinwe yinqununu/ngumphathi weziko.
- 14.2 **IsiHlomelo G (Attendance register)** masizaliswe yaye masisayinwe yinqununu/ngumphathi weziko **ukungqinisa** inani leeseshoni ezigqityiweyo size singeniswe kunye nefom yokwenza ibango.
- 14.3 Amagama abagadi babaviwa abaneqhuzu abatyunjiweyo, makahanjiswe neekopi ezingqinisiweyo zesazisi somntu ngamnye otyunjiweyo, isivi (*curriculum vitae*) elikhasi elinye kunye nengxelo yamabanga emfundo akhe, **emayiquke isatifikethi seBakala 12**.
- 14.4 Kukhethwa ukuba mabangaqwalaselelwa ukuqeshwa abenzi-sicelo okanye abatyunjwa ababefake izicelo zokuqeshwa ngokusisigxina kwezinye iindawo.
- 14.5 Kuphela ngumntu ekuvunyiweyo ukuqeshwa kwakhe nguNdlunkulu onokwenza imisebenzi njengomgadi wabaviwa. Akuvumelekanga naphantsi kwazo naziphi iimeko ukuba abagadi babaviwa batyumbwe abagadi babaviwa ababambeleyo nakweyiphi inxenye yomsebenzi wabo. Abasebenzi abaqeshwe libhunga lolawulo kwizithuba zokukhawulelana nemeko

yethutyana okanye kwizithuba zengqesho ezisisigxina mabazifekekise iikhrayitheriya ezisezantsi zabagadi babaviwa basekuhlaleni ukuze benze imisebenzi enxulumene neemviwo okanye imisebenzi yokugada abaviwa.

14.6 Ukuba iimeko ziyamthintela umgadi wabaviwa oyintloko, umgadi wabaviwa oneqhuzu okanye umgadi wabaviwa ukuba agade abaviwa kuviwo, inqununu/umphathi weziko, ngokuthetha-thethana nomphathi weseke the, makenze amalungiselelo okuqeshwa komgadi wabaviwa obambeleyo kwaye malaziswe ngolo tshintsho ngoko nangoko iCandelo loLawulo lweeMviwo. Abagadi babaviwa ababambeleyo nabo mabangenise ngokunjalo **isiHlomelo D no-H** ezizaliswe ngokupheleleyo. **Makuqatshelwe ukuba ngamaxwebhu ayintsusa kuphela angeniswayo aya kwamkelwa.**

17. **Ukuhlawulwa kwabagadi babaviwa**

- 17.1 ISebe iWCED liya kubaqesha yaye libahlawule abagadi babaviwa abangabantu basekuhlaleni ngokungqinelana nemimiselo ye-*Personnel Administration Measures (PAM)* eyapapashwa kwiGazethi kaRhulumente No. 46879 yomhla we-09 Septemba 2022.
- 17.2 **Izikolo ezizimeleyo, iikholeji neentolongo, zinoxanduva lokuhlawula abagadi babaviwa bazo.** Nakuba kunjalo, iinqununu zezikolo ezizimeleyo, iintloko zeekholeji nezeentolongo maziqaphele ukuba **kunyanzelekile ukuzalisa iziHlomelo A, B, C no-E yaye zibuyiselwe kwiSebe iWCED** nangona abagadi babaviwa bala maziko bengahlawulwa liSebe i-WCED.
- 17.3 **Izikolo ezizimeleyo, iikholeji neentolongo** mazithobele iikhrayitheriya zokuqeshwa ezikhankanywe kumhlathi 10.1 yaye azinakunxaxha kuzo.
- 17.4 **Abasebenzi benkonzo karhulumente nootitshala (abaqeshwe ngokwemvumelwano nabasisigxina) abafumana umvuzo kwiSebe i-WCED nabasebenza njengabagadi babaviwa, ABAYI kuhlawulwa** liSebe i-WCED ngemisebenzi yokugada abaviwa abayenzileyo.
- 17.5 Ireyithi yentlawulo yokugada abaviwa ngoku (esengatshintsha) **ngama-R310, 00 ngeseshoni nganye kumgadi wabaviwa oneqhuzu yaye ibe ngama-R230, 00 ngeseshoni nganye kumgadi wabaviwa.**
- 17.6 **Abagadi babaviwa abasayi kuhlawulwa phantsi kwazo naziphi iimeko ngeendleko zeehambo eziphathelele ekwenzeni imisebenzi yokugada abaviwa.** Iinqununu/abaphathi bamaziko, ngoko ke, mabaqeshe abagadi babaviwa abangabantu basekuhlaleni abafumana iinkonzo kweso sikolo/kwelo ziko.
- 17.7 Imimiselo (*IRP10*) engokuhlawulwa kwerhafu yomqeshwa imisela ukuba yonke imivuzo yabantu abaqeshwe ngokungesosigxina mayitsalelwe irhafu yama-25%. ISebe iWCED liya kuthi, ngoko ke, **litsale ama-25% eyirhafu yezixa zentlawulo yabagadi babaviwa ngeenkono abazenzileyo.** Ngoko ke, **ukungeniswa komyalelo werhafu yabaqeshwa (tax directive) (IRP 3) akusasebenzi.**
- 17.8 Abagadi babaviwa abafanele ukuxolelwa ngokupheleleyo okanye ngokuyinxenye kwintlawulo yerhafu yomqeshwa, mabangenise isatifikethi (emva kokuba befumene izatifikethi ze-*IRP 5*) kwi-ofisi yabo ye-*South African Receiver of Revenue* ekufutshane nabo, kwakunye nefom emiselweyo eyi-*IT12 S form*. Ii-*IRP 5 certificates*, ziya kuthunyelwa

ngekhuriya ezikolweni ngoJuni/ngoJulayi kunyaka olandela lowo bebengabagadi babaviwa ngawo.

- 17.9 Ukwenzela ukuba kukhawuleziswe intlawulo yamabango kumgadi wabaviwa oneqhuza okanye kumgadi wabaviwa, makabhale **inombolo yesazisi** yakhe kwifom yokwamkela ukuqeshwa baze baqhuboshele ikopi yesazisi eqinisekisiweyo. **IsiHlomelo D** ekubhalwe kuso kwakhona **inombolo yesalathiso yerhafu (tax reference number)** masizaliswe ngabo **bonke abagadi babaviwa abaneqhuza nangabagadi babaviwa abangabantu basekuhlaleni**. Le fom mayizaliswe yaye ingqinwe njengechanekileyo yaye i-akhawunti yebhanki mayingqinwe njengesebenzayo yibhanki echaphazelekayo. **Makuqatshelwe: abagadi babaviwa mabaqinisekise ukuba ii-akhawunti zabo zebhanki zihlala zisebenza.**
- 17.10 Abagadi babaviwa abaqeshwe liSebe i-WCED kwizithuba ezisisigxina okanye ezemvumelwano, abathatha ipakheji yokuyeka emsebenzini ngokuzithandela okanye abagxothwayo kwinkonzo yalo naliphi na isebe likaRhulumente waseMzantsi Afrika, baya kusalwa (*blocked*) kwisistim yePesali (*Persal system*) yaye abayi kuzihlawulelwa iinkonzo abazenzileyo.
