**Isihloko: Ukubuyiselwa kweezatifikethi zeSatifikethi seMatriki sikaZwelonke (NSC) ezingabangwanga.**

1. Bonke abathathi-nxaxheba, kuqukwa iinqununu zezikolo zemfundo ephakamileyo/ezeesekondari, nabaphathi bamaZiko okuFunda asekuHlalani (*Community Learning Centres*), kufuneka bakuthathele ingqalelo oku kulandelayo:
  - a) Zonke izatifikethi ezingabangwanga kunye nekopi yelisti yezatifikethi (ilisti yeesignitsha zabafundi abazithathileyo izatifikethi zabo) mazifunyanwe yaye zibuyiselwe kwaNdlunkulu emva kwethuba leenyanga eziyi-12 ukususela ngomhla wokwamkelwa kwazo ngamaziko (*centres*); yaye
  - b) Izatifikethi zemviwo zangoNovemba 2022, ezahanjiswa ngo-2023, kucelwa zibuyiselwe kwaNdlunkulu engadlulanga uLwesihlanu we-16 Agasti 2024. Le nkqubo kufuneka iphindwe ngonyaka ngamnye.
2. Izatifikethi ezingabangwanga ziya kugcinwa kwaNdlunkulu kwindawo ekhuselekileyo ithuba leminyaka emithathu, ukulungiselela ukuthathwa kwazo okunokwenzeka ngabaviwa. Ukuba azibangwanga kwithuba leminyaka emithathu, izatifikethi ziya kutshatyalaliswa.

3. Ukongeza koku kungentla, abathathi-nxaxheba abachaphazelekayo kufuneka kananjalo bathobele imimiselo, imigaqo-nkqubo nemiyalelo ka-UMALUSI ngokuphathelele koku kulandelayo:
- a) Izatifikethi ezingabangwanga kufuneka zibuyiselwe emva konyaka omnye zikhutshiwe ezikolweni.
  - b) Izatifikethi **kufuneka** zithathwe njengezixabiseke kakhulu neziyimfihlo,
  - c) Izatifikethi **kufuneka zisoloko** zigcinwe ngokunqatyisiweyo ngalo lonke ixesha yaye,
  - d) Abaviwa **kufuneka** baziswe xa izatifikethi zikulungele ukuthathwa yaye ukuhanjiswa kwazo kufuneka kwenziwe phantsi kwemeko ezikhuselekileyo.
