**Isihloko: Ukubuyiselwa kweezatifikethi zeSatifikethi seMatriki sikaZwelone (NSC) ezingabangwanga.**

1. Bonke abathathi-nxaxheba, kuqukwia iinqununu zezikolo zemfundu ephakamileyo/ezeesekondari, nabaphathi bamaZiko okuFunda asekuHlaleni (Community Learning Centres), kufuneka bakuthathethi ingqalelo oku kulandelayo:
  - a) Zonke izatifikethi ezingabangwanga kune nekopi yelisti yezatifikethi (ilisti yeesignitsha zabafundi abazithathileyo izatifikethi zabo) mazifunyanwe yaye zibuyiselwe kwaNdlinkulu emva kwethuba leenyanga eziyi-12 ukususela ngomhla wokwamkelwa kwazo ngamaziko (centres); yaye
  - b) Izatifikethi zemviwo zangoNovemba 2022, ezahanjiswa ngo-2023, kucelwa zibuyiselwe kwaNdlinkulu engadlulanga uLwesihlanu we-16 Agasti 2024. Le nkubo kufuneka iphindwe ngonyaka ngamnye.
2. Izatifikethi ezingabangwanga ziya kugcinwa kwaNdlinkulu kwindawo ekhuselekileyo ithuba lemnyaka emithathu, ukulungiselela ukuthathwa kwazo okunokwenzeka ngabaviwa. Ukuba azibangwanga kwithuba lemnyaka emithathu, izatifikethi ziya kutshatyalaliswa.

3. Ukongeza koku kungentla, abathathi-nxaxheba abachaphazelekayo kufuneka kananjalo bathobebe imimiselo, imigaqo-nkqubo nemiyalelo ka-UMALUSI ngokuphathelele koku kulandelayo:
  - a) Izatifikethi ezingabangwanga kufuneka zibuyiselwe emva konyaka omnye zikhutshiwe ezikolweni.
  - b) Izatifikethi **kufuneka** zithathwe njengezixabiseke kakhulu neziyimfihlo,
  - c) Izatifikethi **kufuneka zisoloko** zigcinwe ngokunqatyisiweyo ngalo lonke ixesha yaye,
  - d) Abaviwa **kufuneka** baziswe xa izatifikethizikulungele ukuthathwa yaye ukuhanjiswa kwazo kufuneka kwensiwe phantsi kwemeko ezikhuselekileyo.
