ISihloko: **Ukuhlolwa kwamaziko okubhalela iimviwo karhulumente nazimeleyo ekuya kubhalelwa kuwo iimviwo zeSatifikethi seMatriki sikaZwelonke/zeSatifikethi seMatriki ngo-2024**

1. NgokoMmiselo 27(2) we-Regulations Pertaining to the Conduct, Administration and Management of the National Senior Certificate examination, epapashwe kwiGazethi kaRhulumente No. 37651 ye-16 Meyi 2014, "Onke amaziko okubhalela iimviwo makahlolwe (evaluated) ligosa lequmrhu lovavanyo, ukungainisa ukuba zonke iifasilithi eziyimfuneko zokuqhutywa kweemviwo ziyanfumaneka kwiziko elo".
2. Iinqununu mazizalise isixhobo sokuhlola amaziko (*audit instrument*) qho ngonyaka, esibonisa ukulungela kwesikolo ukubhalisela iimviwo zeSatifikethi seMatriki sikaZwelonke (NSC)/zeSatifikethi seMatriki (Senior Certificate (SC)). Isixhobo sokuhlola amaziko masizaliswe kwikhompyutha yaye sinokufunyanwa kwi-CEMIS phantsi kwemenyu: Exams/Assessments, Exam centre audit instrument.
3. Phambi kokuzalisa isixhobo i-audit instrument sango-2024, kucelwa iinqununu ukuba ziqale zizifunde kuqala zonke iikhomenti, iingcebiso nemiba eyinkxalabo ephakanyiswe ngabaphathi besekethe, ngabaququzeleli bovavanyo nangumququzeleli oyi-provincial audit coordinator malunga nokuzaliswa kwesixhobo sokuhlola kwamaziko oviwo lwango 2023 kwi-CEMIS. Oku kuya kukhokelela ekubeni kuthathwe inyathelo lokulungisa imiba eyingxaki eliyimfuneko koku.

4. **Zonke izikolo** ezibhalisa iimviwo ze-NSC/SC zango-2024 mazizalise isixhobo sokuhlolwa kwangaphakathi kweziko lokubhalela uviwo kunye nesixhobo i-electronic audit instrument. Umhla omisiwego wokuzaliswa nokusayinelwa kwsixhobo esikwikhompyutha i-electronic audit instrument, nguLwesihlanu we-**19 Julai 2024**.
5. Isixhobo i-electronic audit instrument masisayinelwe kwi-CEMIS yinqununu nangumphathi wesekekethe.
6. Isixhobo esizalisiwego kwikhompyutha sango-2024 sifakelwe izilungiso kwingcaciso eyimfuneko kwicandelo elimalunga ne-Computer Application Technology (CATN) ne-Information Technology (INFT) emalunga nokulungela kweziko ukubhalela iimviwo. Eli candelo malizaliswe yinqununu, ngutitshala we-CATN ne-INFT kunye nomphathi wesekekethe wazo zonke izikolo ezifundisa ezi zifundo.
7. Iziko lokubhalela uviwo ngalinye malifake kwikhompyutha isatifikethi i-Health and Safety certificate esisemthethweni nesatifikethi i-Fire Equipment Service Certificate xa lingenisa isixhobo i-electronic audit instrument.
8. Makusetyenziswe ezi khrayitheriya zokhuseleko zintlanu zilandelayo zizezona zisezantsi ukongeza kula manyathelo okhuseleko angamanye ekufuneka asetyenziswe kuwo onke amaziko okubhalela uviwo apha kugcinwa imathiriyeli yeemviwo ze-NSC/SC:
 - 8.1 **Ukuphunyezwa kwestim yokutshixa ngokuphindwe kabini, o.k.t. apha kufuneka kubekho abagcini bezitshixo ababini ukwenzela ukuba kufumanekе imathiriyeli yeemviwo ze-NSC/SC egciniwego.**
 - 8.2 **Abagcini bezitshixo zesistim yokutshixa ngokuphindwe kabini mababe ngamalungu eKomiti yoLawulo yeSikolo.**
 - 8.3 **Unogada (onoogada) wokhuseleko makabekhona iiyure eziyi-24 ukwenzela ukuba akulawule ukungena nokuphuma kumasango ngethuba lokubhalwa koviwo, xa amaphepha emibuzo kunye/ okanye izikripti zoviwo zigcinwa kumasango esikolo.**
 - 8.4 **Iziko lokubhalela iimviwo malibe negumbi elinqatyisiwego.**
 - 8.5 **Igumbi elinqatyisiwego malibe nendawo yokugcina izixhobo zokubhala uviwo.**
9. Ngo-2023, ezinye izikolo zafumana inkxaso-mali yeemeko ezingxamisekileyo ukwenzela ukuba kuthengwe inkonzo yezokhuseleko (security guarding) ukulungiselela ukugcinwa ngokhuseleko (safekeeping) kwemathiriyeli yemviwo ze-NSC/SC zangoNovemba. Ngenxa yamanyathelo angqongqo okonga iidleko, akukho nkxaso-mali yongezelelweyo ifumanekayo ngo-2024, yaye ngenxa yoko, izikolo ezingenako ukufezekisa iimfuno ezimiselweyo zendawo yokugcina imathiriyeli yeemviwo ze-NSC/SC zangoNovemba, kufuneka ziqinisekise ukuba le mfuno imiselweyo ichaziwego ngokomgaqo-nkqubo kazwelonke ifezekisiwe phambi kokuba kuqale iimviwo.

10. Amagosa avela kwiSebe leMfundu leNtshona Koloni aya kuqhagamshelana nezikolo ukulungiselela umhla nexesha lokundwendwelwa kwazo ukwenzela ukuhlolelwa ukulungela kwazo ukuba ngamaziko okubhalela uviwo.
11. Amathuba okundwendwelwa ukulungiselela ukuhlolwa aya kwenziwa ukususela ngo-Julayi ukuya ku-Oktobha 2024.
12. Apho kukho izenzo eziphinda-phindayo zokungathotyelwa kwemigaqo yeemviwo, iziko linokuphulukana nobume (*status*) balo bokuba liziko lokubhalela iimviwo.
13. Abafundi ababhaliswe kwizikolo ezizimeleyo abayi kungqinwa njengabaphumelele amabanga emfundu achaphazelekayo ukuba isikolo esizimeleyo asivunywanga (accredited) njengesifanelekileyo ngu-UMALUSI.
14. Okuqulethwe kule ngcaciso imfutshane makufundwe kunye neNgcaciso eMfutshane yeCandelo loLawulo loViwo 0011/2022, yomhla we-03 Oktobha 2022.
15. Okuqulethwe yile ngcaciso imfutshane makwaziswe bonke abasebenzi abenza umsebenzi wokusingatha nokulawula iimviwo zeNSC zango-2024 ezikolweni.
