Subject: Updated guidelines on cellular phones and other mobile technologies in public schools

- 1. With the ever-expanding nature of digital learning and teaching, this minute seeks to inform public schools of the updated guidelines on the use of cellular phones and other mobile technologies within schools.
- 2. This guideline document supports the Western Cape Education Department eLearning's objectives and cyber wellness education and aims to assist schools in formulating and implementing their own cellular and mobile device usage policy. (See Annexure A: Guidelines)

4.1 To create insight and awareness about some of the opportunities presented by cellular

phones and mobile technologies for educators, learners, and parents within the school

environment.

4.2 To highlight the potential benefits and risks associated with the implementation and use of

mobile technologies within the school environment.

4.3 To reinforce the scope of learning and accessibility that comes with the using of cellular

phones and mobile technologies in the learning environment.

4.4 To assist public schools to develop their own policies to manage the use of cellular phones

and mobile technologies in schools.

4.5 To emphasise cyber safety risks and possible mitigations.

4.6 To provide clarity on the roles and responsibilities of the school, educators, and learners

when using mobile technologies in the school environment.
