**Isihloko: ISaveyi eQuphayo (SNAP Survey) yeSebe leMfundo leNtshona Koloni (WCED) yango-2024 yezikolo zikarhulumente eziqhelekileyo nezikolo ezizimeleyo**

1. Isaveyi eQuphayo (SNAP survey) yezikolo zikarhulumente eziqhelekileyo neyezikolo ezizimeleyo iya kusetyenziselwa ukulawulwa nokuphathwa kwezikolo, kwakunye nokukhutshwa kwezibonelelo ukulungiselela owama-2024.
2. Isaveyi eQuphayo mayizaliswe yaye isayinelwe yinqununu kwi-CEMIS **ngowama-30 Januwari 2024** (usuku lweshumi lwesikolo).
3. Phambi kokusayinelwa kwayo kwi-CEMIS, inqununu mayiqinisekise oku kulandelayo:
  - a) Bonke abafundi ababhalisiweyo nabahamba isikolo ngowama-2024 mabavele kwibakala nakwiklasi echanekileyo yabo kwi-CEMIS.
  - b) Bonke abafundi ebekulindeleke ukuba babuyele esikolweni, kodwa abafika esikolweni ukuza kubhalisa ungadlulanga owama-30 Januwari 2024, bayakhutshwa ezincwadini ngokungqinelana nomgaqo-nkqubo wokuhamba isikolo kwabafundi. (Aba bafundi banokubhaliswa kwakhona kwi-CEMIS ukuba beza kubhalisela ukwamkelwa esikolweni emva kowama-30 Januwari 2024.)
  - c) Abafundi abaswelekileyo bayakhutshwa ezincwadini yaye "umhla wokusweleka" ubhalwe njengoko uchaziwe kwisatifikethi sokusweleka.
  - d) Ilisti yootitshala/yeepraktishina ezikwi-CEMIS mayihlaziye yaye ingqinisiswe, ukususela ngowama-30 Januwari 2024, yaye kungqinisiswe nemeko yokuqeshwa kwabo.
  - e) Icandelo lokusayinelwa kwesaveyi malizaliswe ukuvuma ukungqinisiswa kwedatha njengelibonakalisa ngokuchanekileyo inani lobhaliso labafundi kunye nenani labasebenzi (staff), ngowama-30Januwari 2024.
  - f) Kukhunjujwa iinqununu ngendima yazo njengamagosa asingethe i-Education Management Information System (EMIS) kumaziko yaye kufuneka ziqinisekise

ukuba ingcaciso efakwe ekhompuyutheni ngethuba lesaveyi eQuphayo ibonisa ngokuchanekileyo amanani abafundi nawabasebenzi esikolweni ngolo suku.

g) Inqununu maziqinisekise ngokungaphezulu ukuba amanani abafundi afakwe kwisaveyi yeSNAP achanekile, njengoko iimposiso yokungachaneki kwamanani abafundi ithathelwa ingqalelo njengesenzo sobuqhophololo.

4. Ukuncedisa ukungqinisiswa kwedatha yabafundi neyootitshala yesikolo, kukho iingxelo zeemposiso ezininzi ezifumanekayo eziya kukhokela izikolo ngokuchaneka kwedatha ekhoyo efakwe kwi-CEMIS. Kucelwa kuqinisekiswa ukuba zisonjululwe zonke iimposiso njengoko zibonakala kwiingxelo phambi kokusayinelwa kwazo. Umgangatho wedatha ye-EMIS uya kuqhagamshelaniswa nemimiselo nemigangatho yokwenziwa kwentlawulo (*norms and standards transfer payments*)
5. Inqununu, njengegosa le-EMIS yesikolo, kufuneka ilawule iinkqubo zedatha ukuqinisekisa ukuba ubungqina bokungqinisiswa kwazo neesignitsha zabasebenzi abanikwe igunya lokutshekisha idatha bunako ukuvezwa xa kuceliwe ngabaphicothi-zincwadi. Inkqubo yedatha eyi-*data business process* ye-EMIS yesikolo kufuneka irekhodwe ukuqinisekisa uxanduva lokuchaneka kwedatha, njengoko inako ukuhlolwa ingcaciso.
6. Umhla osikiweyo olungiselelwe abaphathi beesekethe ukuba basayinele idatha yesaveyi eQuphayo (*SNAP survey data*) ngowe-**06 Februwari 2024**. Abaphathi beesekethe kuya kufuneka babeke esweni inkqubela yaye abasayi kuba nako ukuzisayinela iisethi zeedatha zesaveyi ukuba kusekho iimposiso nalapho iinqununu zingazisayinelanga iisaveyi eziQuphayo zazo (*SNAP surveys*).
7. Ikhona ingxelo yeCEMIS efumanekayo ukuqaphela abafundi abangenazinombolo zezazisi (*ID*) nokulungiselela ukufakwa ekhompuyutheni kweenombolo zezazisi (*ID*) ezingekhoyo. Niyacelwa nimcebise umzali ngenkqubo yokwenza isicelo sesazisi kwiSebe leMicimbi yezeKhaya (*DHA*), ukuba umfundi akanayo inombolo yesazisi (*ID*) esemthethweni. Inqununu zikhunjuzwa ngeSetyhula 0053/2021, yomhla we-09 Matshi 2022, engokwamkelwa kwabafundi baseMzantsi Afrika okanye abavela kwamanye amazwe abangenawo amaxwebhu ayimfuno yaye ziyacelwa ukuba zibancedise abazali, apho kunokwenzeka oku, ngokuthi ziyiququzelele le nkqubo kwiSebe leMicimbi yezeKhaya.
