Isihloko: ISaveyi yeZikolo yaQho ngoNyaka (Annual School Survey (ASS)) yeSebe leMfundo leNtshona Koloni (WCED) ka-2024 yezikolo zikarhulumente neyezikolo zemfundo eneemfuno ezizodwa ezizimeleyo

1. ISaveyi i-ASS ka-2024 yeSebe iWCED yezikolo zikarhulumente nezikolo zemfundo eneemfuno ezizodwa ezizimeleyo, iya kuqhutywa **nge-05 Septemba 2024**.
2. Iinqununu kuya kufuneka ukuba zikusayinele ukuchaneka kwedatha. Umhla omisiweyo wokusayinelwa kwedatha yeSaveyi i-ASS ngabaphathi beeprogram zephondo nangamagosa eCandelo loCwangciso Lawulo noKuphathwa kwamaZiko, **yi-12 Septemba 2024**.
3. Phambi kokuba kusayinelwe idatha kwi-CEMIS, kucelwa ukuba inqununu okanye lowo kudluliselwe kuye amagunya, makaqinisekise ukuba oku kulandelayo kubonakala ngokuchanekileyo kwi-CEMIS:
 - (a) Bonke abafundi ababhalisileyo yaye behamba isikolo ngo-2024 bayavela ngokuchanekileyo kumabakala, kwiiklasi, nakudidi loLwimi lokuFunda nokuFundisa.
 - (b) Kuzalisiwe kubhaliswa kwabafundi abatshintshwayo (abangenayo nabaphumayo) esikolweni (*Learner transfers (in and out)*).
 - (c) Kuzalisiwe ukutshintshwa kwamabakala.
 - (d) Ichanekile ingcaciso yokhubazeko lwabafundi.

- (e) Abafundi abaswelekileyo mababe bakhutshiwe kuluhlu lwababhalisiweyo yaye “umhla wokusweleka” urekhodwe njengoko ubhaliwe kwisatifikethi sokusweleka (*death certificate*).
4. Inqununu mayiqinisekise nokuba ihlaziyiwe yaye ingqinisiwe ilisti yootitshala kwi-CEMIS, kwakunye neminyaka yamava, amabakala nezifundo ezifundiswa ngo- 2024. (makasuswe amabakala nezifundo ebezifundiswa kwiminyaka engaphambili ukuba azifanelekanga kumsebenzi katitshala ngo-2024).
 5. Ukuncedisa ukungqinisiwa kwedatha yesikolo yabafundi nootitshala; kukho iingxelo zemposiso (*error reports*) ezifumanekayo ukucacisa ukuba idatha efakwe kwi-CEMIS yechanekileyo. Kucelwa niqinisekise ukuba zonke iimposiso eziboniswe zezi ngxelo ziyasonjululwa phambi kokuba zisayinelwe iingxelo.
 6. Icandelo lokusayinelwa kwe-ASS malizaliswe ukuvuma ukungqinisiwa kwedatha njengebonakalisa ngokuchanekileyo inani lobhaliso labafundi nenani labasebenzi (*staff*) njengokuba enjalo **nge-05 Septemba 2024**.
 7. Njengegosa le-*Education Management Information Systems (EMIS)* leziko, inqununu mayilawule iinkqubo zedatha ukuqinisekisa ukuba ubungqina bokungqinisiwa neesignitsha zabasebenzi ekudluliselwe kubo amagunya okutshekisha idatha zinokunikwa abaphichothi-zincwadi xa kuceliwe oko. Inkqubo yedatha ye-EMIS yesikolo mayirekhodwe ukuqinisekisa uxanduva lokuphendula ngokuchaneka kwedatha, njengokuba ingcaciso inokuphicothwa.
 8. Iyafumaneka ingxelo ye-CEMIS ukulungiselela ukuqaphela abafundi abangenazo iinombolo zezazisi nokuququzelela ukufakwa kwikhompyutha kweenombolo zezazisi ezingekhoyo. Ukuba umfundi akanayo inombolo yesazisi esemthethweni, niyacelwa nibacebise abazali ngenkqubo yokwenza isicelo sencwadi yesazisi kwiSebe leMicimbi yezeKhaya (DHA). Iinqununu zikhunjuzwa ngeSetyhula 0053/2021, (Ukwamkelwa kwabafundi abangabemi baseMzantsi Afrika okanye abangabemi belinye ilizwe (*foreign*) abangenawo amaxwebhu asemthethweni), yomhla we-09 Matshi 2022, yaye ziyacelwa ukuba zibancedise abazali apho kufanelekileyo ngokuthi ziyiququzelele le nkqubo kwiSebe leMicimbi yezeKhaya.
 9. ICandelo loLawulo loLwazi neNgcaciso liya kubeka esweni ukuthotyelwa kwale nkqubo nokuqinisekiswa komgangatho wedatha yawo onke amaxwebhu angenisiweyo eSaveyi i-ASS yaye liya kunika ingxelo kwiNtloko yezeMfundo ngazo naziphi na izenzo zokungathotyelwa, ukungangqinelani nokungapheleli kwedatha.

10. Ziyakhunjuzwa izikolo zemfundo eneemfuno ezizodwa ezizimeleyo ukuba mazibe nolwazi ngemiqathango yazo yobhaliso. Kucelwa kuqatshelwe ukuba ukuzilandela mbo iimfuno ezimiselweyo zedatha zeSebe iWCED, kuyinxalenye yale miqathango yaye ukungathotyelwa kwayo kunokukhokelela ekukhutshweni kweziko ezincwadini zobhaliso.
